We hereby confirm that the repurchases made on the Exchange set out in Part A above were made in accordance with the Main Board Rules and that there have been no material changes to the particulars contained in the Explanatory Statement dated May 24, 2024 which has been filed with the Exchange.

Remarks: As disclosed in the Company's announcement dated August 12, 2024, the Company intends to allot and issue a total of 139,159,664 Consideration Shares to Alcon (the "Share Issue") upon Shareholders' approval at the upcoming EGM. The Company expects the Share Issue to be completed by October 21, 2024 (Hong Kong Time) and has obtained the approval from the Stock Exchange under Rule 10.06(3)(a) of the Listing Rules for completing the Share Issue with 30 days after any repurchase of Shares on the Stock Exchange, on the condition that the Share Issue will be completed on or before October 21, 2024. Subject to the aforementioned approval, the moratorium period shall be up to the date as stated above.

The Company will suspend the repurchase of Shares and/or seek a new approval from the Stock Exchange in accordance with Rule 10.06(3)(a) should the Share Issue not be completed by October 21, 2024.
