UNAUDITED OPERATING FIGURES FOR AUGUST 2024

The board of directors (the “**Board**”) of Sanxun Holdings Group Limited (the “**Company**”) wishes to provide the shareholders of the Company and potential investors with a sales update containing certain operating data of the Group for the eight months ended 31 August 2024. For the eight months ended 31 August 2024, the aggregate contracted sales of the Company, its subsidiaries and associated companies (the “**Group**”) was approximately RMB242 million, the aggregate contracted gross floor area was 37,947 sq.m. and the average selling price was approximately RMB6,366.0 per sq.m..
