UNAUDITED OPERATING STATISTICS FOR SEPTEMBER 2024

The board of directors (the “**Board**”) of Jingrui Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce the unaudited operating statistics of the Group for September 2024.

The Group’s aggregated contracted sales (including contracted sales by joint ventures and associates) for September 2024 was approximately RMB130 million. The Group’s contracted gross floor area for September 2024 was approximately 6,545 square meters. The contracted average selling price for September 2024 was approximately RMB19,862 per square meter.

For the Nine months ended 30 September 2024, the Group’s aggregated contracted sales (including contracted sales by joint ventures and associates) was approximately RMB1,466 million, the Group’s contracted gross floor area was approximately 98,014 square meters and the Group’s contracted average selling price was approximately RMB14,957 per square meter.

The above-mentioned sales data is unaudited and is based on preliminary internal information of the Group, which may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such sales information.
