(首鋼集團有限公司) (" Shougang "), a copy of which is tabled at the SGM and marked "A" and initiated by the Chairman of the SGM for identification purpose, pursuant to which, the Company has conditionally agreed to provide or procure its subsidiaries to provide the facilities of up to an aggregate principal amount of RMB2,000,000,000 (equivalent to approximately HK\$2,151,000,000) to Shougang and/or its subsidiaries; (b) To approve the annual caps for each of the finance lease loan and credit financing loan to be provided under the Renewed Master Facilities Agreement as set out in the circular of the Company dated 9 October 2024 in respect of the Renewed Master Facilities Agreement and Technology License Agreement (the " CCT Renewal Circular "); (c) To authorise any one director of the Company, or any two directors of the Company if the affixation of the common seal is necessary, for and on behalf of the Company to execute all such other documents, instruments and agreements and to do all such acts or things deemed by him/her to be incidental to, ancillary to or in connection with the matters contemplated in the Renewed Master Facilities Agreement.

(a) To approve, ratify and confirm the agreement (the " Technology License Agreement ") dated 29 August 2024 entered into between the Company and Shougang, a copy of which is tabled at the SGM and marked "B" and initiated by the Chairman of the SGM for identification purpose, pursuant to which, the Company shall grant a license to Shougang and/or its subsidiaries shall to use, copy, modify or merge the Technology for businesses in respect of finance lease, supply chain finance and factoring for a term of three (3) years; (b) To approve the annual caps of the transactions to be conducted under the Technology License Agreement as set out in the CCT Renewal Circular; (c) To authorise any one director of the Company, or any two directors of the Company if the affixation of the common seal is necessary, for and on behalf of the Company to execute all such other documents, instruments and agreements and to do all such acts or things deemed by him/her to be incidental to, ancillary to or in connection with the matters contemplated in the Technology License Agreement.
