The resolutions authorise the issuer to make purchases of its ordinary shares (subject to certain conditions) until the end of its 2025 annual general meeting (or, if earlier, until the close of business on 30 June 2025), save that this authority shall allow the issuer prior to the expiry of this authority to make a contract or contracts to purchase ordinary shares under this authority which will or may be completed or executed wholly or partly after such expiry and may make a purchase of ordinary shares pursuant to any such contract or contracts as if the authority conferred had not expired.

On 30 January 2024 and 11 April 2024, the Exchange gave HSBC consent under Rule 10.06(3) for (a) the grant of new options and issue of new Shares (as the case may be) in accordance with the Company's existing employee share plans; and (b) the issue of new contingent convertible securities, where such issuances would occur within a period of 30 days after any purchase of Shares made under the Buyback on the Hong Kong Stock Exchange and the UK Venues respectively as announced on 7 May 2024. Subject to the aforementioned consent, the moratorium period shall be up to the date as stated above.
