On 30 January 2024 and 11 April 2024, the Exchange gave HSBC consent under Rule 10.06(3) for (a) the grant of new options and issue of new Shares (as the case may be) in accordance with the Company's existing employee share plans; and (b) the issue of new contingent convertible securities, where such issuances would occur within a period of 30 days after any purchase of Shares made under the Buyback on the Hong Kong Stock Exchange and the UK Venues respectively as announced on 7 May 2024. Subject to the aforementioned consent, the moratorium period shall be up to the date as stated above.
