### **UNAUDITED OPERATING FIGURES FOR OCTOBER 2024**

For the ten months ended 31 October 2024, the aggregate contracted sales of the Company, its subsidiaries and associated companies (the “**Group**”) was approximately RMB267 million, the aggregate contracted gross floor area was 42,510 sq.m. and the average selling price was approximately RMB6,273.0 per sq.m..
