FURTHER EXTENSION OF LONG STOP DATE

Reference is made to the announcement of China Beidahuang Industry Group Holdings Limited (the “**Company**”) dated 25 January 2024 and the circular of the Company dated 24 July 2024 (the “**Circular**”) in relation to the Proposed Restructuring, and the announcements of the Company dated 31 May 2024, 31 July 2024, 30 August 2024, 30 September 2024, 31 October 2024 and 15 November 2024 in relation to extensions of the Long Stop Date (the “**Announcements**”). Unless otherwise stated or defined herein, capitalised terms used herein shall have the same meanings as those defined in the Circular.

As of the date of this announcement, Conditions Precedent (a), (b), (c) and (d) have been fulfilled.

On 29 November 2024, the Company and the Investor entered into an agreement pursuant to which the parties have agreed to further extend the Long Stop Date to 6 December 2024, or such later date as the Company and the Investor may agree in writing (the “**Extended Long Stop Date**”), and Completion shall be subject to the Conditions Precedent being satisfied (or waived, if applicable) on or before 5:00 p.m. on the Extended Long Stop Date.

Save as disclosed above, all other terms and conditions of the Restructuring Agreement shall remain unchanged and in full force and effect in all respects.
