Flash Report on Production and Sales Volume of Dongfeng Motor Group for November 2024

This is a voluntary announcement made by Dongfeng Motor Group Company Limited (the “Company”).

The Company’s sales volume in the first eleven months of 2024 was 1,704,507 units, representing a decrease of 11.1% year-on-year. Dongfeng Motor Corporation, the parent company of the Company, recorded a total sale of 2,236,085 vehicles for the first eleven months, representing an increase of 2.4% year-on-year. The sales volume of Dongfeng Automobile Company Limited (A-share code 600006, hereinafter referred to as “DFAC”), a subsidiary of the Company, was 139,726 units for the first eleven months, representing a decrease of 1.3% year-on-year.
