POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 6 DECEMBER 2024

The Board is pleased to announce that all resolutions proposed at the AGM were duly passed by way of poll.

Reference is made to the circular of Hang Sang (Siu Po) International Holding Company Limited (the “**Company**”) dated 30 October 2024 (the “**Circular**”). Terms used herein shall have the same meanings as defined in the Circular unless the context requires otherwise.

POLL RESULTS OF THE ANNUAL GENERAL MEETING

Pursuant to Rule 13.39(4) of the Listing Rules and the Articles, the voting of all resolutions proposed at the AGM held on 6 December 2024 (the “**Resolutions**”) had been taken by poll.

As at the date of the AGM, the issued share capital of the Company comprised 184,000,000 Shares, which was the total number of Shares entitling the Shareholders to attend and vote on any of the Resolutions at the AGM. There were no Shares entitling the Shareholders to attend and abstain from voting in favour of any of the Resolutions at the AGM as set out in Rule 13.40 of the Listing Rules. No Shareholder was required under the Listing Rules to abstain from voting on any of the Resolutions at the AGM.

The Company’s branch share registrar and transfer office in Hong Kong, Union Registrars Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking.
