UNAUDITED OPERATING FIGURES FOR NOVEMBER 2024

The board of directors (the “**Board**”) of Sanxun Holdings Group Limited (the “**Company**”) wishes to provide the shareholders of the Company and potential investors with a sales update containing certain operating data of the Group for the eleven months ended 30 November 2024. For the eleven months ended 30 November 2024, the aggregate contracted sales of the Company, its subsidiaries and associated companies (the “**Group**”) was approximately RMB290 million, the aggregate contracted gross floor area was 46,399 sq.m. and the average selling price was approximately RMB6,253.0 per sq.m..
