As more than 50% of the votes were cast in favour of each of the Resolutions, all of the Resolutions were duly passed as ordinary resolutions of the Company at the AGM. As at the date of the AGM, the total number of issued shares of the Company was 2,713,791,221 shares, which was the total number of shares entitling the holders to attend and vote for or against the Resolutions at the AGM. There were no shares entitling the holder to attend and abstain from voting in favour of the Resolutions at the AGM as set out in rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”). No shareholder was required under the Listing Rules to abstain from voting on the Resolutions at the AGM. None of the shareholders have stated their intention in the circular of the Company dated 30 December 2024 to vote against or to abstain from voting on any of the Resolutions at the AGM. All the directors of the Company attended

the AGM. The Company's Hong Kong share registrar, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking.
