BERMUDA COURT HEARING

The Company would like to announce that the Chief Justice of the Commercial Court of the Supreme Court of Bermuda adjourned the hearing of the Petition to Friday, 20 June 2025 (Bermuda time).

Further announcements on the development of the Petition will be made by the Company to update the shareholders and potential investors of the Company as and when required.

UPDATES ON PROPOSED RESTRUCTURING

The Board of Directors (the “**Board**”) of the Company is pleased to announce a significant development in the Proposed Restructuring. After careful consideration of the latest developments surrounding the restructuring and the Bermuda Court hearing, the Board has passed a resolution acknowledging a change in the Company’s stance regarding the restructuring and the winding up petition. This change reflects the Board’s renewed commitment to support and actively pursue the Proposed Restructuring, as we believe this new direction offers the best opportunity to achieve a favorable outcome for all stakeholders.

The change supersedes the Company’s previous position on the Proposed Restructuring and its previous stance on the Bermuda Court hearing, as stated in our announcements dated 3 February 2025 and 6 February 2025.

Further announcements on any material developments in the Proposed Restructuring will be made by the Company as and when appropriate.
