INSIDE INFORMATION LITIGATION UPDATES

This announcement is made by Sinohope Technology Holdings Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities (the “**Listing Rules**”) on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

UPDATE ON THE UK ACTION

Reference is made to the announcement (the “**Announcement**”) dated 20 September 2024 in relation to the UK Action. Unless otherwise defined herein, capitalised terms used in this announcement shall have the same meaning as those defined in the Announcement. The Company has received a sealed consent order dated 13 February 2025 from the High Court of England and Wales that all the Claimant’s claims in relation to the UK Action against the Company have been dismissed.

UPDATE ON ADVERSARY COMPLAINT IN THE US

The Company would also like to take this opportunity to provide update on the adversary complaint in the United States against Hbit Limited (“**Hbit**”), a wholly-owned subsidiary of the Company which is set out in note 44(b) to the consolidated financial statements (page 183) in the annual report for the year ended 30 September 2024. The Company has received a notice of voluntary dismissal dated 26 February 2025 from the United States Bankruptcy Court for the District of Delaware that all claims in the adversary proceeding against Hbit have been dismissed.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the securities of the Company.
