## **QUARTERLY UPDATE ON RESUMPTION PROGRESS**

This announcement is made by Greentech Technology International Limited (“**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2)(a) and 13.49(6) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (“**Stock Exchange**”) (“**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the laws of Hong Kong).

Reference is made to the announcements of the Company dated 30 August 2024, 30 September 2024, 10 October 2024, 21 November 2024 and 2 December 2024 (collectively the “**Announcements**”) in relation to, among others, the delay in publication of the interim results of the Group for the six months ended 30 June 2024 (“**Interim Results**”), the suspension of trading in the securities of the Company (“**Suspension**”), the Resumption Guidance and the quarterly update on resumption progress. ## **QUARTERLY UPDATE ON RESUMPTION PROGRESS**

Pursuant to Rule 13.24A of the Listing Rules, the Board wishes to update the Shareholders and potential investors that as at the date of this announcement, the latest development of the Company and the resumption plan and progress are as follows:

### **Update on business operations**

The principal activities of the Company are investment holding and providing corporate management services to its subsidiaries. The principal activities of the major subsidiaries of the Company are exploration, development and mining of tin and copper bearing ores in Australia through a joint operation.

As at the date of this announcement, the business operations of the Group are continuing as usual in all material aspects notwithstanding the Suspension.

### **Resumption plan and progress**

The Company is taking action to address the Resumption Guidance and will make further announcement(s) to inform the Shareholders and potential investors relating to the appointment and engagement of professional parties, the progress and/or results of the Independent Investigation and the IC Review and the publication of the Interim Results and other financial information as required to be published under the Listing Rules as and when appropriate.

## **CONTINUED SUSPENSION OF TRADING**

Trading in the shares of the Company (Stock Code: 195) on the Stock Exchange has been suspended since 9:00 a.m. on 2 September 2024 pending the publication of the Interim Results.
