UNAUDITED OPERATING STATISTICS FOR FEBRUARY 2025

The board of directors (the “**Board**”) of Yida China Holdings Limited (the “**Company**”) hereby announces certain unaudited operating statistics of the Company and its subsidiaries (the “**Group**”) for February 2025 as follows:

- In February 2025, the Group’s contracted sales amounted to approximately RMB54 million and the Group’s attributable contracted sales was approximately RMB42 million. During the same period, the Group’s gross floor area (“GFA”) sold was 6,203 sq.m. and the Group’s attributable GFA sold was 4,431 sq.m.. The Group’s average selling price (the “ASP”) was approximately RMB8,759 per sq.m. and the Group’s attributable ASP was approximately RMB9,582 per sq.m..
- For the two months ended 28 February 2024, the Group’s contracted sales amounted to approximately RMB116 million and the Group’s attributable contracted sales was approximately RMB102 million. During the same period, the Group’s GFA sold was 10,569 sq.m. and the Group’s attributable GFA sold was 8,029 sq.m.. The Group’s ASP was approximately RMB10,974 per sq.m. and the Group’s attributable ASP was approximately RMB12,707 per sq.m..

The above-mentioned sales data is unaudited and is based on preliminary internal information of the Group, which may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on annual or semi-annual basis. As such, the above data is provided for investors’ reference only.
