QUARTERLY UPDATE ON PROGRESS OF RESUMPTION AND CONTINUED SUSPENSION OF TRADING

This announcement is made by Prosperity Investment Holdings Limited (the “**Company**” and, together with its subsidiaries, the “**Group**”) pursuant to Rules 13.09 and 13.24A of the Rules Governing the Listing of Securities (the “**Listing Rules**”) on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to (i) the announcement of the Company dated 21 June 2024 in relation to the resumption guidance; (ii) the quarterly update announcement dated 28 June 2024; (iii) the quarterly update announcement dated 30 September 2024; and (iv) the quarterly update announcement dated 31 December 2024 ((i); (ii); (iii); and (iv) collectively, the “**Announcements**”). Capitalised terms used in this announcement shall have the same meanings as those defined in the Announcements.

BUSINESS OPERATIONS

The Company is principally engaged in investing in listed and unlisted investments and other related financial assets.

As at the date of this announcement, the Group continued the implementation of its business strategies to enhance the corporate value to the Shareholders. The strategy of the Group is to identify and invest in both listed and unlisted investments with potential of growth within their industries.

UPDATES ON PROGRESS OF RESUMPTION

As disclosed in the Announcements, the Stock Exchange has set out the Resumption Guidance for the Company. Pursuant to Rule 13.24A of the Listing Rules, the Board wishes to update the Shareholders and potential investors of the Company on the progress of the Company’s fulfillment of the Resumption Guidance.

Since the publication of the annual report of the Company for the year ended 31 December 2023 containing the Disclaimer of Opinion, the Company has been seeking professional advice on the corporate actions which may be undertaken by the Company to address the issues giving rise to the Disclaimer of Opinion (the “**Audit Issues**”). The management of the Company (the “**Management**”) has preliminarily formulated certain corporate action plans with an aim to address the Audit Issues and has been in discussion with the auditors of the Company (the “**Auditors**”) on the effectiveness of these action plans. The Management understands that after the Company’s investment in Wealth Spread Investment Limited which accounted as financial assets at fair value through other comprehensive income is de-consolidated from the financial positions and results of the Group, the Auditors would be satisfied that the Audit Issues will no longer exist.

The Management has been actively identifying and engaging suitable professional advisers to assist the Company in implementing the intended corporate action plans. During the past six months, the Management had shortlisted two professional firms who are able to provide the services required by the Company. The Management is still considering their proposed terms of engagement and expects to appoint one of them shortly. The Company will make further announcement(s) in compliance with the requirements under the Listing Rules as and when appropriate.

The Company is unable to announce the audited annual financial results for the year ended 31 December 2024 before 1 April 2025. It was noted that a further resumption guidance will be issued to the Company by the Stock Exchange on or after 1 April 2025.

The Company will publish further announcement(s) to keep the Company’s shareholders and potential investors informed of the status and development of the Company as and when appropriate, as well as announce quarterly updates on its development pursuant to Rule 13.24A of the Listing Rules.

CONTINUED SUSPENSION OF TRADING

Trading in the shares of the Company on the Stock Exchange has been suspended with effect from 9:00 a.m. on 2 April 2024 and will remain suspended until further notice.

Shareholders of the Company and potential investors should exercise extreme caution when dealing in the shares of the Company.
