After you have consented to receiving future Corporate Communications in electronic form by accessing the Website Version (the "**Consent**"), you will still be entitled to (i) request printed copies of the relevant Corporate Communications free of charge; or (ii) revoke the Consent at any time by giving reasonable notice in writing to the Share Registrar specifying your request together with your full name and contact phone number.

You do not need to complete Box A of the Reply Form if you wish to continue to receive printed copies of future Corporate Communications.

The English and Chinese versions of the ESG Report 2024 of the Bank, published in electronic form only, are now available on the Bank's Website and the HKEXnews Website. You may access the ESG Report 2024 by visiting "About BEA – Sustainability" section on the home page of the Bank's Website. If you wish to receive a printed copy of the ESG Report 2024, please send your written request to the Share Registrar by post or by email at the addresses stated in Note 3.

Please note that the Bank is required by the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited to send Actionable Corporate Communications to Shareholders individually in electronic or printed form.

If you do not provide your email address in the Reply Form or the email address provided is not functional, the Bank will only be able to send future Actionable Corporate Communications to you in printed form.
