ANNOUNCEMENT ON KEY OPERATING DATA

This announcement is made based on the operating data for March 2025 of the Group to be published on the Shanghai Stock Exchange, and pursuant to Rules 13.09 and 13.10B of the Listing Rules and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The relevant key operating data was calculated based on the internal statistics of the Group, which may differ from the data disclosed in the relevant periodic reports. This announcement is made based on the operating data for March 2025 of China Southern Airlines Company Limited (the "Company") and its subsidiaries (collectively, the "Group") to be published on the Shanghai Stock Exchange, and pursuant to Rules 13.09 and 13.10B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules") and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

In March 2025, passenger capacity (measured by available seat kilometres ("ASK")) of the Group increased by 3.07% as compared with the same period last year (a year-on-year ("YoY") basis), of which, the passenger capacity for domestic routes decreased by 3.15% as compared with the same period last year, and the regional routes and international routes increased by 1.76% and 25.46%, respectively, as compared with the same period last year. Compared with the same period last year, passenger traffic (measured by revenue passenger kilometres ("RPK")) increased by 6.08%, of which, passenger traffic for domestic routes, regional routes and international routes increased by 0.63%, 2.29% and 25.54%, respectively, as compared with the same period last year. The passenger load factor was 84.74%, representing an increase of 2.40 percentage points as compared with the same period last year, of which, the passenger load factor for domestic routes, regional routes and international routes increased by 3.21, 0.39 and 0.05 percentage points, respectively, as compared with the same period last year.

In terms of cargo operations, in March 2025, cargo capacity (measured by available tonne kilometers ("ATK") - Cargo and Mail) increased by 2.82% as compared with the same period last year. Cargo and mail traffic (measured by revenue tonne kilometres ("RTK") - Cargo and Mail) increased by 5.45% as compared with the same period last year. The cargo and mail load factor was 54.56%, representing an increase of 1.36 percentage points as compared with the same period last year.

In March 2025, the Group has newly launched the following new major route: Haikou - Nanjing – Haikou (being seven flights a week).

In March 2025, the Group introduced thirteen aircrafts (including seven A321NEO aircrafts, two A320NEO aircrafts, one B737-8 aircraft, one B787-9 aircraft, one C909 aircraft and one B777F aircraft), and disposed of four aircrafts (including three B737-700 aircrafts and one A330-200 aircraft). As of the end of March 2025, the Group operated a fleet of 932 commercial aircrafts as set out below:
