

The Group's revenue comprises income from sale of properties, property management, rental and other related services earned during the year. The Group's revenue amounted to RMB89,226.5 million for the year ended 31 December 2024. Such year-on-year decrease compared to the year ended 31 December 2023 was attributable to shrinking of property business due to downturn of the real estate industry.

Cost of sales and services includes construction costs, land use rights costs, tax and surcharges, capitalized interest and other business costs. The Group's cost of sales and services for the year ended 31 December 2024 amounted to approximately RMB74,242.1 million.

The Group makes provision for impairment based on the difference between the cost of properties held or under development for sale and its net realisable value. Net realisable value is based on estimated selling price in the ordinary course of business as determined with reference to the prevailing market conditions, less further costs expected to be incurred to completion and selling and marketing costs. The Group's provision for impairment of properties held or under development for sale was RMB1,635.0 million, representing a decrease of RMB3,713.2 million from the previous year.

毛利

截至2024年12月31日止年度,本集團錄得毛利約人民幣14,984.4百萬元,毛利率16.8%。毛利率較上年的13.5%提高3.3個百分點,提高的主要原因是毛利率較高的商業物業管理服務收入和租賃收入在總收入中的佔比較上年提高。

投資物業公允價值虧損

本集團開發並持有若干商業物業,以賺取租金收入或取得資本增值,例如購物廣場及停車位等。本集團的投資物業每年由獨立物業估值師進行評估。本集團投資物業的升值或貶值部份於本集團合併損益表中確認為公允價值收益或虧損。截至2024年12月31日止年度,投資物業估值稅前損失約人民幣39.0百萬元,主要由於若干細分市場的部分投資物業受市場競爭加劇的影響,導致估值略有下降。

金融資產減值虧損淨額

截至2024年12月31日止年度,金融資產減值虧 損淨額約人民幣908.1百萬元,同比截至2023 年12月31日止年度減少24.2%,主要受貿易及 其他應收款、債務投資等的規模和可回收性的 綜合影響。

銷售及營銷成本

銷售及營銷成本由截至2023年12月31日止年度 約人民幣5,209.3百萬元下降22.6%至截至2024 年12月31日止年度約人民幣4,032.1百萬元, 主要因為廣告宣傳費等開支減少。

其他(虧損)/收益淨額

截至2024年12月31日止年度,其他虧損淨額約人民幣125.8百萬元,主要為處置子公司及資產等的虧損。較截止2023年12月31日止年度其他收益淨額約人民幣439.3百萬元減少收益約人民幣565.1百萬元,主要因為處置本公司子公司資產所得一次性收益減少。

Gross Profit

The Group recorded a gross profit of approximately RMB14,984.4 million with a gross profit margin of 16.8% for the year ended 31 December 2024. The gross profit margin increased by 3.3 percentage points compared to 13.5% of the last year, mainly attributable to a higher proportion of the revenue from commercial property management service and rental income with higher gross profit margin to the total revenue.

Fair Value Losses on Investment Properties

The Group develops and holds certain of its commercial properties such as shopping malls and carparks for rental income or capital appreciation. The Group's investment properties are appraised annually by an independent property valuer. Any appreciation or depreciation in the Group's investment property value is recognized as fair value gains or losses in the Group's consolidated statements of profit or loss. For the year ended 31 December 2024, valuation loss on investment properties was approximately RMB39.0 million before tax, mainly attributable to the slight decrease in valuation of certain investment properties under certain segment due to intensified market competition.

Net Impairment Losses on Financial Assets

For the year ended 31 December 2024, the net impairment losses on financial assets amounted to approximately RMB908.1 million, representing a year-on-year decrease of 24.2% compared to the year ended 31 December 2023, mainly attributable to the combined effect of the scale and recoverability of trade and other receivables and debt investment.

Selling and Marketing Costs

Selling and marketing costs decreased by 22.6%, to approximately RMB4,032.1 million for the year ended 31 December 2024 from approximately RMB5,209.3 million for the year ended 31 December 2023, which was primarily attributable to the decrease in advertising and publicity costs etc.

Other (Losses)/Gains - Net

For the year ended 31 December 2024, net other losses amounted to approximately RMB125.8 million, mainly derived from losses from disposal of subsidiaries and assets, representing a decrease of gains of approximately RMB565.1 million as compared to the net other gains of approximately RMB439.3 million for the year ended 31 December 2023, mainly due to decrease in one-off gains from disposals of assets of the subsidiaries of the Company.

行政開支

行政開支由2023年12月31日止年度約人民幣 4.149.8百萬元下降23.0%至截至2024年12月 31日 止年度約人民幣3.193.6百萬元,主要是因 為僱員減少及節約開支。

所得税開支

本集團的所得税開支包括年內土地增值税撥 備、中國企業所得税和遞延所得税。截至2024 年12月31日止年度,本集團錄得所得稅開支約 人民幣3.511.8百萬元,相比截至2023年12月 31日止年度約人民幣5,486.7百萬元的下降原因 是除所得税前利潤減少。

年度利潤

截至2024年12月31日止年度,歸屬於本公司權 益持有人的淨利潤約人民幣491.3百萬元,同 比截至2023年12月31日止年度下降44.1%,變 動主要受營業額、銷售及服務成本、銷售及營 銷成本、行政開支、金融資產減值虧損淨額、 所得税開支及來自終止經營業務的利潤等的綜 合影響。

截至2024年12月31日止年度,歸屬於本公司權 益持有人的核心盈利*約人民幣632.2百萬元。 核心盈利為一項非香港財務報告準則計量,有 助評估本集團核心業務營運的財務表現。其他 公司所用的類似詞彙可能會對該非香港財務報 告準則計量有不同定義。

Administrative Expenses

Administrative expenses decreased by 23.0% from approximately RMB4,149.8 million for the year ended 31 December 2023 to approximately RMB3,193.6 million for the year ended 31 December 2024, mainly because of the decrease in the number of employees and reduction of expenses.

Income Tax Expense

The Group's income tax expense includes provisions made for land appreciation tax, PRC corporate income tax and deferred income tax during the year. For the year ended 31 December 2024, the Group recorded an income tax expense of approximately RMB3,511.8 million, the reason for the decline compared to approximately RMB5,486.7 million for the year ended 31 December 2023 is the decrease in profit before income tax.

Profit for the Year

Net profit attributable to equity holders of the Company amounted to approximately RMB491.3 million for the year ended 31 December 2024, representing a year-on-year decrease of 44.1% compared to the year ended 31 December 2023, the change was mainly due to the combined effect of revenue, cost of sales and services, selling and marketing costs. administrative expenses, net impairment losses on financial assets, income tax expenses and profit from discontinued operation, etc.

Core earnings* attributable to equity holders of the Company amounted to approximately RMB632.2 million for the year ended 31 December 2024. Core earnings is a non-HKFRS measure for facilitating the evaluation of financial performance of the Group's core operations. Such non-HKFRS measure may be defined differently from similar terms used by other companies.

財務狀況

於2024年12月31日,本集團的借款總額為人民幣577.3億元,在手現金為人民幣106.2億元*。 淨負債權益比率**為53.8%,剔除預收款後的資產負債率***為65.7%。

本集團截至2024年12月31日止的長期借款佔總借款的比重為72.2%,確保了本集團未來現金流的健康穩定。董事會相信,本集團負債水平和財務結構的持續優化為本集團抵禦市場波動、減低財務風險奠定了良好基礎。

本集團銀行借款、優先票據、公司債券及中票等融資工具的加權平均借貸成本為年利率5.88%,平均貸款年限為5.4年;非抵押債務佔總債務比例為12.6%。抵押債務金額為人民幣500.9億元。抵押債務由以下一種或幾種方式的組合擔保:物業、廠房及設備、投資物業、完工待售或在建銷售物業及使用權資產。本集團的銀行借款向主要商業銀行(全部為獨立第三方)借入。

一年內到期債務為人民幣160.7億元,佔總債務比例為27.8%。借款的到期組別如下:

Financial Position

As at 31 December 2024, the total borrowings of the Group amounted to RMB57.73 billion and cash on hand amounted to RMB10.62 billion*. Net debt-to-equity ratio** was 53.8%, and the debt-to-asset ratio*** excluding advances received was 65.7%.

As of 31 December 2024, the proportion of long-term borrowings to total borrowings of the Group was 72.2%, ensuring the healthy and stable future cash flow of the Group. The Board believes that the continuous optimisation of the Group's debt level and financial structure has laid a solid foundation for the resilience to the market fluctuations and mitigation of financial risks.

The weighted average borrowing cost of the Group's bank borrowings, senior notes, corporate bonds, medium-term notes and other financial instruments was 5.88% per annum, with an average loan term of 5.4 years; the proportion of unsecured debt to total debt was 12.6%. Secured debt amounted to RMB50.09 billion. Secured debt were secured by one or a combination of the following methods: property, plant and equipment, investment properties, property held or under development for sale and right-of-use assets. The Group's bank borrowings are from major commercial banks, all of which are independent third parties.

Debts due within one year amounted to RMB16.07 billion, accounting for 27.8% of the total debt. The maturity groupings of the borrowings are as follows:

供股所得款項淨額用途

於2021年12月2日,本公司建議按非包銷基準進行供股,基準為於2022年1月4日(記錄日期)每持有二十一(21)股現有股份獲配發一(1)股供股股份,認購價為每股供股股份5.30港元(「供股」)。有關供股及本公司購股權相應調整的詳情,請參閱本公司日期分別為2021年12月2日、2022年1月10日及2022年1月26日的公告,以及本公司日期為2022年1月5日的供股章程(「供股章程」)。

供股已於2022年1月27日完成,並由本公司向 合資格股東(定義見供股章程)配發及發行合共 295,715,521股供股股份。供股所得款項淨額 約為1,559.79百萬港元。於2023年12月31日, 本集團已根據供股章程所披露的用途動用有關 所得款項淨額約623,920,000港元,而已分配 至收購四川省及湖北省土地(「收購土地」)的有 關所得款項淨額餘下935,870,000港元尚未動 用。考慮到中國土地市場的狀況,本集團就收 購土地採取更為審慎的方式,以確保任何有關 收購事項僅在仔細考慮且符合本公司及本公司 股東(「股東」)整體利益的情況下進行。因此, 收購土地的進度未如預期,而董事會認為,本 公司不大可能按原訂時間表或即時動用原本分 配至上述用途的資金。因此,截至2024年12 月31日止年度,董事會已議決原本分配至收 購土地的所得款項淨額將重新分配,全數用於 償還本集團的境外貸款(「重新分配所得款項淨 額」),此舉將令本集團能夠更有效部署其財務 資源,加強本集團財政穩健,以及改善本集團 服務品質,從而為股東創造長遠價值。於截至 2024年12月31日止年度,上述重新分配所得 款項淨額已生效並全面落實。於2024年12月 31日,供股所得款項淨額的全部金額已悉數動 用。

Other fund raising activities and use of proceeds

Use of net proceeds from the Rights Issue

On 2 December 2021, the Company proposed the rights issue on the basis of one (1) rights share for every twenty-one (21) existing shares held on 4 January 2022, being the record date, at the subscription price of HKD5.30 per rights share on a non-underwritten basis (the "Rights Issue"). For details of the Rights Issue and the resulting adjustments relating to the share options of the Company, please refer to the announcements of the Company dated 2 December 2021, 10 January 2022 and 26 January 2022, respectively, and the Rights Issue prospectus of the Company dated 5 January 2022 (the "Rights Issue Prospectus").

The Rights Issue was completed on 27 January 2022, and 295,715,521 rights shares in total were allotted and issued by the Company to the Qualifying Shareholders (as defined in the Rights Issue Prospectus). The net proceeds raised from the Rights Issue were approximately HKD1,559.79 million. As at 31 December 2023, the Group has utilised approximately HKD623.92 million of such net proceeds according to the purpose disclosed in the Rights Issue Prospectus, whereas the remaining HKD935.87 million of such net proceeds, which were allocated for acquisition of lands in Sichuan Province and Hubei Province (the "Acquisition of Lands"), remained unutilised. Considering the condition of the land market in the PRC, the Group had adopted a more prudent approach with regards to the Acquisition of Lands, with a view to ensure that any such acquisition is only made after more careful consideration and in the interests of the Company and the shareholders of the Company (the "Shareholders") as a whole. As a result, the progress of acquisition of lands has fallen short of expectations, and the Board considered that it is not likely for the Company to be able to apply the funds originally allocated for the above purpose by the original timeline or in a timely manner. As a result, during the year ended 31 December 2024, the Board has resolved that the net proceeds originally allocated for the Acquisition of Lands to be re-allocated and fully used for repayment of offshore loans of the Group (the "Re-allocation of Net Proceeds"), which would enable the Group to deploy its financial resources more efficiently, strengthen the financial health of the Group, and improve the quality of the Group's services, thereby creating long term value to the Shareholders. The aforesaid Re-allocation of Net Proceeds had taken effect and fully implemented during the year ended 31 December 2024. As at 31 December 2024, the entire amount of the net proceeds from the Rights Issue had been fully utilised.

Contingent Liabilities

Pursuant to the mortgage contracts, banks require the Group to guarantee its purchasers' mortgage loans. The Group's guarantee period typically starts from the date of the grant of the mortgage. Guarantees for mortgages on pre-sold residential properties are generally discharged at the earlier of: (i) the issue of the real estate ownership certificate by government authorities to the purchasers; or (ii) the satisfaction of mortgage loans by the purchasers of the properties. The Group has provided guarantees to financial institutions for mortgage loan facilities granted to purchasers of the Group's properties.

As at 31 December 2024, the Group's contingent liabilities in respect of the guarantees given to the financial institutions for mortgage loan facilities granted to purchasers of the Group's properties amounted to approximately RMB21,775.3 million (as at 31 December 2023: approximately RMB33,026.3 million).

As at 31 December 2024, there were certain corporate guarantees provided by the Company's subsidiaries for each other in respect of borrowings. The Directors considered that the Company's subsidiaries are sufficiently and financially resourceful to settle their obligations.

As at 31 December 2024, the Group provided pledge guarantee for the borrowings of such joint ventures and associates with equity held by the Group.

As at 31 December 2024, the Group provided guarantee with the amount of RMB2,751.6 million (as at 31 December 2023: RMB3,142.0 million) to its joint ventures and associates.

Save as those disclosed in this annual report, the Group had no other material contingent liabilities as at 31 December 2024.

Employees and Compensation Policy

As at 31 December 2024, the Group had 20,243 full-time employees in the PRC and Hong Kong, 19,935 of which worked in the property development operations and management of commercial complexes and 308 were engaged in other operations.

The Group determines the remuneration packages of all employees (including the Directors) based on their performance, work experience and the prevailing market wage level, and provides promotional opportunities for them with reference to their individual strengths and potentials. The remuneration package of the employees consists of basic salary, cash bonus and share-based payments. The Group has established a performance appraisal system so as to evaluate the performance of its employees on an annual basis and use the evaluation results to determine their salary increment or promotion accordingly.

主要業務

業績

回顧與展望

2024年,全國商品房銷售額實現人民幣9.7萬億元,同比下降17.1%;銷售面積9.7億平方米,同比下降12.9%。中國房地產行業仍處於築底階段,市場供需在不斷調節中。2024年刺激性政策頻出,為未來行業釋放堅定穩樓市基調。展望2025年,房地產政策有望在現有寬鬆基礎上優化完善,市場供需有望進入新的平衡階段,本公司的房地產業務有望實現銷售收入增長和資產運營提效。

回望2024,新城積極響應國家號召,堅守「讓幸福變得簡單」的企業使命,全力以赴保交樓、穩信用、守價值。全年累計交付住宅超10萬套,新開業吾悦廣場15座,新增物業託管面積超2,500萬平方米。在持續的行業調整中,全體新城人如堅毅的行者,每一套住宅的順利交付,每一座吾悦廣場的盛大開業,都是我們對承諾的莊嚴兑現。

PRINCIPAL ACTIVITIES

The principal activities of the Group are property development, property investment and commercial property management in China.

An analysis of the Group's revenue for the year ended 31 December 2024 by principal activities is set out in note 23 to the consolidated financial statements.

RESULTS

Review and Prospects

In 2024, the national commercial housing sales amount reached RMB9.7 trillion, representing a year-on-year decrease of 17.1%; the sales area amounted to 970 million sq.m., representing a year-on-year decrease of 12.9%. China's real estate industry is still in the bottoming-out phase, with market supply and demand under ongoing adjustment. In 2024, stimulus policies have been frequently introduced, setting a firm tone for stabilising the future property market. Looking forward to 2025, real estate policies are expected to be optimised and improved on the existing relaxed basis, and market supply and demand are expected to reach a new stage of equilibrium. The Company's real estate business is expected to achieve growth in sales revenue and enhance the efficiency of asset operation.

Looking back at 2024, Seazen actively responded to the national call, adhering to its corporate mission of "making happiness simple", and made every effort to guarantee house delivery, stabilise credit and preserve value. Throughout the year, the aggregate residential units delivered exceeded 100,000 units, 15 new Wuyue Plazas were opened, and the new property management area exceeded 25 million sq.m.. Amid the ongoing industry adjustments, all members of Seazen stood as determined trailwalkers. Each successful delivery of a residential unit and each grand opening of Wuyue Plaza represented our solemn fulfillment of commitments.

2024年,新城持續踐行ESG理念,將可持續發 展融入日常經營。截至2024年底,新城新建及 在建項目的綠建覆蓋率達到100%,累計獲得 64項國內外綠色認證,100座吾悦廣場獲得省 級以上綠色商場稱號。2024年,新城的MSCI ESG評級保持BBB級。

Strategically, Seazen adhered to its dual-drive strategy, offering premium housing products for society in residential operations, and continuing to deepen its efforts in commercial operations. The newly launched Wuyue Business Management brand marked another milestone in terms of the professionalisation of commercial operations and reflected our long-term aspirations for commercial development. By the end of 2024, 200 Wuyue Plazas urban complexes were either opened or under construction, with 173 already opened with an occupancy rate of 97.97%. Annual commercial operating income* was approximately RMB12,808 million. Each high-quality launch of a Wuyue Plaza represented a fusion of local culture, lifestyle sentiments, social gathering scenarios and brand ecosystems, revitalising urban commercial landscapes while driving local economic development.

In 2024, Seazen continued to put ESG principles in place, integrating sustainable development into its daily operations. By the end of 2024, 100% of Seazen's newly constructed projects and projects under construction met green building standards, with a total of 64 domestic and international green certifications obtained, and 100 Wuyue Plazas were awarded the title of green malls at the provincial level or above. In 2024. Seazen maintained its MSCI ESG rating of BBB.

Seazen adheres to a bottom-line mindset, ensuring that every debt is repaid either in advance or at maturity. The Group has received strong supports from financial institutions with respect to financing to ensure a smooth provision of financial facilities. In May 2024, Seazen Holdings, a subsidiary of the Group, successfully issued middle term notes of RMB1.36 billion, followed by another successful issuance of middle term notes of RMB1.56 billion in November. In November 2022, the People's Bank of China ("PBOC") and the CBIRC jointly issued the Notice on Providing Quality Financial Services to Promote the Stable and Healthy Development of the Real Estate Market (關於做好當前金融支持房地產市 場平穩健康發展工作的通知) (the "16 Financial Measures"). In January 2024, the General Office of the PBOC and the General Office of the National Financial Regulatory Administration jointly issued the Notice on the Management of Commercial Property Loans (關於做好經營性物業貸 款管理的通知) (together with the "16 Financial Measures", the "Two Policy Documents"). In September 2024, the Two Policy Documents originally due to expire by the end of 2024 were extended until the end of 2026. Benefitting from the support of this policy, the Group will further enhance its efforts in commercial property loans financing while actively pursuing domestic and international public market financing in response to market conditions. Moving forward. Seazen will continue to improve and optimise its capital structure, steadily strengthening its robust financial fundamentals.

We gather momentum for innovation to achieve long-term success with our steadfast efforts. We would like to express our gratitude to our partners for their trust and support in 2024. As the Company embarks on its 32nd year in 2025, facing numerous market challenges, Seazen will set sail once again with even greater determination, firmer conviction and a more pragmatic approach. PRINCIPAL RISKS AND UNCERTAINTIES

The following lists out the key risks and uncertainties the Group is facing. It is a non-exhaustive list and there may be other risks and uncertainties further to the key risk areas outlined below.

Risks Pertaining to the Property Market and Operation

The Group's businesses and prospects are largely dependent on the performance of the property market in mainland China. The property market in mainland China is affected by a number of factors, including changes in social, political, economic and legal environment, as well as changes in the government's financial, economic, monetary, industrial and environmental conservation policies. The Group is also susceptible to changes in economic conditions, consumer confidence, consumption spending, and changes in consumption preferences. The Group cannot predict whether any of the aforesaid changes in the PRC's economic, political and social conditions and in its laws, regulations and policies will have any adverse effect on the Group's current or future business, financial condition or results of operations.

中國物業市場反覆不定,或會出現供應不足或供應過剩及樓價波動的情況。本集團的業務有賴於並將繼續依賴於中國經濟的增長。中國經濟的大幅下滑可能對商業及住宅物業的需求造成不利影響。此外,本集團的營運受到物業發展、物業投資及物業相關業務多種特有的風險因素所影響,例如來自買家、租戶及策略性業性務夥伴的失責行為、內部流程、人為及系統性不足或失誤,或其他可能對經營業績構成不同程度的負面影響的外圍因素。

管理層將秉持穩健經營的原則,積極研判政策 變化、調整供貨結構和營銷策略,以降低以上 因素的影響。

流動資金風險

本集團正面臨流動資金壓力。鑒於當前流動資金狀況,本集團採取多項計劃及措施,以緩解流動資金壓力及改善本集團的財務狀況,詳情載於本報告「合併財務報表附註」中的附註2及3。

外匯風險

除若干銀行借款及發行優先票據以港元或美元 計值外,本集團僅於中國從事房地產開發、銷 售及管理,幾乎所有交易均以人民幣計值。由 於本集團若干現金結餘以及若干一般及行政費 用以及其他貸款(例如發行優先票據/美元債) 以美元或港元結算,本集團面臨美元及港元兑 人民幣而產生的外匯風險。

不以功能貨幣計值的現金及借款面臨外匯風險。港元及美元兑人民幣的匯率波動將影響本集團的經營業績。本集團目前並無外匯對沖政策。然而,管理層密切監察外匯資產及債務規模,以最大程度降低面臨的外匯風險,並於必要時採取行動。

The PRC property market is volatile and may experience undersupply or oversupply of property units and significant property price fluctuations. The Group's business depends and will continue to depend on the growth of the economy in the PRC. A significant downturn in the PRC's economy could adversely affect the demand for commercial and residential properties. In addition, the Group's operation is subject to a number of risk factors distinctive to property development, property investment and property related businesses, such as default on the part of our buyers, tenants and strategic business partners, inadequacies or failures of internal processes, people and systems or other external factors which may have various levels of negative impact on the results of operations.

The management will adhere to the principle of prudent operation, actively assess policy changes and adjust supply structures and marketing strategies, to mitigate the impact of the aforementioned factors.

Liquidity Risk

The Group is facing liquidity pressure. In light of the current liquidity position, the Group has undertaken a number of plans and measures to mitigate the liquidity pressure and to improve the financial position of the Group, details of which are set out in notes 2 and 3 to the "Notes to the Consolidated Financial Statements" in this report.

Foreign Exchange Risk

The Group is engaged in the development, sale and management of properties solely in the PRC with almost all the transactions denominated in RMB. The Group is exposed to foreign currency risk arising from the exposure of U.S. dollars and Hong Kong dollars against Renminbi as a result of certain cash balances and the settlement of certain general and administrative expenses and other loans (such as the issuance of senior notes) in U.S. dollars or Hong Kong dollars.

Cash and borrowings not denominated in functional currency is subject to foreign exchange risk. Fluctuations in the exchange rates of HKD and USD against RMB will affect the Group's result of operations. The Group currently does not have a foreign currency hedging policy. However, the management has closely monitored the scale of assets and liabilities in foreign currencies to minimise the foreign exchange exposure, and will take actions when necessary.

COMPLIANCE WITH RELEVANT LAWS AND REGULATIONS

The PRC property market is heavily regulated. The PRC government exerts considerable direct and indirect influence on the growth and development of the PRC property market through industry policies and other economic measures such as setting interest rates, controlling the supply of credit by changing bank reserve ratios and implementing lending restrictions/encouragement, increasing/sticking to tax and duties on property transfers.

The PRC government introduced a series of regulations and policies, including, among others, strictly enforcing the idle land related laws and regulations; restricting the grant or extension of revolving credit facilities to property developers that hold a large amount of idle land and vacant commodity properties; prohibiting commercial banks from lending funds to real estate developers with an internal capital ratio of less than a certain prescribed percentage; and restricting PRC commercial banks from granting loans to property developers for the purpose of paying land grant premiums; limiting the maximum amount of monthly mortgage and the maximum amount of total monthly debt service payments of an individual borrower; imposing tax levy on the sales proceeds for second-hand transfers subject to the length of holding period and type of properties; increasing the minimum amount of down payment of the purchase price of family residential property; tightening the availability of individual housing loans in the property market for individuals and their family members with more than one residential property; and limiting the availability of individual housing provident fund loans for the purchase of second (or more) residential properties by labourers and their family members.

During the year ended 31 December 2024, there was no material breach of or non-compliance with the applicable laws and regulations by the Group during the year.

本集團與其客戶及供應商保持良好關係。本集團主要供應商為建築材料供應商及建築承建商。本集團大部分物業發展項目委聘第三方承辦商提供有關各項服務,包括設計、樁設置、地基建設、建築、設備安裝、機電及管道道工程、電梯安裝及美化。本集團通常透過招標過程選擇第三方承辦商,努力委聘具有良好聲譽及業績記錄、高性能、可靠及財務資源充足的公司。

ENVIRONMENTAL POLICIES AND PERFORMANCE

Property developers in the PRC are subject to a number of environmental laws and regulations including the Environment Protection Law of the People's Republic of China (《中華人民共和國環境保護法》), the Prevention and Control of Noise Pollution Law of the People's Republic of China (《中華人民共和國環境噪聲污染防治法》), the Environmental Impact Assessment Law (《環境影響評價法》), and Administrative Regulations on Environmental Protection in Relation to Construction Projects (《建設項目環境保護管理條例》). The Group is subject to these laws and regulations concerning the protection of health and environment. The local authorities may request a developer to submit the environmental impact documents, issue orders to suspend the construction and impose a penalty for a project where environmental impact assessment documents have not been approved before commencement of construction. The Group is in compliance in all material respects with applicable environmental laws and regulations in the PRC.

For further details, please refer to the environmental, social and governance ("**ESG**") report of the Company, which will be reported separately from this report and will be published at the same time with this annual report.

RELATIONSHIPS WITH CUSTOMERS AND SUPPLIERS

The Group has maintained good relationships with its customers and suppliers. The major suppliers of the Group are construction material suppliers and construction contractors. The Group engages third-party contractors to carry out various services for most of its property development projects, including design, pile setting, foundation building, construction, equipment installation, electromechanical and pipeline engineering, elevator installation and landscaping. The Group generally selects third-party contractors through a tender process and endeavors to engage companies with good reputation and track record, high performance, reliability and adequate financial resources.

The Board's decision to declare or to pay any dividends in the future, and the amount of such dividends will depend upon, among other things, the current and future operations, financial condition, liquidity position and capital requirements of the Group, as well as dividends received from the Company's subsidiaries, which in turn will depend on the ability of those subsidiaries to pay a dividend. In addition, any final dividends for a financial year is subject to the approval of the Shareholders. The declaration and payment of dividends by the Company is also subject to any applicable restrictions under the laws of the Cayman Islands, the Company's articles of association and any other applicable laws, rules and regulations.

FINAL DIVIDEND

The Board does not recommend the declaration of any final dividend for the year ended 31 December 2024 (for the year ended 31 December 2023: nil).

Loan Agreement

Seazen Holdings and S-Enjoy Service entered into a loan agreement (the "Loan Agreement") on 30 September 2024 in relation to the provision of a loan in the principal amount of RMB120.0 million for a term commencing from the date of actual remittance and up to 29 September 2027 (the "New Loan").

Pursuant to the Loan Agreement, S-Enjoy Service Group Co., Limited and its subsidiaries ("S-Enjoy Service", and together with its subsidiaries, "S-Enjoy Group") (the "New Loan Lender") shall provide the New Loan in the principal amount of RMB120.0 million to Seazen Holdings Group (the "New Loan Borrower"). Subject to the fulfillment of the relevant conditions for remittance, the entire loan shall be remitted to the New Loan Borrower in one lot. The New Loan shall be used for the construction of the projects of the New Loan Borrower and replenishment of its working capital, and shall not be used in the stock market or for any illegal purpose. The interest rate for the New Loan shall be the higher of: (i) the LPR for loans of more than one year (inclusive) and less than five years (if any) published by PBOC applicable on the date of drawdown; and (ii) the fixed lending rate of 6.05% per annum. The interest shall be accrued daily based on a 360-day year commencing from the relevant drawdown date, and shall be paid on an annual basis on 30 September every year. The New Loan shall be secured by the mortgage of the Property provided by the New Loan Borrowers pursuant to a mortgage agreement.

S-Enjoy Service is indirectly owned as to 68.86% by Mr. Wang Zhenhua, a Controlling Shareholder. Accordingly, S-Enjoy Service is an associate of Mr. Wang Zhenhua and a connected person of the Company and the entering into of the Loan Agreement constitute connected transactions for the Company under Chapter 14A of the Listing Rules.

As the New Loan under the Loan Agreement is secured by the assets of Seazen Holdings Group, the transactions contemplated under the Loan Agreement, although represented financial assistance provided by connected persons of the Company for the benefit of the Group, would not be exempt from the reporting, announcement and Independent Shareholders' approval requirements for connected transactions under Rule 14A.90 of the Listing Rules, and thus compliance by the Company with the Listing Rules in relation to the Loan Agreement shall be necessary. As the highest percentage ratio (as defined in the Listing Rules) in respect of the New Loan under the Loan Agreement exceeds 0.1% but is less than 5%, the provision of the New Loan under the Loan Agreement is subject to the reporting and announcement requirements but are exempt from the circular and Independent Shareholders' approval requirements under Chapter 14A of the Listing Rules.

The Company has engaged S-Enjoy Group in the ordinary and usual course of business to provide property management services, and the property services framework agreement (the "2024 Seazen Framework Agreement") was entered into between Seazen Holdings and S-Enjoy Service on 27 October 2023 in relation to provision of property management services by S-Enjoy Group for a term of one year from 1 January 2024 to 31 December 2024 subject to the annual cap of RMB680 million. During the year ended 31 December 2024, the fees incurred by the Group for the property management services provided by S-Enjoy Group were approximately RMB343.15 million. As the 2024 Seazen Framework Agreement had expired on 31 December 2024, the renewed property services framework agreement (the "2025 Seazen Framework Agreement") was entered into between Seazen Holdings and S-Enjoy Service on 30 October 2024 in relation to provision of property management services by S-Enjoy Group for a term of 3 years from 1 January 2025 to 31 December 2027 subject to the annual cap of RMB100 million for each of the three years ending 31 December 2027.

The annual cap of the service fees under the 2024 Seazen Framework Agreement for the year ended 31 December 2024 shall not exceed RMB680 million, which was determined with reference to, among others, the following factors:

- the aggregate amount of approximately RMB489.5 million settled by the Company for property management services and value-added services for the nine months ended 30 September 2023;
- (2) the Group's total contracted sales area of approximately 7.53 million sq.m. for the nine months ended 30 September 2023;
- (3) the expected sales scale, area and number of the Group's property projects to be managed by S-Enjoy Service, as well as the pre-sale and delivery time of such property projects;
- (4) the estimated demand of the Group for property management services and the price charged by such services; and
- (5) other factors such as the Group's business plans, inflation and 10% buffer for all categories of services.

The annual caps of the service fees under the 2025 Seazen Framework Agreement for each of the three years ending 31 December 2027 shall not exceed RMB100.0 million, RMB100.0 million and RMB100.0 million, respectively. The service fees are expected to be satisfied by the internal resources of the Group.

Accordingly, S-Enjoy Service is an associate of Mr. Wang Zhenhua and a connected person of the Company and the entering into of the 2024 Seazen Framework Agreement and the 2025 Seazen Framework Agreement and the transactions contemplated thereunder constitute continuing connected transactions for the Company under Chapter 14A of the Listing Rules.

As the highest applicable percentage ratios in respect of the transactions contemplated under the 2024 Seazen Framework Agreement is more than 5%, the transactions contemplated thereunder are subject to the reporting, announcement, annual review and independent shareholders' approval requirements under Chapter 14A of the Listing Rules. The effective date of the Loan Framework Agreement was the date which the conditions in the Loan Framework Agreement have been satisfied and that the Loan Framework Agreement has been approved by the shareholders of S-Enjoy Services and the Company, respectively. The Loan Framework Agreement has been approved by the Shareholders at the extraordinary general meeting of the Company held on 9 December 2024.

Pursuant to the Loan Framework Agreement, S-Enjoy Group (the "Lender") shall provide the loan in the aggregate principal amount of RMB1,000.0 million to Seazen Holdings Group (the "Borrower"). Subject to the terms of the Loan Framework Agreement, and upon fulfilment of the underlying conditions for drawdown thereunder, the Borrower may drawdown the Loan in several tranches within the term of the Loan Framework Agreement. The Lender and the Borrower shall separately enter into specific agreements and security documents for the relevant drawdowns. The Loan is a one-time line of credit, and any repaid principal amount of the Loan under the relevant specific agreements to be entered into pursuant to the Loan Framework Agreement shall not refresh the total amount available for drawdown within the term of the Loan Framework Agreement. Loan shall be used for the construction of the projects of the Borrower and replenishment of its working capital. The Borrower shall provide its assets as approved by the Lender as credit enhancement measures of the Loan.

- (i) with regard to any amount drawdown which is secured by assets of Seazen Holdings Group, the Company expects that the corresponding total value of the Charged Assets shall maintain at similar level as the unpaid principal amount of the Loan divided by the loan-to-value ratio of 60%, and the Company will monitor any repaid Loan principal and apply to the Lender to release the Charged Assets thereto on a timely basis;
- (ii) the finance department of the Company will closely monitor the outstanding Loan balances to be repaid and report the latest status of the Loan granted to the finance department of the Company on a monthly basis to ensure that the outstanding loan balances will not exceed the proposed annual caps. In the event the aggregated principal amount of the Loan is expected to exceed the proposed annual caps, the responsible staff would escalate the issue to the Board forthwith, and the Company would timely re-comply with the requirements under Chapter 14A of the Listing Rules;

The internal audit department of the Company reviewed the continuing connected transactions and the adequacy and effectiveness of the internal control procedures, and provided the findings to the independent non-executive Directors to assist them in performing their annual reviews. The independent non-executive Directors also made appropriate enquiries with the management to ensure that they have sufficient information to review the transactions and the internal control procedures. All independent non-executive Directors confirmed that the transactions were conducted:

- 1. in the ordinary and usual course of business of the Group;
- 2. under normal commercial terms or not less favourable terms that the Group receives or provides services from an independent third party or obtains from an independent third party; and
- 3. in accordance with the agreements related to the above continuing connected transactions, the terms of which are fair and reasonable and in the interest of the Shareholders as a whole.

In this connection, PwC has tendered its resignation as the Auditor with effect from 25 November 2024 pursuant to the consensus of the Company and PwC.

With the recommendation of the Audit Committee, Grant Thornton Hong Kong Limited has been appointed by the Board as the new Auditor with effect from 26 November 2024 to fill the casual vacancy following the resignation of PwC until the conclusion of the next annual general meeting of the Company.

Save as the above, there was no change in Auditor during the past three years.

MATERIAL EVENTS DURING THE REPORTING PERIOD

Amendments to the Memorandum and Articles of Association

On 28 March 2024, the Company announced the proposed amendments to the memorandum and articles of association of the Company for the purposes of, among others, (i) updating and bringing the then existing third amended and restated memorandum and articles of association of the Company in line with the latest regulatory requirements in relation to the expanded paperless listing regime and the electronic dissemination of corporate communications by listed issuers and the relevant amendments made to the Listing Rules which took effect from 31 December 2023; and (ii) incorporating certain housekeeping changes (the "**Proposed Amendments**"). The Proposed Amendments were subsequently approved by the Shareholders at the annual general meeting of the Company held on 28 June 2024.

EVENTS AFTER THE REPORTING PERIOD

Save as disclosed in this report, the Group did not have any significant events as at the end of the reporting period and up to the date of this report.

企業管治常規

本集團致力於保持企業管治的高標準,以保障股東的權益及提升企業價值與問責性。本公司已採納企業管治守則,作為其本身的企業管治守則。本公司於截至2024年12月31日止年度一直遵守企業管治守則所載的守則條文。本公司將繼續檢討及提升其企業管治常規,以確保遵守企業管治守則。

董事會

職責

董事會負責本集團的整體領導,監督本集團的 戰略決策及監控業務與表現。董事會已向本集 團高級管理層授予有關本集團日常管理及經營 方面的權力及職責。為監督本公司事務的特定 方面,董事會已成立四個董事委員會,包括審 核委員會、薪酬委員會、提名委員會及ESG委 員會(統稱「董事委員會」)。董事會已向董事委 員會授權彼等各自職權範圍所載的職責。

全體董事須確保彼等各自須以誠信態度執行職 責,並遵守適用法例及法規,且始終符合本公 司及其股東的利益。

本公司已為本集團董事安排適當的責任保險, 以彌償彼等因企業活動所引致的責任。保險範 圍將每年進行審閱。

董事會組成

董事會目前由三名執行董事(即呂小平先生、陸忠明先生及周福東先生)、一名非執行董事(即王曉松先生(彼亦是董事長))及三名獨立非執行董事(即朱增進先生、鍾偉先生及吳科女士)組成。該等董事的履歷均載於本年報「董事」一節。董事服務合約的詳情載於本年報董事會報告內。

The Board is pleased to present this corporate governance report in the annual report of the Company for the year ended 31 December 2024.

CORPORATE GOVERNANCE PRACTICES

The Group is committed to maintaining high standards of corporate governance to safeguard the interests of the Shareholders and to enhance corporate value and accountability. The Company has adopted the CG Code as its own code of corporate governance. The Company has complied with the code provisions as set out in the CG Code for the year ended 31 December 2024. The Company will continue to review and enhance its corporate governance practices to ensure compliance with the CG Code.

THE BOARD

Responsibilities

The Board is responsible for the overall leadership of the Group, oversees the Group's strategic decisions and monitors business and performance. The Board has delegated the authority and responsibility for day-to-day management and operation of the Group to the senior management of the Group. To oversee particular aspects of the Company's affairs, the Board has established four Board committees, namely the Audit Committee, the Remuneration Committee, the Nomination Committee and the ESG Committee (together, the "Board Committees"). The Board has delegated to the Board Committees responsibilities as set out in their respective terms of reference.

All Directors shall ensure that they carry out duties in good faith, in compliance with applicable laws and regulations, and in the interests of the Company and its Shareholders at all times.

The Company has arranged appropriate liability insurance to indemnify the Group's Directors for their liability arising from corporate activities. The insurance coverage will be reviewed on an annual basis.

Board Composition

The Board currently comprises three executive Directors, namely Mr. Lv Xiaoping, Mr. Lu Zhongming and Mr. Zhou Fudong, one non-executive Director, namely Mr. Wang Xiaosong (who is also the chairman of the Board), and three independent non-executive Directors, namely Mr. Zhu Zengjin, Mr. Zhong Wei and Ms. Wu Ke. The biographies of the Directors are set out under the section headed "Directors" of this annual report. The details of the service contracts of the Directors are set out in the Report of the Directors of this annual report.

誠如截至2024年12月31日止年度年報中所披露,董事會遵守上市規則第3.10(1)及3.10(2)條有關委任至少三名獨立非執行董事的規定,而其中至少有一名獨立非執行董事擁有適當的專業資格或會計或相關財務管理專長,亦已遵守上市規則第3.10A條有關委任佔董事會人數至少三分之一的獨立非執行董事。

根據上市規則第3.10A條,發行人所委任的獨立非執行董事必須佔董事會成員人數至少三分之一。誠如本年報所披露,本公司目前有三名獨立非執行董事,佔董事會成員人數至少三分之一,因此本公司符合上市規則第3.10A條。

根據企業管治守則的守則條文第B.2.4(b)條,倘所有獨立非執行董事均於董事會在任超過九年,則應於本公司的應屆股東週年大會上委任一名新獨立非執行董事。吳科女士於2024年6月28日舉行股東週年大會上獲委任,以滿足守則條文。

上市發行人須採納董事會成員多元化政策。本公司已採納董事會成員多元化政策,故符合該守則條文。董事會成員多元化政策概要載列於下文「董事委員會一提名委員會」。

本公司已接獲各位獨立非執行董事根據上市規則規定的獨立身份週年書面確認函。本公司認為,根據上市規則所載的獨立身份指引,全體獨立非執行董事均屬獨立人士。

除本年報所披露者外,各董事與任何其他董事 之間概無任何個人關係(包括財務、商業、親 屬或其他重大/相關關係)。

全體董事(包括獨立非執行董事)已為董事會的 有效運作帶來廣泛有價值的業務經驗、知識及 專業技能。獨立非執行董事應邀於審核委員 會、薪酬委員會及提名委員會任職。

至於企業管治守則條文規定董事應向發行人披露其於公眾公司或組織擔任職位的數目及性質以及其他重大承擔,亦應披露所涉及的公眾公司或組織的名稱以及其擔任有關職務所涉及的時間,全體董事已同意適時向本公司披露他們的職務承擔及任何變動。

As disclosed in this annual report for the year ended 31 December 2024, the Board met the requirements of Rules 3.10(1) and 3.10(2) of the Listing Rules relating to the appointment of at least three independent non-executive Directors with at least one independent non-executive Director possessing appropriate professional qualifications or accounting or related financial management expertise and Rule 3.10A of the Listing Rules relating to the appointment of independent non-executive Directors representing at least one-third of the Board.

Under Rule 3.10A of the Listing Rules, issuers are required to appoint independent non-executive Directors representing at least one-third of the Board. As disclosed in this annual report, the Company has three independent non-executive Directors currently representing one-third of the Board and therefore the Company has complied with Rule 3.10A of the Listing Rules.

Pursuant to code provision B.2.4(b) of the CG Code, if all the independent non-executive Directors have served on the Board for more than nine years, a new independent non-executive Director should be appointed at the forthcoming annual general meeting of the Company. Ms. Wu Ke was appointed at the annual general meeting held on 28 June 2024 to satisfy the code provision.

Listed issuers are required to adopt a board diversity policy. The Company has adopted a board diversity policy and therefore complied with this code provision. A summary of the board diversity policy is set out under "Board Committees – Nomination Committee" below.

The Company has received written annual confirmation from each independent non-executive Director of his/her independence pursuant to the requirements of the Listing Rules. The Company considers all independent non-executive Directors to be independent in accordance with the independence guidelines as set out in the Listing Rules.

Save as disclosed in this annual report, none of the Directors has any personal relationship (including financial, business, family or other material/relevant relationship) with any other Director.

All Directors, including independent non-executive Directors, have brought a wide spectrum of valuable business experience, knowledge and professionalism to the Board for its efficient and effective functioning. Independent non-executive Directors are invited to serve on the Audit Committee, the Remuneration Committee and the Nomination Committee.

In regards to the CG Code provision requiring Directors to disclose to the issuer the number and nature of offices held in public companies or organisations and other significant commitments, as well as their identity and an indication of the time involved, all the Directors have agreed to disclose their commitments and any change to the Company in a timely manner.

- 3. 鑒於良好企業管治常規及避免利益衝突, 兼任本公司控股股東及/或控股股東若干 子公司董事及/或高級管理層的董事會於 有關控股股東及/或其聯繫人士的交易的 相關董事會決議案中放棄投票;
- 4. 董事長與獨立非執行董事每年至少會面一次;及
- 5. 董事會所有成員於必要時可根據本公司政 策尋求獨立專業意見以履行彼等職責。

董事會每年檢討有關制度,旨在確保其可聽取獨立觀點及意見,不論是有關獨立非執行董事的比例、招聘及獨立性,以及確保彼等所作貢獻以及有途徑獲取外部獨立專業建議。

Mechanisms to Ensure Independent Views

The Company ensures independent views and input are available to the Board via the below mechanisms:

- The Board composition and the independence of the independent non-executive Directors should be reviewed by the Nomination Committee on an annual basis, in particular the independence of some of the independent non-executive Directors who has served for more than nine years;
- A written confirmation was received by the Company under Rule 3.13
 of the Listing Rules from each of the independent non-executive
 Directors in relation to his independence to the Company. The
 Company considers all its independent non-executive directors to be
 independent;
- 3. In view of good corporate governance practices and to avoid conflict of interests, the Directors who are also directors and/or senior management of the Company's controlling shareholders and/or certain subsidiaries of the controlling shareholders, would abstain from voting in the relevant Board resolutions in relation to the transactions with the controlling shareholders and/or its associates;
- 4. The chairman of the Board shall meet with independent nonexecutive Directors at least once annually; and
- 5. All members of the Board can seek independent professional advice when necessary to perform their responsibilities in accordance with the Company's policy.

The Board reviews the mechanisms for ensuring independent views and input are available to the Board on an annual basis, whether in terms of the proportion, recruitment and independence of independent non-executive Directors, and ensures them to make contribution and have access to external independent professional advice.

周福東先生作為新獲委任董事,已於2025年3 月26日接受董事培訓。周福東先生已確認彼知 悉其作為本公司董事的責任。

董事長及行政總裁

根據企業管治守則第C.2.1條守則規定,主席及行政總裁的角色應分離且由不同人士擔任。 本公司董事長和行政總裁的職務分離,分別的 王曉松先生和呂小平先生擔任。董事長王時松 先生負責本公司業務戰略和整體發展等重大 項。在聯席公司秘書的協助下,董事長擬備每 一個董事會之議程、確保公司良好的企業管治 常規及程序均獲全面遵守、確保全體董事獲及 時提供足夠及可靠資料,足以應付彼等根據專 長作出必要分析所需及鼓勵所有董事積極投入 董事會事務,並以身作則,確保董事會行事符 合本公司最佳利益。

行政總裁呂小平先生負責管理本集團業務的日 常運作。

董事長及行政總裁之角色互相分立,各自有明 確職責區分。

Induction and Continuous Professional Development

To assist the Directors in discharge of their duties, each newly appointed Director will be provided with necessary induction and information to ensure that they have a proper understanding of the Company's operations and businesses as well as their responsibilities under relevant statutes, laws, rules and regulations. The Company also arranges regular seminars to provide all Directors with updates on latest development and changes in the Listing Rules and other relevant legal and regulatory requirements from time to time. The Directors are also provided with regular updates on the Company's performance, position and prospects to enable the Board as a whole and each Director to discharge their duties. The joint company secretaries, from time to time, update and provide written training materials relating to the roles, functions and duties of Director.

During the year, each of the Directors, namely Mr. Lv Xiaoping, Mr. Lu Zhongming, Mr. Wang Xiaosong, Mr. Zhang Shengman, Mr. Zhu Zengjin, Mr. Zhong Wei and Ms. Wu Ke, received and studied these training materials. The Company has received confirmation from all Directors of their respective training records for the year ended 31 December 2024.

Mr. Zhou Fudong as a newly appointed director has received director's training on 26 March 2025. Mr. Zhou Fudong has confirmed he understood his obligations as a director of the Company.

Chairman and Chief Executive Officer

Under code provision C.2.1 of the CG Code, the roles of chairman and chief executive officer should be separate and performed by different individuals. The positions of chairman and chief executive officer of the Company are segregated and are held by Mr. Wang Xiaosong and Mr. Lv Xiaoping respectively. The Chairman of the Board, Mr. Wang Xiaosong, is responsible for material matters such as business strategies and overall development of the Company. With the assistance of the joint company secretaries, the Chairman draws up the agenda for each Board meeting, ensures that good governance practices and procedures are complied with and that all the Directors are provided with sufficient and reliable information in a timely manner required for necessary analysis based on their expertise, encourages all Directors to make an active contribution to the Board's affairs and take the lead in ensuring that the Board acts in the best interests of the Company.

The chief executive officer, Mr. Lv Xiaoping, is responsible for managing the day-to-day operations of the Group's business.

The roles of the chairman and the chief executive officer are separate and independent, with clear division of responsibilities.

根據本公司組織章程細則,全體董事須每三年至少輪值退任一次,且任何因填補臨時職位空缺而經董事會委任的新任董事須在接受委任後的本公司首屆股東週年大會上提請其本身供股東進行選舉,而因填補董事會而獲委任的新董事須在接受委任後的本公司下屆股東週年大會上提請其本身供股東進行重選。

董事的委任、重選及罷免的程序及過程乃載於 本公司組織章程細則。提名委員會負責檢討董 事會組成及監察董事的委任、重選及繼任計 劃。

Appointment and Re-Election of Directors

Mr. Wang Xiaosong has entered into an appointment letter with the Company for a term of three years commencing from 18 October 2024, and his appointment may be terminated in accordance with the terms of the appointment letter.

Mr. Lv Xiaoping has entered into an appointment letter with the Company for a term of three years commencing from 7 January 2025, and his appointment may be terminated in accordance with the terms of the appointment letter.

Mr. Lu Zhongming has entered into an appointment letter with the Company for a term of three years commencing from 7 January 2025, and his appointment may be terminated in accordance with the terms of the appointment letter.

Mr. Zhou Fudong has entered into a service contract with the Company for a term of three years commencing from 1 April 2025 and his service may be terminated in accordance with the terms of the service contract.

Mr. Zhu Zengjin entered into an appointment letter with the Company for a term of two years commencing from 6 November 2024.

Mr. Zhong Wei entered into an appointment letter with the Company for a term of two years commencing from 3 December 2024.

Ms. Wu Ke entered into an appointment letter with the Company, for a term of two years commencing from 28 June 2024.

None of the Directors has entered into with the Group any service agreement which is not determinable by the Group within one year without payment of compensation (other than statutory compensation).

In accordance with the Company's articles of association, all Directors are subject to retirement by rotation at least once every three years and any new Director appointed by the Board to fill a causal vacancy shall submit himself/herself for election by Shareholders at the first annual general meeting of the Company after appointment and new Directors appointed in addition to the Board shall submit himself/herself for reelection by Shareholders at the next following annual general meeting of the Company after appointment.

The procedures and process of appointment, re-election and removal of Directors are set out in the Company's articles of association. The Nomination Committee is responsible for reviewing the Board composition, monitoring the appointment, re-election and succession planning of Directors.

Board Meetings

The Company adopted the practice of holding Board meetings regularly, at least four times a year, and at approximately quarterly intervals. Notices of not less than fourteen days are given for all regular Board meetings to provide all Directors with an opportunity to attend and include matters in the agenda for a regular meeting. For other Board and committee meetings, a reasonable notice is generally given. The agenda and accompanying Board papers are despatched to the Directors or committee members at least three days before the meetings to ensure that they have sufficient time to review the papers and be adequately prepared for the meetings. When Directors or committee members are unable to attend a meeting, they will be advised of the matters to be discussed and given an opportunity to make their views known to the chairman prior to the meeting. Minutes of meetings are kept by the joint company secretaries with copies circulated to all Directors for information and records.

Minutes of the Board meetings and committee meetings are recorded in sufficient detail including the matters considered by the Board and the committees and the decisions reached, and any concerns raised by the Directors. Draft minutes of each Board meeting and committee meeting are sent to the Directors for consideration within a reasonable time after the date on which the meeting was held. The minutes of the Board meetings are open for inspection by Directors.

The chairman also held a meeting with the independent non-executive Directors without presence of other Directors during the year.

Mr. Lv Xiaoping, the executive Director who took the chair of the 2024 annual general meeting and the extraordinary general meeting, together with other members of the Board who attended that meeting, were of sufficient calibre for answering, and had competently answered, the questions raised at those meetings.

Model Code for Securities Transactions

The Company has adopted the Model Code as set out in Appendix C3 to the Listing Rules as its code of conduct regarding Directors' securities transactions. Having made specific enquiries with all the Directors, each of the Directors has confirmed that he has complied with the Model Code throughout the year ended 31 December 2024.

For the year ended 31 December 2024, the Company has also adopted its code of conduct regarding employees' securities transactions on terms no less exacting than the standards set out in the Model Code for compliance by its relevant employees who are likely to own inside information of the Company in respect of their dealings in the Company's securities.

企業管治職能

董事會知悉企業管治乃全體董事的共同責任, 而授予提名委員會的企業管治職責包括:

- (j) 制定、檢討及推行本公司的企業管治政策 及常規,並向董事會提出建議;
- (ii) 檢討及監察董事及高級管理層培訓及持續 專業發展;
- (iii) 檢討及監察本公司在遵守法律及監管規定 方面的政策及常規;
- (iv) 制定、檢討及監察僱員及董事的操守準則 及合規手冊(如有);
- (v) 檢討本公司遵守企業管治守則的情況及於 企業管治報告內的披露;及
- (vi) 制定、檢討及監察股東通訊政策的有效推 行及適時向董事會提出有助鞏固本公司與 股東的關係的建議。

Delegation by the Board

The Board reserves for its decision all major matters of the Company, including approval and monitoring of all policy matters, overall strategies and budgets, internal control and risk management systems, material transactions (in particular those that may involve conflicts of interests), financial information, appointment of Directors and other significant financial and operational matters. Directors could have recourse to seek independent professional advice in performing their duties at the Company's expense and are encouraged to access and consult with the Company's senior management independently.

The daily management, administration and operation of the Group are delegated to the senior management. The delegated functions and responsibilities are periodically reviewed by the Board. Approval has to be obtained from the Board prior to any significant transactions entered into by the management.

Corporate Governance Function

The Board recognizes that corporate governance should be the collective responsibility of Directors and delegated the corporate governance duties to the Nomination Committee which include:

- to develop, review and implement the Company's policy and practices on corporate governance and make recommendations to the Board;
- (ii) to review and monitor the training and continuous professional development of Directors and senior management;
- (iii) to review and monitor the Company's policies and practices in compliance with legal and regulatory requirements;
- (iv) to develop, review and monitor the code of conduct and compliance manual (if any) applicable to employees and Directors;
- (v) to review the Company's compliance with the CG Code and disclosure in the Corporate Governance Report; and
- (vi) to develop, review and monitor the implementation of the Shareholders' communication policy to ensure its effectiveness, and make recommendations to the Board where appropriate to enhance Shareholders' relationship with the Company.

為提升董事會的效益及企業管治水平,董事會應保持執行與非執行董事(包括獨立非執行董事)的均衡組合,使董事會高度獨立而可有效發揮獨立的判斷能力。

本公司已採納一項董事會成員多元化政策(「董事會多元化政策」)並制定可計量目標。提名委員會評估董事會成員在技巧、經驗及多樣的觀點與角度的平衡和結合。在甄選候選人時,將從多樣的觀點與角度出發,包括但不限於考慮年齡、文化及教育背景、專業及行業經驗、技巧、知識、種族、對本公司業務具有不可優勢,其他素質,以至候選人能為董事會帶來的優勢及貢獻。董事會將不時審閱該等可計量目標,確保其合適及確認達致該等目標的進度。

BOARD COMMITTEES

Nomination Committee

The Nomination Committee comprises three members, including one executive Director and two independent non-executive Directors. It is chaired by an independent non-executive Director. The members of the Nomination Committee are Mr. Zhu Zengjin (chairman), Mr. Lu Zhongming and Ms. Wu Ke, the majority of them are independent non-executive Directors.

The principal duties of the Nomination Committee include the following:

- to review the structure, size and composition of the Board, assist the Board in maintaining a board skills matrix, and make recommendations regarding any proposed changes;
- to identify suitable candidates for appointment as Directors and develop the Company's Board and employee diversity policies;
- to make recommendations to the Board on appointment or re-appointment of and succession planning for Directors; and
- to assess the independence of independent non-executive Directors.
- to support the regular evaluation of the Board's performance.

The Nomination Committee will assess the candidate or incumbent on criteria such as integrity, experience, skill and ability to commit time and effort to carry out the duties and responsibilities. The recommendations of the Nomination Committee will then be put to the Board for decision. Their written terms of reference are available on the websites of the Stock Exchange and the Company. The nomination policy of the Company will be further discussed in the paragraph headed "Nomination policy" below.

With a view to enhance Board effectiveness and corporate governance, the Board should include a balanced composition of executive and non-executive Directors (including independent non-executive Directors) so that there is a strong independent element on the Board, which can effectively exercise independent judgment.

The Company adopted a board diversity policy (the "Board Diversity Policy") with measurable objectives. The Nomination Committee evaluates the balance and blends of skills, experience and diversity of perspectives of the Board. Selection of candidates is based on a range of diverse perspectives, including but not limited to age, cultural and educational background, professional and industry experience, skills, knowledge, ethnicity and other qualities essential to the Company's business, and merit and contribution that the selected candidates will bring to the Board. The Board will review such measurable objectives from time to time to ensure their appropriateness and ascertain the progress made towards achieving those objectives.

Pursuant to the Board Diversity Policy, the Group aims to maintain at least one female representation in the Board and the current composition of the Board satisfies this target. Going forward, the Board will strive to maintain or improve this proportion of female representation.

Nomination Policy

This nomination policy adopted by the Company aims to set out the approach to guide the nomination committee of the Company in relation to the election, appointment and re-appointment of the Directors. It aims to ensure that the Board has the skills, experience, knowledge and diversity of perspectives appropriate to the requirements of the Company's business.

The relevant provisions of the Terms of Reference of the Nomination Committee adopted by the Company are regarded as the key nomination criteria and principles of the Company for the nomination of Directors, and these provisions, as set out below, constitute the nomination policy of the Company:

- to review the structure, size and composition (including skills, knowledge, experience and gender) of the Board on a regular basis at least annually, assist the board in maintaining a board skills matrix, and make recommendations to the Board regarding any proposed change to complement the Company's corporate strategy;
- (ii) to develop the criteria for identifying and assessing the qualifications of and evaluating candidates for directorship, including but not limited to evaluating the balance of skills, knowledge and experience on the Board, and in the light of this evaluation prepared a description of the role and capabilities required for a particular appointment; develop the Company's Board diversity in the member selection process and employees (including senior management) diversity policy in the employees selection process, which include but not limited to the following factors: gender, age, culture, perspectives, education background, and professional experience, review and update the objects that the Board has set for implementing such policies, monitor the progress made and the gender diversity targets annually;
- (iii) to identify individuals who are qualified/suitable to become a member of the Board and to select or make recommendations to the Board on the selection of individuals nominated for directorships, having due regard to the Board Diversity Policy, the Company's constitution, the Listing Rules and applicable laws and regulations, and the relevant candidates' contributions to the Board in terms of qualifications, skills, experiences, independence and gender diversity;
- (iv) to assess the independence of independent non-executive directors to determine their eligibility with reference to the factors set out in Rule 3.13 of the Listing Rules and any other factors deemed appropriate by the Nomination Committee or the Board. If a proposed independent non-executive director will be holding their seventh (or more) listed company directorship, to assess his/her ability to devote sufficient time to the Board matters;

Proposed candidates will be asked to submit the necessary personal information, together with their written consent to be appointed as a director of the Company. The Nomination Committee may request candidates to provide additional information and documents, if considered necessary.

The Nomination Committee shall evaluate the proposed candidate's suitability with reference to the information and aspects stated above and make recommendation(s) to the Board's consideration and approval.

In the case of the re-election of a Director at the general meeting, the Nomination Committee shall review the overall contribution of the Directors to the Company and their services, their participation and performance within the Board, and whether such Director still meets the needs to complement the Company's corporate strategy.

Remuneration Committee

The Remuneration Committee currently comprises three members, namely Mr. Zhu Zengjin (chairman), Mr. Zhong Wei and Ms. Wu Ke, three of them are independent non-executive Directors.

The primary duties of the Remuneration Committee include making recommendations on and approving/determining the remuneration policy and structure and remuneration packages of the executive Directors and the senior management. The Remuneration Committee is also responsible for establishing transparent procedures for formulating such remuneration policy and structure to ensure that no Director or any of his/her associates will participate in deciding his/her own remuneration, which remuneration will be determined by reference to the performance of the individual and the Company as well as market practice and conditions. Their written terms of reference are available on the websites of the Stock Exchange and the Company.

The Directors acknowledge their responsibility for preparing the financial statements for the year ended 31 December 2024 which give a true and fair view of the affairs of the Company and the Group and the Group's results and cash flows.

The statement by the auditor of the Company regarding their reporting responsibilities on the consolidated financial statements of the Company is set out in the Independent Auditor's Report on pages 109 to 112 of this annual report.

The management has provided to the Board such explanation and information as necessary to enable the Board to carry out an informed assessment of the Company's financial statements, which are provided to the Board for approval. The Company provides all members of the Board with monthly updates on the Company's performance, positions and prospects.

In preparing financial statements for the year ended 31 December 2024, the Directors have (i) selected suitable accounting policies and applied them consistently; (ii) made judgements and estimates that are prudent and reasonable; and (iii) prepared financial statements on a going concern basis. The Directors noted that the auditor of the Company (the "Auditor") has indicated some material uncertainties relating to events or conditions that may cast significant doubt on the Group's ability to continue as a going concern. During the year ended 31 December 2024 and up to the date of the consolidated financial statements, the Group experienced a year-on-year decline in the collection of property sales proceeds and pre-sales performance due to the downturn of the Mainland China property market. As at 31 December 2024, the Group's current liabilities exceeded its current assets by RMB17,743,103,000. As at the same date, the Group had current borrowings amounted to RMB16,071,392,000 in aggregate, while its cash and cash equivalents amounted to RMB6,914,613,000 and restricted cash amounted to RMB3,703,679,000. The Auditor is of the view that these events and conditions indicate that a material uncertainty exists that may cast significant doubt on the Group's ability to continue as a going concern. The Auditor's opinion is not modified in respect of this matter.

Save as aforesaid and as disclosed under the section headed "(iii) Going concern basis" in note 2.1 to the consolidated financial statements, the Board, having made all reasonable enquiries, is not aware of any material uncertainties relating to any events or conditions that may cause significant doubt upon the Company's ability to continue as a going concern.

企業管治報告

Corporate Governance Report

鑒於上述情況,董事在評估本集團是否會具有 足夠財務來源以持續經營時,已審慎考慮本集 團未來流動資金、表現、可融資來源、管理層 過往表現以及政策趨勢等。經過過去一年的努 力,本集團充分借助政策支持,實現了融資總 量和結構的優化以及融資成本的下降,確保了 公開市場的到期全額兑付。本集團將實施下列 措施以減輕資金壓力及改善財務狀況:

- 1) 進一步鞏固本集團商業運營管理的優勢地 位,提升本集團商業運營總收入,作為有 息負債本息償還的重要來源;
- 2) 繼續借助金融政策支持,增加經營性物業 貸融資、增加公開市場債券融資、積極推 進消費類基礎設施REITS的註冊發行、積 極參與不動產相關的創新融資,同時積極 推進股權類融資,增加資本和資金,調整 資產負債結構和降低資產負債率。抓住市 場止跌回穩的機會,恢復和提升主體信用 融資,與資產信用融資相互補充;
- 3) 抓住收儲政策的落地機會,採用多種方式 盤活存量資產,增加現金來源;
- 4)繼續加強與主要建造商和供貨商的溝通, 友好協商妥善安排付款金額、進度及方式,平滑工程款和材料款的支付,確保各項目施工有序進行。

董事已審閱管理層編製的本集團現金流量預測,其涵蓋期間自本合併財務報表報告日起不少於12個月的期間。鑒於行業和市場信心有所恢復、全面的政策支持、豐富的流動性管理經驗、持續的可融資源,董事會認為本集團將能夠獲得足夠的營運資金及融資來源以確保本集團於2024年12月31日後12個月內能夠清償到期的債務。因此,董事會認為採用持續經營基礎編製本集團的合併財務報表是恰當的。

In view the above circumstances, the Directors have given careful consideration to the future liquidity and performance of the Group, its available sources of financing, past performance of management and policy trend in assessing whether the Group will have sufficient financial sources to continue as a going concern. With the efforts made in the past year, the Group fully capitalised on the policy support to optimise facility line and structure and reduce financing costs, ensuring the full payment in the open market when maturity. The following measures are formulated to mitigate the liquidity pressure and to improve the financial position of the Group:

- further enhancing the Group's advantages in commercial operation management and increasing the commercial operation revenue as a major source of funds for repayments of principals and interests of interests-bearing liabilities;
- 2) continuing to leverage financial policy support to increase operating property loan financing, increase open market bond financing, actively promote the registration and issuance of consumer infrastructure REITS, actively participate in real estate related innovative financing, and at the same time actively promote equity financing to increase capital and funding, adjust the gearing structure and reduce the gearing ratio. Seizing the opportunity of market stabilisation to restore and enhance principal credit financing to complement asset credit financing;
- seizing the opportunities of implementing resumption policy and adopting various methods to revitalise existing assets to increase cash sources;
- 4) continuing to enhance communications with major constructors and supplier, amicably negotiating the proper arrangements of payment schedules and methods to smooth out the payments for project costs and materials and keep the constructions of projects proceeding as scheduled.

The Directors have reviewed the Group's cash flow projections prepared by management, which cover a period of not less than twelve months from the reporting date of the consolidated financial statements. In view of the recovery of industry and market confidence, comprehensive policy support, extensive experience in liquidity management, continuous availability of financing resources, the Boards are of the opinion that, the Group will have sufficient working capital to finance its operations and to meet its financial obligations as and when they fall due within twelve months from 31 December 2024. Accordingly, the Board are satisfied that it is appropriate to prepare the consolidated financial statements of the Group on a going concern basis.

風險管理及內部監控系統主要包括董事會、審 核委員會、高級管理層及內部審核部門組成的 四級架構。

- 至少每年與高級管理層討論本公司面臨的 主要風險,以及高級管理層為評估及應對 該等風險已採取或應採取的措施;及
- 持續檢討本公司風險管理實務的有效性。

高級管理層負責管理本公司的風險管理程序, 於考慮環境變化及本公司的風險承受能力後, 負責確保本公司業務營運乃遵照我們的風險管 理政策進行。

RISK MANAGEMENT AND INTERNAL CONTROL

Risk Management and Internal Control Systems

The Board, the Audit Committee, the senior management and the internal audit department are the four levels of structure and main features of risk management and internal control systems.

The Board acknowledges that it is the responsibility of the Board for maintaining adequate risk management and internal control systems to safeguard the investments of the Shareholders and the assets of the Company and reviewing the effectiveness of such systems on an annual basis. Risk management and internal control systems were designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable, but not absolute, assurance against material misstatement or loss.

As disclosed in its terms of reference of the Audit Committee, the Audit Committee is responsible for the oversight of the Company's risk management and internal control systems. The Audit Committee oversees the risk management process and reviews the effectiveness of the risk management and internal control systems by conducting the following procedures:

- reviewing the Company's risk management process and policy;
- reviewing with senior management at least annually the reports demonstrating the compliance with the risk management policy;
- discussing with senior management at least annually the Company's major risk exposures and the steps senior management has taken or should take to assess and treat such exposures; and
- reviewing the ongoing effectiveness of the Company's risk management practices.

Senior management is responsible for administering the Company's risk management process, and for ensuring that the Company's business operations are conducted in compliance with our risk management policy after taking into consideration changes in the environment and the Company's risk tolerance.

Responsibilities of the Company's senior management include:

- designing and implementing a Company-wide risk management policy;
- reviewing and updating the risk management policy on a timely basis, ensuring it remains relevant and adequate, taking into account changes in the environment, industry and the Company's operations and risk profile and, where necessary, recommending changes to the risk management policy for the Audit Committee to review;
- ensuring that the Company's risk management process is aligned and integrated with the annual strategic and business planning process and vice versa;
- designing and establishing a risk management methodology which provides the appropriate tools to identify, evaluate, and manage business exposures;
- establishing a Company-wide risk reporting process to ensure that the Company's senior management, the Audit Committee and the Board are apprised of all material risk issues and business exposures;
- ensuring necessary management controls and oversight processes are in place to monitor compliance with the risk management policy and the risk management methodology;
- approving and monitoring key risk positions and exposure trends, risk management strategies and risk management priorities;
- reviewing and discussing the Company's overall risk profile, key and emerging risks and risk management activities through periodic risk discussions among senior management; and
- reviewing the key business strategies and initiatives to assess their impact on the Company's overall risk position.

風險管理程序

董事會及高級管理層根據(i)本公司財務業績風險影響的嚴重程度、(ii)風險發生的概率及(iii)風險可能發生的速率或速度評估風險。

截至2024年12月31日止年度,本公司已確保遵守企業管治守則項下的風險管理及內部監控條文。董事會於風險管理及內部監控系統年度檢討期間已確認,發行人的會計、內部審計、財務報告職能方面的資源、員工資歷及經驗、培訓計劃及預算,以及與本公司ESG表現及報告相關的資源、員工資歷及經驗、培訓計劃及預算屬充足。

內幕消息

董事會就可能影響股份價格或股份交投量的任何意料之外的重大事件評估其可能影響,並釐定有關信息是否根據上市規則第13.09條及第13.10條以及證券及期貨條例第XIVA部內幕消息條文是否屬內幕消息,且是否需在實際可行情況下儘快作出披露。執行董事及本公司聯席公司秘書亦負責批准若干董事會授權本公司不時刊發的若干公告及/或通函。

Risk Management Process

In addition to the Board's oversight responsibilities, the Company has developed a risk management process to identify, evaluate and manage significant risks and to resolve material internal control defects (if any). Senior management, through the Company's internal audit department, is responsible for the annual risk reporting process. Members of the internal audit department meet with various members of the senior management to review and assess risks and discuss solutions to address material internal control defects (if any), including any changes relevant to a given year. Risks are compiled, ratings are assigned and mitigation plans are documented. The risk assessment is reviewed by certain members of senior management and presented to the Audit Committee and the Board for their review. No major deficiencies were identified in the reviews during the year ended 31 December 2024.

Risks are evaluated by the Board and senior management based on (i) the severity of the impact of the risk on the Company's financial results, (ii) the probability that the risk will occur, and (iii) the velocity or speed at which the risk could occur.

During the year ended 31 December 2024, the Company has ensured that the risk management and internal control provisions under the CG Code have been complied with. The Board, during its annual review on the risk management and internal control systems, has confirmed the adequacy of the resources, staff qualifications and experience, training programmes and budget of the issuer's accounting, internal audit, financial reporting functions, as well as those relating to the Company's ESG performance and reporting.

Inside Information

The Board assesses the likely impact of any unexpected and significant event that may have impact on the price of the shares or their trading volume and decides whether the relevant information is considered as inside information and needs to be disclosed as soon as reasonably practicable pursuant to Rules 13.09 and 13.10 of the Listing Rules and the Inside Information Provisions under Part XIVA of the SFO. Executive Directors and the joint company secretaries of the Company also may have responsibility for approving certain announcements and/or circulars to be issued by the Company as authorised by the Board from time to time.

核數師酬金

本集團於截至2024年12月31日止年度應付予本公司外聘核數師的年度審計費用約為人民幣1.2百萬元。此外,於2024年發生的費用包括新城控股外聘核數師就其年度審計收取費用約人民幣3.2百萬元,稅務諮詢等非審計服務費用約為人民幣0.9百萬元。

聯席公司秘書

截至2024年12月31日止年度,張宛玲女士及伍 秀薇女士為本公司的聯席公司秘書。

張宛玲女士負責就企業管治事宜向董事會提出 建議,並確保遵循董事會的政策及程序、適用 法律、規則及法規。

為維持良好的企業管治並確保符合上市規則及適用香港法律,本公司亦委聘達盟香港有限公司(公司秘書服務提供商)董事伍秀薇女士擔任聯席公司秘書,協助張宛玲女士履行彼作為本公司的公司秘書的職責。本公司的主要聯絡人為聯席公司秘書張宛玲女士。

截至2024年12月31日止年度,張宛玲女士及伍 秀薇女士分別已遵照上市規則第3.29條進行不 少於15小時的相關持續培訓。

Internal Audit Department

The Group's internal audit department plays a major role in monitoring the internal governance of the Company. The major responsibilities of the internal audit department are reviewing the financial conditions and internal control of the Company, and conducting comprehensive audits of all branches and subsidiaries of the Company on a regular basis.

For the year ended 31 December 2024, the Board has conducted a review of the effectiveness of the risk management and internal control systems of the Group and considered the risk management and internal control systems to be effective and adequate.

AUDITOR'S REMUNERATION

Annual audit fee of the Group for the year ended 31 December 2024 payable to the Company's external auditor is approximately RMB1.2 million. In addition, there are fees incurred in 2024, including fees of approximately RMB3.2 million for annual audit of Seazen Holdings charged by its external auditor, and fees of approximately RMB0.9 million for non-audit services including tax consulting.

JOINT COMPANY SECRETARIES

During the year ended 31 December 2024, Ms. Zhang Wanling and Ms. Ng Sau Mei were the joint company secretaries of the Company.

Ms. Zhang Wanling is responsible for advising the Board on corporate governance matters and ensuring that the Board policy and procedures, and the applicable laws, rules and regulations are followed.

In order to uphold good corporate governance and ensure compliance with the Listing Rules and applicable Hong Kong laws, the Company also engages Ms. Ng Sau Mei, director of TMF Hong Kong Limited (a company secretarial services provider), as its Joint Company Secretary to assist Ms. Zhang Wanling to discharge her duties as company secretary of the Company. The primary corporate contact person at the Company is Ms. Zhang Wanling, the joint company secretary.

During the year ended 31 December 2024, Ms. Zhang Wanling and Ms. Ng Sau Mei have undertaken not less than 15 hours of relevant professional training, respectively, in compliance with Rule 3.29 of the Listing Rules.

意見

OPINION

We have audited the consolidated financial statements of Seazen Group Limited (the "Company") and its subsidiaries (together, the "Group") set out on pages 113 to 300, which comprise the consolidated statement of financial position as at 31 December 2024, and the consolidated statement of profit or loss, the consolidated statement of comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including material accounting policy information.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2024, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and have been properly prepared in compliance with the disclosure requirements of Hong Kong Companies Ordinance.

BASIS FOR OPINION

We conducted our audit in accordance with Hong Kong Standards on Auditing ("HKSAs") issued by the HKICPA. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Consolidated Financial Statements section of our report. We are independent of the Group in accordance with the HKICPA's Code of Ethics for Professional Accountants (the "Code"), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.



與持續經營有關的重大不確定性

我們提請 閣下垂注合併財務報表附註2.1,於2024年12月31日, 貴集團流動負債超出流動資產約人民幣17,743,103,000元。同日, 貴集團的流動借款合計約為人民幣16,071,392,000元, 而其現金及現金等價物約為人民幣6,914,613,000元,受限制現金約為人民幣3,703,679,000元。此等事件及情況,以及合併財務報表附註2.1所述的其他事項,顯示存在重大不確定性,可能會對 貴集團持續經營的能力產生重大疑慮。我們的意見並無就此事宜作出修訂。

關鍵審計事項

關鍵審計事項是根據我們的專業判斷,認為對本期合併財務報表的審計最為重要的事項。這 些事項是在我們審計整體合併財務報表及對其 出具意見過程中需要應對的,但我們不對這些 事項提供單獨的意見。

MATERIAL UNCERTAINTY RELATED TO GOING CONCERN

We draw attention to note 2.1 to the consolidated financial statements, which indicates that as at 31 December 2024, the Group's current liabilities exceeded its current assets by approximately RMB17,743,103,000. As at the same date, the Group had current borrowings amounted to approximately RMB16,071,392,000 in aggregate, while its cash and cash equivalents amounted to approximately RMB6,914,613,000 and restricted cash amounted to approximately RMB3,703,679,000. These events and conditions, along with other matters as set forth in note 2.1 to the consolidated financial statements, indicate that a material uncertainty exists that may cast significant doubt on the Group's ability to continue as a going concern. Our opinion is not modified in respect of this matter.

KEY AUDIT MATTERS

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

In addition to the matter described in the Material Uncertainty Related to Going Concern section, we have determined the matters described below to be the key audit matters to be communicated in our report.



1 一般資料

新城發展控股有限公司(「本公司」)於2010年4月23日根據開曼群島公司法(2010年修訂本)在開曼群島註冊成立為獲豁免有限公司。其註冊辦事處地址為Grand Pavilion, Hibiscus Way, 802 West Bay Road, P.O. Box 31119, Grand Cayman KY1-1205, Cayman Islands。

本公司及其子公司(統稱「本集團」)的主要業務為於中華人民共和國(「中國」)從事物業開發及物業投資。本公司的母公司為富域香港投資有限公司(「富域香港」),本公司的最終控股公司為First Priority Group Limited,兩家公司均於英屬處女群島註冊成立。本集團最終控股方為王振華先生(「王先生」或「控股股東」)。

本公司股份於2012年11月29日開始在香港聯合交易所有限公司(「聯交所」)主板上市(「上市」)。

除另有指明外,合併財務報表以人民幣千元(「人民幣千元」)為單位呈列。

本公司董事會(「董事會」)已於2025年3月 28日批准及授權刊發此等載於第113頁至 第300頁的合併財務報表。

1 GENERAL INFORMATION

Seazen Group Limited (the "Company") was incorporated in the Cayman Islands on 23 April 2010 as an exempted company with limited liability under the Companies Law (2010 Revision) of the Cayman Islands. The address of its registered office is Grand Pavilion, Hibiscus Way, 802 West Bay Road, P.O. Box 31119, Grand Cayman KY1-1205, Cayman Islands.

The principal activities of the Company and its subsidiaries (together, the "Group") are property development and property investment in the People's Republic of China (the "PRC"). The Company's parent company is Wealth Zone Hong Kong Investments Limited ("Wealth Zone Hong Kong") and the Company's ultimate holding company is First Priority Group Limited, both of which are incorporated in the British Virgin Islands. The ultimate controlling party of the Group is Mr. Wang Zhenhua ("Mr. Wang" or the "Controlling Shareholder").

The Company's shares began to list on the Main Board of The Stock Exchange of Hong Kong Limited ("The Stock Exchange") on 29 November 2012 (the "Listing").

The consolidated financial statements are presented in thousands of Renminbi ("RMB'000"), unless otherwise stated.

These consolidated financial statements set out on pages 113 to 300 have been approved and authorised for issue by the board of directors (the "Board") of the Company on 28 March 2025.

As at 31 December 2024, the Group's current liabilities exceeded its current assets by approximately RMB17,743,103,000. Non-controlling interests in the results and equity of subsidiaries are shown separately in the consolidated statement of financial position, consolidated statement of profit or loss, consolidated statement of comprehensive income and consolidated statement of changes in equity respectively.

(ii) Associates

Associates are all entities over which the Group has significant influence but not control or joint control. This is generally the case where the Group holds between 20% and 50% of the voting rights. Investments in associates are accounted for using the equity method of accounting (see (iv) below), after initially being recognised at cost.

Properties in the course of construction for production, supply or administrative purposes are carried at cost, less any recognised impairment loss. Various costs incurred for qualifying assets and borrowing costs capitalised in accordance with the Group's accounting policy. Such properties are classified to the appropriate categories of property, plant and equipment when completed and ready for intended use. Depreciation of these assets, on the same basis as other property assets, commences when the assets are ready for their intended use.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognised when replaced. Property that is held for long-term rental yields or for capital appreciation or both, and that is not occupied by the Group, is classified as investment property. Investment property also includes property that is being constructed or developed for future use as investment property.

The Group is the lessor of certain leased properties. For leased right-of-use assets together with leasehold improvements leased out, the Group classifies them as investment properties and measured them at fair value.

After initial recognition, investment property is carried at fair value. Changes in fair value are recognised and presented separately in the consolidated statement of profit or loss.

Fair value is based on active market prices, adjusted, if necessary, for any difference in the nature, location or condition of the specific asset. If this information is not available, the Group uses alternative valuation methods such as recent prices on less active markets or discounted cash flow projections. These valuations are performed at balance sheet date by external valuers.

Property under construction is measured at fair value if the fair value is considered to be reliably measurable. If the fair value cannot be reliably determined, the investment property under construction will be measured at cost until such time as fair value can be determined or construction is completed, whichever is earlier. Any difference between the fair value of the property at that date and its then carrying amount shall be recognised in the consolidated statement of profit or loss. Investment property that is being redeveloped for continuing use as investment property, or for which the market has become less active, continues to be measured at fair value.

Subsequent expenditure is capitalised to the asset's carrying amount only when it is probable that future economic benefits associated with the expenditure will flow to the Group and the cost of the item can be measured reliably. All other repairs and maintenance costs are expensed when incurred.

Goodwill is not subject to amortisation and is tested annually for impairment, or more frequently if events or changes in circumstances indicate that it might be impaired. Other assets are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of disposal and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets (cash-generating units). Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at the end of each reporting period.

Properties held or under development for sale are included in current assets at the lower of cost and net realisable value. The costs of properties held or under development consist of costs of leasehold land, construction expenditure, capitalised borrowing costs and other direct costs incurred during the development period. The costs of properties held are determined by apportionment of the total development costs for that development project attributable to the unsold properties. Net realisable value is based on estimated selling price in the ordinary course of business as determined by management with reference to the prevailing market conditions, less further costs expected to be incurred to completion and selling and marketing costs.

2.2.7 Borrowings and borrowing costs

Borrowings are initially recognised at fair value, net of transaction costs incurred. Borrowings are subsequently stated at amortised cost; any difference between the proceeds (net of transaction costs) and the redemption amount is recognised in the consolidated statement of profit or loss over the period of the borrowings using the effective interest method.

Borrowings are classified as current liabilities unless as at the end of the reporting period, the Group has a right to defer settlement of the liability for at least twelve months after the end of the reporting period.

Covenants that the Group is required to comply with, on or before the end of the reporting period, are considered in classifying loan arrangement with covenants as current or non-current. Covenants that the Group is required to comply with after the reporting period do not affect the classification.

Fees paid on the establishment of loan facilities are recognised as transaction costs of the loan to the extent that it is probable that some or all of the facilities will be drawn down. In this case, the fee is deferred until the drawdown occurs. To the extent there is no evidence that it is probable that some or all of the facility will be drawn down, the fee is capitalised as a prepayment for liquidity services and amortised over the period of the facilities to which it relates.

Borrowings are removed from the consolidated statement of financial position when the obligation specified in the contract is discharged, cancelled or expired. The difference between the carrying amount of a financial liability that has been extinguished or transferred to another party and the consideration paid, including any non-cash assets transferred or liabilities assumed, is recognised in profit or loss as other income or finance costs.

General and specific borrowing costs that are directly attributable to the acquisition, construction or production of a qualifying asset are capitalised during the period of time that is required to complete and prepare the asset for its intended use or sale. Qualifying assets are assets that necessarily take a substantial period of time to get ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation. Other borrowing costs are expensed in the period when they are incurred.

The income tax expense for the year is the tax payable on the current period's taxable income based on the applicable income tax rate for each jurisdiction adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and to unused tax losses.

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the end of the reporting period in the countries where the Company and its subsidiaries operate and generate taxable income. Management periodically evaluate positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation and establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

Deferred income tax is provided in full, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. However, deferred tax liabilities are not recognised if they arise from the initial recognition of goodwill. The deferred income tax is not accounted for if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss, and does not give rise to equal taxable and deductible temporary differences. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantively enacted by the end of the reporting period and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

The deferred tax liability in relation to investment property that is measured at fair value is determined assuming the property will be recovered entirely through sale.

Deferred tax assets are recognised to the extent that it is probable that future taxable profit will be available to utilise those temporary differences and losses.

Deferred tax liabilities and assets are not recognised for temporary differences between the carrying amount and tax bases of investments in foreign operations where the Group is able to control the timing of the reversal of the temporary differences and it is probable that the differences will not reverse in the foreseeable future.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets and liabilities and when the deferred tax balances relate to the same taxation authority. Current tax assets and tax liabilities are offset where the entity has a legally enforceable right to offset and intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

Current and deferred tax is recognised in profit or loss, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

Companies within the Group may be entitled to claim special tax deductions for investments in qualifying assets or in relation to qualifying expenditure. The Group accounts for such allowances as tax credits, which means that the allowance reduces income tax payable and current tax expense. A deferred tax asset is recognised for unclaimed tax credits that are carried forward as deferred tax assets.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of management's best estimate of the expenditure required to settle the present obligation at the end of the reporting period. The discount rate used to determine the present value is a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability. The increase in the provision due to the passage of time is recognised as interest expense.

A contingent liability is a possible obligation that arises from past events and whose existence will only be confirmed by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Group. It can also be a present obligation arising from past events that is not recognised because it is not probable that outflow of economic resources will be required or the amount of obligation cannot be measured reliably.

A contingent liability is not recognised but is disclosed in the notes to the consolidated financial statements. When a change in the probability of an outflow occurs so that outflow is probable, it will then be recognised as a provision.

The Group provides commercial property management services. Revenue from providing services is recognised in the accounting period in which the services are rendered.

For commercial property management services, the Group billed a fixed amount each month for services provided and recognised as revenue in the amount to which the Group has a right to invoice and corresponds directly with value of performance completed.

A receivable is recorded when the Group has an unconditional right to consideration. A right to consideration is unconditional if only the passage of time is required before payment of that consideration is due.

(iii) Other services

The Group provides various services to its customers at fixed or variable amounts. If the consideration is variable, the Group estimates the amount of consideration to which it will be entitled in exchange for the promised goods or services. The estimated amount of variable consideration is included in the transaction price only to the extent that it is highly probable that a significant reversal in the amount of cumulative revenue recognised will not occur when the uncertainty associated with the variable consideration is subsequently resolved. The Group recognises revenue associated with fixed fees over time where the customer simultaneously receives and consumes the benefits provided by the Group or when the Group's performance do not create an asset with alternative use and the Group has an enforceable right to perform completed to date, by reference to completion of the specific transaction assessed on the basis of the actual costs incurred up to the end of the reporting period as a percentage of total estimated costs for each contract.

(c) Presentation of contract liabilities

Advanced proceeds received from customers are presented as contract liabilities.

(d) Accounting for significant financing component

Following the adoption of HKFRS 15, the amount of revenue recognised exceeds the amount of cash received from the customers when an arrangement contains a significant financing component.

2.2.11 Leases

Leases are recognised as a right-of-use asset and a corresponding liability at the date at which the leased asset is available for use by the Group.

Contracts may contain both lease and non-lease components. The group allocates the consideration in the contract to the lease and non-lease components based on their relative stand-alone prices. However, for leases of real estate for which the group is a lessee, it has elected not to separate lease and non-lease components and instead accounts for these as a single lease component.

Assets and liabilities arising from a lease are initially measured on a present value basis. Lease liabilities include the net present value of the following lease payments:

- fixed payments (including in-substance fixed payments), less any lease incentives receivable;
- variable lease payment that are based on an index or a rate, initially measured using the index or rate as at the commencement date:
- amounts expected to be payable by the group under residual value guarantees;
- the exercise price of a purchase option if the group is reasonably certain to exercise that option; and
- payments of penalties for terminating the lease, if the lease term reflects the group exercising that option.

Lease payments to be made under reasonably certain extension options are also included in the measurement of the liability.

The lease payments are discounted using the interest rate implicit in the lease. If that rate cannot be readily determined, which is generally the case for leases in the Group, the lessee's incremental borrowing rate is used, being the rate that the individual lessee would have to pay to borrow the funds necessary to obtain an asset of similar value to the right-of-use asset in a similar economic environment with similar terms, security and conditions.

Right-of-use assets are generally depreciated over the shorter of the asset's useful life and the lease term on a straight-line basis. If the Group is reasonably certain to exercise a purchase option, the right-of-use asset is amortised over the underlying asset's useful life. While the Group revalues its land and buildings that are presented within property, plant and equipment, it has chosen not to do so for the right-of-use buildings held by the Group.

Payments associated with short-term leases of equipment and vehicles and all leases of low-value assets are recognised on a straight-line basis as an expense in profit or loss. Short-term leases are leases with a lease term of 12 months or less. Low-value assets comprise IT equipment and small items of office furniture.

Lease income from operating leases where the Group is a lessor is recognised in income on a straight-line basis over the lease term. Initial direct costs incurred in obtaining an operating lease are added to the carrying amount of the underlying asset and recognised as expense over the lease term on the same basis as lease income. Impairment testing of the investments in subsidiaries is required upon receiving a dividend from these investments if the dividend exceeds the total comprehensive income of the subsidiary in the period the dividend is declared or if the carrying amount of the investment in the separate financial statements exceeds the carrying amount in the consolidated financial statements of the investee's net assets including goodwill.

2.3.2 Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker.

The board of the Company has appointed a strategic steering committee which assesses the financial performance and position of the Group, and makes strategic decisions. The steering committee, which has been identified as being the chief operating decision maker, consists of the chief executive officer, the chief financial officer and the manager for corporate planning.

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). Since the majority of the assets and operations of the Group are located in the PRC, the financial statements are presented in RMB, which is the functional currency of the Company and the presentation currency of the Group.

(ii) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation of monetary assets and liabilities denominated in foreign currencies at year end exchange rates are generally recognised in profit or loss. They are deferred in equity if they relate to qualifying cash flow hedges and qualifying net investment hedges or are attributable to part of the net investment in a foreign operation.

Foreign exchange gains and losses that relate to borrowings and cash and cash equivalents are presented in the statement of profit or loss within 'finance income or costs'. All other foreign exchange gains and losses are presented in the consolidated statement of profit or loss within 'other gains or losses – net'.

(c) Impairment of financial assets

The Group assesses on a forward looking basis the expected credit losses associated with its debt instrument carried at amortised cost and financial assets at fair value through other comprehensive income. The impairment methodology applied depends on whether there has been a significant increase in credit risk. Note 3.1.2 details how the Group determines whether there has been a significant increase in credit risk.

For trade receivables, the Group applies the simplified approach permitted by HKFRS 9, which requires expected lifetime losses to be recognised from initial recognition of the receivables.

For other receivables, financial assets at amortised cost and financial assets at FVOCI, the Group applies the general model for expected credit loss prescribed by HKFRS 9, since credit risk has not significantly increased after initial recognition, the loss allowance recognised was therefore limited to 12 months expected losses.

(d) Recognition and derecognition

Regular way purchases and sales of financial assets are recognised on trade-date, the date on which the Group commits to purchase or sell the asset. Financial assets are derecognised when the rights to receive cash flows from the financial assets have expired or have been transferred and the Group has transferred substantially all the risks and rewards of ownership.

2.3.8 Cash and cash equivalents

For the purpose of presentation in the consolidated statement of cash flows, cash and cash equivalents include cash on hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value. Restricted cash is excluded from cash and cash equivalents.

2.3.9 Trade and other payables

Trade and other payables represent liabilities for goods and services provided to the Group prior to the end of financial year which are unpaid. Trade and other payables are presented as current liabilities unless payment is not due within 12 months after the reporting period (or out of the normal operating cycle of the business if longer).

Trade and other payables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method.

The municipal and provincial governments undertake to assume the retirement benefit obligations of all existing and future retired mainland China based employees payable under the plans described above. Other than the monthly contributions, the Group has no further obligation for the payment of retirement and other post-retirement benefits of its employees. The assets of these plans are held separately from those of the Group in independently administrated funds managed by the municipal and provincial governments.

Termination benefits are payable when employment is terminated by the group before the normal retirement date, or when an employee accepts voluntary redundancy in exchange for these benefits. The group recognises termination benefits at the earlier of the following dates: (a) when the group can no longer withdraw the offer of those benefits; and (b) when the entity recognises costs for a restructuring that is within the scope of HKAS 37 and involves the payment of terminations benefits. In the case of an offer made to encourage voluntary redundancy, the termination benefits are measured based on the number of employees expected to accept the offer. Benefits falling due more than 12 months after the end of the reporting period are discounted to present value.

The Group's activities expose it to a variety of financial risks: market risk (including foreign exchange risk, price risk, cash flow and fair value interest rate risk), credit risk and liquidity risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

3.1.1 Market risk

(i) Foreign exchange risk

The Group is engaged in the development, sale and management of properties solely in the PRC with almost all the transactions denominated in RMB, except for certain borrowings from banks and issuance of senior notes which are denominated in Hong Kong Dollar ("HKD") or United States Dollar ("USD"). As of 31 December 2024 and 2023, majority of the Group's assets and liabilities are denominated in RMB except that certain cash and borrowings are denominated in HKD or USD.

Cash and borrowings not denominated in functional currency is subject to foreign exchange risk. Fluctuations in the exchange rates of HKD and USD against RMB will affect the Group's result of operations. The Group currently does not have a foreign currency hedging policy. However, management closely monitors the foreign exchange exposure and will take actions when necessary.

As at 31 December 2024, if RMB had strengthened/ weakened by 5%, against HKD and USD with all other variables held constant, post-tax profit for the year would have been RMB362,847,000 (2023: RMB190,916,000) higher/lower, mainly as a result of net foreign exchange gains/losses on translation of HKD and USD denominated bank deposits and borrowings.

The Group typically provides guarantees to secure obligations of such customers for repayments, normally up to the time when the customers obtain the legal certificates of the property ownership. Detailed disclosure of these guarantees is made in note 34.

(b) Cash in banks (included restricted cash)

The Group expects that there is no significant credit risk associated with cash deposits at banks since they are substantially deposited with state-owned banks and other medium or large size listed banks. Management does not expect that there will be any significant losses from non-performance by these counterparties.

(c) Trade receivables

The Group applies the simplified approach to providing for ECL prescribed by HKFRS 9, which permits the use of the lifetime expected loss provision for all trade receivables. To measure the ECL, trade receivables have been grouped based on shared credit risk characteristics and the days past due. The ECL also incorporate forward looking information.

The Group has policies in place to ensure that sales are made to purchasers with an appropriate financial strength and appropriate percentage of down payments. The Group has arranged bank financing for certain purchasers of the Group's property units and provided guarantees to secure obligations of such purchasers for repayments. If a purchaser defaults on the payment of its mortgage loan during the guarantee period, the bank holding the guarantee may demand the Group to repay the outstanding principal of the loan and any interest accrued thereon. Under such circumstances, the Group is able to forfeit the customer's deposit and resell the property to recover any amounts paid by the Group to the bank. In this regard, the directors consider that the Group's credit risk is significantly reduced.

The Group also provides guarantees to certain related parties of the Group to obtain borrowings after assessing the credit history and pledge information of these related parties. The Group closely monitors the repayment progress of the relevant borrowings by these related parties. In the opinion of the directors of the Group, the related party transactions were carried out in the normal course of business and at terms mutually negotiated between the Group and the respective related parties. The directors consider that the likelihood of default in payments is not material, as all the related parties are engaged in property development with solid financial position.

The Group monitors capital on the basis of the gearing ratio. This ratio is calculated as net debt divided by total capital. Net debt is calculated as total borrowings and lease liabilities less cash and cash equivalents. Total capital is calculated as total equity, as shown in the consolidated statement of financial position, plus net debt.

Changes in level 2 and 3 fair value are analysed at the end of each reporting period during the half-yearly valuation discussion between the CFO, AC and the valuation team. As part of this discussion, the team presents a report that explains the reason for the fair value movements.

(b) Non-financial assets and liabilities

The Group's investment property is measured at fair value and under level 3 of the fair value hierarchy. Please see note 7 for details of valuation.

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances. The management makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are outlined below.

4.1 Development costs directly attributable to property development activities

The Group allocates portions of land and development costs to properties held and under development for sale. As certain of the Group's property development projects are developed and completed by phases, the budgeted development costs of the whole project are dependent on the estimate on the outcome of total development. Based on the experience and the nature of the development undertaken, the management makes estimates and assumptions concerning the future events that are believed to be reasonable under the circumstances. Given the uncertainties involved in the property development activities, the related actual results may be higher or lower than the amount estimated at the end of the reporting period. Any change in estimates and assumptions would affect the Group's operating performance in future years.

4.2 Provision for impairment of properties held or under development for sale

The management makes provision for impairment of properties held or under development for sale based on the estimate of the recoverable amount of the properties. Given the volatility of the property market in the PRC, the actual recoverable amount may be higher or lower than the estimate made as at the end of the reporting period. Any increase or decrease in the provision would affect the Group's operating performance in future years.

4.3 Land appreciation tax of the PRC

The Group is subject to land appreciation tax in the PRC. However, since the implementation and settlement of the tax varies among various tax jurisdictions in cities of the PRC, significant estimate is required in determining the amount of the land appreciation tax. The Group recognises the land appreciation tax based on management's best estimates according to its understanding of the interpretation of tax rules by various tax authorities. The final tax outcome could be different from the amounts that were initially recorded, and these differences will impact the income tax expense in the periods in which such taxes have been finalised with local tax authorities.

4.4 Current and deferred income tax

The Group is subject to corporate income tax in the PRC. Significant judgement is required in determining the provision for corporate income tax. There are many transactions and calculations for which the ultimate determination is uncertain during the ordinary course of business. Where the final tax outcome of these matters is different from the amounts that we initially recorded, such difference will impact the income tax expense in the period in which such determination is made.

Deferred tax assets relating to certain temporary differences and tax losses are recognised when management considers to be probable that future taxable profit will be available against which the temporary differences or tax losses can be utilised. The outcome of their actual utilisation may be different.

4.5 Fair value of investment properties

The fair value of investment properties is determined by using valuation techniques. Details of the judgement and assumptions have been disclosed in note 7.

4.6 Classification of subsidiary, joint venture and associate

In the normal course of business, the Group develops properties together with other developers or institutions, through entering into co-operation agreements with these parties. The rights and obligations of the Group and the other parties are stipulated by respective co-operation agreements, articles of associations of the project companies, etc. Because of the complexity of the arrangements, significant judgement is needed in determining whether the project company is a subsidiary, joint venture or associate of the Group.

The Group makes judgement based on the substance of the arrangements and the definition of subsidiary, joint venture and associate as disclosed in notes 2.2.1, 2.2.2 and 2.3.1.

4.7 Impairment of financial assets at amortised cost and financial assets at FVOCI

The loss allowances for financial assets are based on assumptions about risk of default and expected loss rates. The Group uses judgement in making these assumptions and selecting the inputs to the impairment calculation, based on the Group's past history, existing market conditions as well as forward looking estimates at the end of each reporting period. Details of the key assumptions and inputs used are disclosed in the tables in note 3.

4.8 Revenue recognition

Determining whether revenue should be recognised at a point in time or over time involves judgment. The Group makes judgements based on the specification in contracts with customers, as well as relevant laws and regulations.

For contracts with variable amount, the Group estimates the amount that is highly probable that significant reversal will not occur for determining transition price.

Details of revenue recognition is disclosed in note 2.2.10.

Management has determined the operating segments based on the reports reviewed by the chief operating decision maker (the "CODM") that are used to make strategic decisions. The board of directors has been identified as the CODM.

The Group manages its business by two operating segments, which is consistent with the way in which information is reported internally to the Group's CODM for the purpose of resources allocation and performance assessment. No operating segments have been aggregated to form the following reportable segments.

- Seazen Holdings Co., Ltd., a company listed on the Shanghai Stock Exchange (the "A share company" or "Seazen Holdings")
- Other service companies not within the A share company (the "Non-A share companies")

The A share company is mainly engaged in development of residential properties and mixed-use complexes for sale and investment, while the Non-A share companies are mainly engaged in services. All the property development projects are in the PRC, and accordingly majority of the revenue of the Group are derived from the PRC and most of the assets are located in the PRC.

The CODM assesses the performance of the operating segments based on a measure of revenue and profit before income tax. The measurement basis excludes the effects of income tax expense.

Variable payment terms are used for a variety of reasons, including minimising the fixed costs base for newly established stores. Variable lease payments that depend on sales are recognised in profit or loss in the period in which the condition that triggers those payments occurs.

A 10% increase in sales across all stores in the Group with such variable lease contracts would increase total lease payments by approximately RMB42,986,000 (2023: RMB23,454,000).

The total cash outflow for leases in 2024 was RMB139,963,000 (2023: RMB131,390,000).

In addition, a deemed profit of 5% to 15% of advances received from the customers is added to the accounting income when calculating taxable income and the prepaid income tax is similarly recorded as prepayments.

For the year ended 31 December 2024, the Group accrued for PRC withholding tax based on the tax rate of 5% on a portion of the earnings generated by its PRC entities. The Group controls the dividend policies of these subsidiaries and it has been determined that it is probable that a majority of these earnings will not be distributed in the foreseeable future.

(f) Land appreciation tax

PRC land appreciation tax is levied at progressive rates ranging from 30% to 60% on the appreciation of land value, being the proceeds from sales of properties less deductible expenditures including lease charges for land use rights and all property development expenditures, and is included in the consolidated statement of profit or loss as income tax expense.

As at 31 December 2024, the Group provided guarantee with the amount of RMB2,752 million (as at 31 December 2023: RMB3,142 million) for its joint ventures and associates to obtain borrowings after assessing the credit history and pledge information of these related parties. The Group closely monitors the repayment progress of the relevant borrowings by these related parties. After considering the credit history of these related parties and the assets being pledged for the borrowings, the directors consider that the likelihood of default in payments is not material.

As of 31 December 2024, the Group provided pledge guarantee for the borrowings of such joint ventures and associates with equity held by the Group (note 40(i)).

(c) Pending litigation

The Group has a number of pending litigations as at 31 December 2024. Among such litigations, a third Person initiated litigation against the Group's subsidiary, Suzhou Future Land Chuangjia Property Co., Ltd ("Suzhou Chuangjia") regarding a share transfer dispute of about RMB1,016 million against Suzhou Chuangjia, in which the third party claimed that the share transfer agreements among Suzhou Chuangjia, five other third parties and another third party company were invalid, and the people's court of second-instance judgment for the transfer agreements was rendered invalid. In December 2021, the aforesaid third party instituted litigation against Suzhou Chuangjia, claiming that the relevant equity interests held by each of the above defendants were registered in the name of the aforesaid third party. In December 2022, the court dismissed the claim of the aforesaid third party. The Group received a civil judgment rendered by a court in June 2023. The aforesaid third party withdrew the claim. In December 2023, the aforesaid third party instituted litigation against Suzhou Chuangjia again, claiming to require Suzhou Chuangjia and another third party company to jointly pay an indemnity of RMB200 million. In December 2024, the Group received the first-instance judgment ordering Suzhou Chuangjia and another third-party company to pay compensation of RMB131 million, and the Group has recognized relevant compensation with proper accounting treatment in accordance with the first-instance judgment. At the same time, the Group has appealed to the Jiangsu Provincial High People's Court in accordance with the law. The final result is still uncertain.
