Where there are joint registered holders of any Shares, any one of such joint holders may attend and vote at 2024 Adjourned AGM or any adjournment thereof (as the case may be), either in person or by proxy, in respect of such Shares as if he/she/it were solely entitled thereto; but if more than one of such joint holders are present at 2024 Adjourned AGM or any adjournment thereof (as the case may be) personally or by proxy, then one of such holders so present whose name stands first in the Register of Members in respect of such Shares will alone be entitled to vote in respect thereof.
- 8. Completion and return of this form of proxy does not preclude a Member from attending in person and voting at 2024 Adjourned AGM or its adjournment (as the case may be) should he/she so wish. In such case, the said form(s) of proxy shall be deemed to be revoked.
- 9. Any alterations made in this or any photocopied form of proxy must be initialled by the person who signs it.
- 10. Pursuant to Rule 13.39(4) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited, voting on all resolution set out in the notice of 2024 Adjourned AGM will be decided by way of a poll at 2024 Adjourned AGM.
- 11. The Company reserves its rights to treat any form of proxy which has been incorrectly completed in some manner as valid if such incorrectness is considered, at the Company's absolute discretion, not material.
- 12. A Member or his/her/its proxy should produce proof of identity when attending 2024 Adjourned AGM. If a corporate Member appoints its representative to attend 2024 Adjourned AGM, such representative should produce proof of identity and a copy of the resolution of the board of directors or other governing body of that Member appointing such representative to attend 2024 Adjourned AGM.

PERSONAL INFORMATION COLLECTION STATEMENT
