### **Amendments to Prospectus and Product Key Facts Statement**

On 23 April 2025, Tracker Fund of Hong Kong (“**TraHK**”) issued (i) the seventh addendum (the “**Seventh Addendum**”) to the prospectus dated 19 September 2022, as amended by the First Addendum dated 1 February 2023, Second Addendum dated 28 April 2023, Third Addendum dated 4 September 2023, Fourth Addendum dated 4 December 2023, Fifth Addendum dated 30 April 2024 and Sixth Addendum dated 23 September 2024 (together, the “**Prospectus**”) in relation to TraHK and (ii) a revised product key facts statement of TraHK (the “**Revised KFS**”).
