### Chairman's Statement

### 董事長報告書

In 2024, although the global economy's recovery path was still full of challenges, technological innovations and the flourishing digital economy presented new opportunities to enterprises. In such a macroeconomic environment with both opportunities and challenges, Chia Tai Enterprises International Limited and its subsidiaries (the "Group") were able to proactively embrace changes and adapt to new situations. Drawing on keen market acumen, courage to take decisive actions and tenacious fighting spirit, the Group achieved impressive business growth in 2024.

在二零二四年,雖然全球經濟的復蘇進程充滿挑戰,但科技創新和數字經濟蓬勃發展,則為企業提供了新的機遇。在這樣機遇與挑戰並存的宏觀格局下,正大企業國際有限公司及其附屬公司(統稱「本集團」)積極擁抱變化適應新形勢,憑藉敏鋭的市場觸覺、果斷的決策魄力以及頑強的拼搏精神,年內業務取得顯著增長。

On the biochemical business front, with farming operations scaling up and animal health business going for high-quality development, scientific innovations and technical services have become crucial growth drivers of the industry. Continuing with its strategic transformation, the Group pushed forward to diversify its animal health product business. In order to ensure relevant businesses have strong commercial potential in future development, we have been stepping up research and development investments, focusing on research and applications of emerging technologies, as well as employing artificial intelligence and related tools to drive key technology upgrades. At the same time, the Group actively explored market channels and strengthened in-depth cooperation with leading companies in the industry, expanding its market share as a result. In addition, the Group actively took part in trade exhibitions at home and abroad to showcase its innovative products and technological advantages. These activities have helped to enhance our brand influence in the market place.

在生化業務方面,隨著養殖持續規模化及動保事業 邁入高質量發展階段,科技創新與技術服務成為行 業增長的重要驅動力。就發展多元化動保化藥產品 業務,本集團繼續積極進行戰略轉型,加大研工 人,專注新興技術領域的研究與應用,利用人工研 長等工具推進關鍵技術升級,以確保相關業務在未 來發展中的商業潛力。同時,透過積極開拓市場 道,以及加強與行業內頭部企業的深度合作,本集 團得以進一步擴大市場份額。另外,本集團積極 與國內外行業展會,通過展示其創新產品和技術優 勢,有效提升了品牌的市場影響力。

During the year, the Group, as always, actively honoured its social responsibility by participating in various social welfare and charitable events, such as sponsoring medical supplies and promoting greening. In terms of human resources, we continued to bring in talent of high calibre and wholeheartedly pressed on with research and development, production, as well as sales undertakings. As the large-size excavator market was affected by the country's slowing down in infrastructure investment and the mining sector's holding back in spending, the performance of our Caterpillar dealership business was less than satisfactory. On the other hand, while facing a complex market environment, our automotive parts business achieved stable overall performance in 2024. This result was achieved by stabilizing its traditional carburetor business and actively pursuing the new energy vehicle subcomponent business.

由於國家放緩投資基礎建設,加上礦產業務亦推遲投入,大型挖機市場受壓,我們的卡特彼勒經銷業務亦連帶受到影響,表現未如理想。另一方面,面對複雜的市場環境,我們的汽車零件業務年內除努力穩定傳統化油器業務外,亦同時積極拓展新能源汽車配套件市場,故整體表現平穩。

Looking forward, we will continue to uphold our "Three Benefits Principle" – benefiting the countries in which we operate, benefiting the people whose community we share and benefiting the enterprises for which we are responsible. We would abide by laws and regulations; we would step up efforts in technological innovation, market expansion and talent grooming; and we would work hard to meet the requirements of high-quality development. These efforts would ensure we are ready to realise our business aspirations for 2025.



### **GROUP RESULTS**

The Group has two lines of business: biochemical business and industrial business. The biochemical business focuses on animal health products and chlortetracycline ("CTC"), and is carried on by Group subsidiaries. This business segment accounts for all of the Group's consolidated revenue. The industrial business comprises the Group's interests in its joint venture ECI Metro Investment Co., Ltd. (together with its subsidiaries, "ECI Metro") and its associate Zhanjiang Deni Vehicle Parts Co., Ltd. (together with its subsidiaries, "Zhanjiang Deni"). The results of the Group's industrial business are incorporated in the consolidated statement of comprehensive income as share of profits and losses of joint venture and associate.

For the year ended 31 December 2024, the Group's revenue increased 76.9% to US\$307.7 million (2023: US\$174.0 million). As mentioned above, the Group's revenue came from its consolidated biochemical business. The significant increase in revenue reflected the successful implementation of a crucial strategy to increase sales to key customers. Overall gross profit margin reduced from 17.3% in 2023 to 15.9% in 2024 mainly due to an increase in animal health product business which has a lower profit margin.

Profit attributable to shareholders of the Company was US\$11.2 million in 2024, an increase of over 3 times as compared to US\$2.6 million in 2023. The increase in profit was again primarily due to stronger performance of the Group's biochemical business. However, share of profits of the Group's industrial business declined due to intense competition.

Basic and diluted earnings per share were both 4.4 US cents (2023: 1.0 US cents). The Board of Directors of the Company resolved not to declare a dividend for the year ended 31 December 2024 (2023: Nil).

### 集團業績

本集團從事生化業務及工業業務。生化業務專注於動保化藥產品及金霉素,並由本集團之附屬公司營運。此業務為本集團所有的綜合收入。工業業務包含本集團於ECI Metro Investment Co., Ltd. (及其附屬公司,統稱「ECI Metro」)的合營企業權益及於湛江德利車輛部件有限公司(及其附屬公司,統稱「湛江德利」)的聯營公司權益。本集團工業業務的業績載列於綜合全面收益表內的應佔合營企業及聯營公司溢利及虧損。

截至二零二四年十二月三十一日止年度,本集團的收入上升76.9%至3億770萬美元(二零二三年:1億7,400萬美元)。如上所述,本集團的收入來自於合併的生化業務。收入的大幅增長反映了關鍵策略-開發大客戶銷售的成功實施。整體毛利率從二零二三年的17.3%下降至二零二四年的15.9%,主要由於較低利潤率的動保化藥產品業務增加所致。

二零二四年本公司股東應佔溢利為1,120萬美元,較 二零二三年的260萬美元上升超過3倍。溢利上升主 要得益於本集團生化業務的強勁表現。然而,本集 團工業業務應佔溢利因劇烈競爭而下降。

每股基本及攤薄溢利為4.4美仙(二零二三年:1.0美仙)。本公司董事會決議不派付截至二零二四年十二月三十一日止年度的股息(二零二三年:無)。

### **BUSINESS REVIEW**

#### **Biochemical**

We generate our revenue primarily from the manufacture and/or sale of animal health products and CTC products. Our animal health products are mainly preventive drugs for livestock diseases. CTC products, on the other hand, are antibiotics, used to prevent or cure animal diseases. In the past few years, we have been strategically broadening our product portfolio to cover related veterinary products. Of these new offerings, some we manufacture and sale, and some we source and trade. The Group's major customers include farms, pharmaceutical companies, trading companies and feed mills.

In 2024, the Group's revenue from the biochemical business increased 76.9% to US\$307.7 million (2023: US\$174.0 million). Our sales mix changed in-line with our strategic business direction. Revenue contribution from animal health products increased from 59% in 2023 to 72% in 2024, while revenue contribution from CTC products decreased from 41% in 2023 to 28% in 2024.

Our animal health products consist of a wide variety of veterinary products. When compared to our CTC products, animal health product, on average, have a lower profit margin. As a result, overall gross profit margin reduced from 17.3% in 2023 to 15.9% in 2024. Nevertheless, due to the substantial increase in business, contribution from our biochemical business grew significantly in 2024.

### Industrial

The Group's industrial business is conducted through ECI Metro and Zhanjiang Deni.

ECI Metro is principally engaged in the sale, leasing and servicing of Caterpillar machinery equipment in western China. According to the China Construction Machinery Association, excavator sales, in unit terms, across the entire market recorded a 11.7% increase in 2024 compared to that in 2023. Although our excavator sales, in unit terms, recorded a 5.3% increase in 2024 compared to that in 2023, our revenue from sales of excavators decreased due to a drop in sales of large-sized excavators and an increase in sales of small-and-medium-sized excavators. As a result, for the year ended 31 December 2024, our share of profit of joint venture reduced from US\$4.8 million in 2023 to US\$0.5 million in 2024.

### 業務回顧

### 生化業務

我們的收入主要來自製造及/或銷售動保化藥產品和金霉素產品。我們的動保化藥產品主要是用作禽畜疾病的防治藥。而金霉素產品為用作預防或治療動物疾病的抗生素。近年,我們一直戰略性地擴大我們的產品系列,以涵蓋相關的獸藥產品。在這些新產品中,一部分我們製造及銷售,一部分我們採購和貿易。本集團的主要客戶包括養殖場、製藥公司、貿易公司及飼料加工廠。

二零二四年,本集團生化業務的收入上升76.9%至3億770萬美元(二零二三年:1億7,400萬美元)。我們的銷售結構隨著我們的戰略業務方向發生變化。動保化藥產品的收入佔比從二零二三年的59%增加至二零二四年的72%,而金霉素產品的收入佔比則從二零二三年的41%下降至二零二四年的28%。

我們的動保化藥產品由廣大種類的獸藥產品組成。 對比我們的金霉素產品,動保化藥產品的平均利潤 率較低。因此,整體毛利率從二零二三年的17.3% 下降至二零二四年的15.9%。儘管如此,得益於業 務的大幅增加,我們的生化業務貢獻在二零二四年 大幅增長。

### 工業業務

本集團的工業業務透過ECI Metro及湛江德利經營。

ECI Metro主要在中國西部從事卡特彼勒機械設備的銷售、租賃及維修服務。據中國工程機械工業協會統計,挖掘機二零二四年總體市場銷量比二零二三年上升11.7%。雖然我們的挖掘機銷量在二零二四年比二零二三年上升5.3%,但由於大型挖掘機銷售減少而中小型挖掘機銷售增加,我們挖掘機銷售收入有所下降。因此,截至二零二四年十二月三十一日止年度,應佔合營企業溢利從二零二三年的480萬美元下降至二零二四年的50萬美元。

#### Industrial (continued)

Zhanjiang Deni is principally engaged in the manufacture and sale of automotive parts, which are mainly sold to automobile and motorcycle manufacturers. According to the China Association of Automobile Manufacturers, China automobile sales in 2024 increased by 4.5% when compared to that in 2023; and according to China Chamber of Commerce for Motorcycle, China motorcycle sales in 2024 was 2.8% higher than that in 2023. For the year ended 31 December 2024, our share of profit of associate remained stable at US\$2.2 million (2023: US\$2.1 million).

### **OUTLOOK**

Looking forward, while the macro environment remains complex, increase in animal disease prevention awareness is expected to drive our biochemical business. Overall, we remain cautiously optimistic for our performance in 2025.

### LIQUIDITY AND FINANCIAL RESOURCES

As at 31 December 2024, the Group had total assets of US\$422.2 million, an increase of 11.9% as compared to US\$377.4 million as at 31 December 2023.

Net debt (31 December 2024: US\$36.8 million, 31 December 2023: US\$40.6 million) to equity ratio (defined as total bank borrowings minus cash divided by total equity) was 0.14 as compared to 0.16 as at 31 December 2023.

All the borrowings of the Group are denominated in Renminbi ("RMB") as at 31 December 2024 and 2023.

As at 31 December 2024, the Group's fixed interest rate bank borrowings amounted to US\$34.3 million (31 December 2023: US\$41.1 million).

All domestic sales in mainland China are transacted in RMB and export sales are transacted in foreign currencies. The Group monitors exchange rate movements and determines appropriate hedging activities when necessary.

### **CAPITAL STRUCTURE**

The Group finances its working capital requirements through a combination of funds generated from operations and borrowings. The Group had cash and cash equivalents of US\$32.4 million as at 31 December 2024, a decrease of US\$5.2 million compared to US\$37.6 million as at 31 December 2023.

#### 工業業務(續)

湛江德利主要從事製造及銷售汽車零件,主要出售 予汽車及摩托車製造商。根據中國汽車工業協會統 計,中國汽車銷量在二零二四年比二零二三年增加 4.5%;而根據中國摩托車商會統計,中國摩托車銷 量在二零二四年則比二零二三年增加2.8%。截至二 零二四年十二月三十一日止年度,應佔聯營公司溢 利保持平穩於220萬美元(二零二三年:210萬美元)。

### 展望

展望未來,雖然宏觀環境仍然複雜,動物疫病防治 意識的增強預計帶動我們的生化業務。總體而言, 我們對二零二五年的表現保持謹慎樂觀態度。

### 資金流動性及財政資源

於二零二四年十二月三十一日,本集團之總資產為4億2,220萬美元,較二零二三年十二月三十一日之3億7,740萬美元,上升11.9%。

淨債務(二零二四年十二月三十一日:3,680萬美元, 二零二三年十二月三十一日:4,060萬美元)對權益 比率(定義為銀行借款減現金後除以權益總額)為 0.14,相對二零二三年十二月三十一日之0.16。

本集團於二零二四年及二零二三年十二月三十一日的借款全部按人民幣作為單位。

於二零二四年十二月三十一日,本集團按固定利率計息之借款為3,430萬美元(二零二三年十二月三十一日:4,110萬美元)。

於中國大陸所有國內銷售均以人民幣計算,而出口 銷售則以外幣計算。本集團監控外滙變動,必要時 考慮適當的對沖活動。

### 資本結構

本集團透過營運資金及借款應付其流動資金需求。 於二零二四年十二月三十一日,本集團持有現金及 現金等價物3,240萬美元(二零二三年十二月三十一 日:3,760萬美元),減少520萬美元。

### **CHARGES ON GROUP ASSETS**

As at 31 December 2024, out of the total borrowings of US\$69.2 million (31 December 2023: US\$78.2 million) obtained by the Group, US\$18.8 million (31 December 2023: US\$21.7 million) was secured, which accounted for 27.1% (31 December 2023: 27.7%) of the total borrowings. Certain of the Group's property, plant and equipment and land lease prepayments with an aggregate net book value of US\$24.0 million (31 December 2023: US\$33.8 million) were pledged as security.

### **CONTINGENT LIABILITIES**

As at 31 December 2024, the Group did not have any significant contingent liabilities.

# SIGNIFICANT INVESTMENTS HELD, MATERIAL ACQUISITIONS AND DISPOSALS

Save for those disclosed in this annual report, there were no other significant investments held nor material acquisitions or disposals during the year.

### **EMPLOYEE AND REMUNERATION POLICIES**

As at 31 December 2024, the Group employed around 900 employees in the PRC and Hong Kong. The Group remunerates its employees based on their performance, experience and prevailing market conditions while performance bonuses are granted on a discretionary basis. Other employee benefits include, for example, medical insurance and training.

The principles of these standards are to uphold a high standard of ethics, transparency, accountability and integrity in all aspects of business and to ensure that affairs are conducted in accordance with applicable laws and regulations.

### CORPORATE GOVERNANCE CODE

The Company applied the principles and complied with the code provisions prescribed in the Corporate Governance Code as set out in Appendix C1 to the Rules Governing the Listing of Securities (the "Listing Rules") on The Stock Exchange of Hong Kong Limited (the "Stock Exchange") throughout the year 2024.

### THE BOARD

#### (a) Board Composition

As at the date of this annual report, the board of directors of the Company (the "Board") comprises ten members, including four executive directors, two non-executive directors and four independent non-executive directors.

The biographical details of the directors of the Company (the "Directors") and the relationships among the Directors are set out in the section headed "Biographical Details of Directors" in this annual report.

### (b) Chairman and Chief Executive

Mr. Soopakij Chearavanont is the Chairman of the Company. Mr. Thirayut Phityaisarakul and Mr. Thanakorn Seriburi are the Chief Executive Officers of the biochemical division and the industrial division, respectively. The roles of the Chairman and the Chief Executive Officers are distinct and separate with a clear division of responsibilities. The Chairman is responsible for overseeing the function of the Board while the Chief Executive Officers are responsible for managing the Group's business.

### (c) Roles and Responsibilities

The Board, directly and through its committees, leads and provides direction for the management by laying down strategies and overseeing their implementation by the management, reviews the operational and financial performance, provides oversight to ensure that a sound system of risk management and internal control is in place and performs corporate governance functions.

The non-executive Directors (including the independent non-executive Directors) provide advisory as well as checks and balances for effective and constructive contribution to the Board to safeguard interests of the shareholders of the Company (the "Shareholders") and the Company as a whole.

The management is responsible for execution of business strategies and dealing with day-to-day operations.

### (d) Independent Non-executive Directors

The Company has received from each of the independent non-executive Directors an annual confirmation of his/her independence in accordance with the independence guidelines set out in Rule 3.13 of the Listing Rules and considers that all independent non-executive Directors are independent.

Ms. Cheung Marn Kay, a newly appointed director on 23 February 2024, obtained the legal advice under Rule 3.09D of the Listing Rules on 2 February 2024 and confirmed she understood her obligations as a director of a listed issuer.

### (e) Directors' Securities Transactions

The Company has adopted the Code of Conduct for Securities Transactions, which is based on the required standard set out in Appendix C3 to the Listing Rules – Model Code for Securities Transactions by Directors of Listed Issuers, as the code of conduct for dealings in the Company's securities by its directors. All Directors responded to a specific enquiry by the Company and confirmed that they complied with the required standard set out in the Code of Conduct for Securities Transactions during 2024.

As at 1 January 2024, the Nomination Committee consisted of a non-executive Director, Mr. Soopakij Chearavanont (Chairman) and two independent non-executive Directors, Mr. Surasak Rounroengrom and Mr. Cheng Yuk Wo. On 23 February 2024, Mr. Soopakij Chearavanont ceased to be the Chairman of the Nomination Committee, Mr. Cheng Yuk Wo ceased to be a member of the Nomination Committee, Mr. Surasak Rounroengrom was appointed as the Chairman of the Nomination Committee and each of Mr. Thirayut Phityaisarakul and Ms. Cheung Marn Kay was appointed as a member of the Nomination Committee. Since then and as at the date of this annual report, the Nomination Committee consists of two independent non-executive Directors, Mr. Surasak Rounroengrom (Chairman) and Ms. Cheung Marn Kay, and an executive Director, Mr. Thirayut Phityaisarakul.

The Nomination Committee is delegated by the Board with the primary responsibilities to formulate and implement the Company's Nomination Policy (the "Nomination Policy") and Board Diversity Policy (the "Board Diversity Policy"), make recommendations to the Board on the selection of any individual nominated for directorship and assess the independence of independent non-executive Directors.

The non-executive Directors are appointed for a successive term of one year. The independent non-executive Directors are appointed for a successive term of three years. All Directors are subject to retirement by rotation, but may offer themselves for re-election at annual general meetings in accordance with the Company's bye-laws. According to the Company's bye-laws, at each annual general meeting of the Company, no less than one-third of the Directors for the time being shall retire from office by rotation, provided that every Director shall be subject to retirement at an annual general meeting at least once every three years.



The Group is principally engaged in the manufacture and/or sale of animal health products and chlortetracycline. Due to the nature of the industry, over 70% of our workforce are male. To encourage more gender diversity in the workforce level, the Company plans to increase the existing percentage of female workforce from 27% to 30% by December 2027.

# RISK MANAGEMENT AND INTERNAL CONTROL

### **Our Approach**

The Group has established and adopted a Risk Management Policy which is designed to manage the risk of failure associated with the Group while achieving its business objectives and to provide reasonable, but not absolute, assurance against material misstatement or loss. A risk appetite statement has been established to define the extent of risks that the Group is willing to take in pursuit of its strategies and business objectives.

Clear roles and responsibilities are assigned to different levels of management within the Group. The Board acknowledges that it is responsible for the Group's risk management and internal control systems. The Board also (i) oversees the design, implementation and monitoring of the risk management and internal control systems; and (ii) evaluates and determines the nature and extent of risks it is willing to take in achieving the Group's business objectives. The Board delegates the responsibility of reviewing the effectiveness of the Group's risk management and internal control systems to the Audit Committee, which monitors the Group's risk management and internal control systems through the Internal Audit Department. The Internal Audit Department carries out independent review of significant risks (including ESG risks), key business processes and controls. Key findings and recommendations for improvement are regularly reported to the Audit Committee. The external auditor also reports any control issues which have been identified in the course of audit or review work to the Audit Committee. Management is responsible for designing, implementing and monitoring risk management and internal control systems, whereas risk owners appointed by the management are responsible for identifying, analysing and prioritising risk issues for further consideration by management and ensuring that the risk monitoring and control system are working effectively and risk mitigation actions are implemented timely within business units.

#### **Effectiveness Review**

In 2024, the Board, through the Audit Committee, conducted an annual review of the effectiveness of the Group's risk management and internal control systems for the reporting period. The Board considers that the risk management and internal control systems of the Group are effective and adequate and the internal audit function is effective and adequate. No significant control failings or weaknesses had been identified in 2024. The Board believes the Company has the ability to adequately respond to changes in its business and the external environment. The Board considers the Company's processes for financial reporting and Listing Rules compliance were effective.

The Board also considers that the Group has adequate resources, staff qualifications and experience, training programmes and budget for accounting, internal audit, financial reporting functions as well as those relating to our environmental, social and governance performance and reporting.

### **Continuous Improvement**

We are committed to improving our risk management and internal control framework and will continue to enhance the integration of risk management and internal control into our business process.

For handling and dissemination of inside information, an Inside Information Handling Policy is in place to enable the Group to handle inside information in accordance with relevant requirements and, where required, communicate with the Group's stakeholders in a timely manner.

### SHAREHOLDERS' RIGHTS

#### Convening a Special General Meeting by Shareholders

In accordance with the Company's bye-laws, the Board may, whenever it thinks fit, convene a special general meeting, and special general meetings shall also be convened on requisition, as provided by the Companies Act 1981 of Bermuda (as the same may from time to time be amended) (the "Companies Act"), and, in default, may be convened by the requisitionists.

Pursuant to the Companies Act, at the date of the deposit of the requisition, members holding not less than one-tenth of the paid-up capital of the Company carrying the right of voting at general meetings of the Company can submit a written requisition to the Board for convening a special general meeting.

The requisition must state the purposes of the meeting, and must be signed by the requisitionists and deposited at the registered office of the Company.

If the Board fails to convene a meeting within twenty-one days from the date of the deposit of the requisition, the requisitionists, or any of them representing more than one half of the total voting rights of all of them, may themselves convene a meeting, but any meeting so convened shall not be held after the expiration of three months from the date of the deposit of the written requisition.

Such meeting convened by the requisitionists shall be convened in the same manner as that in which meetings are to be convened by the Board. At least fourteen clear days' notice in writing (and not less than ten business days) shall be given to all members of the Company.

### To Make Enquiry to the Board

The Shareholders can make enquiry to the Board by writing to the Company's principal place of business in Hong Kong.

### To Put Forward Proposals at General Meetings

Pursuant to the Companies Act, any number of members of the Company representing not less than one-twentieth of the total voting rights of all the members having at the date of the requisition a right to vote at the meeting to which the requisition relates, or not less than one hundred members, can submit a written requisition to the Board for putting forward proposals at general meetings.

The requisition must state the resolution with a statement of not more than one thousand words with respect to the matter referred to in the proposed resolution or state the business to be dealt with at that meeting, and the requisition must be signed by the requisitionists.

The requisition must be deposited at the registered office of the Company no less than six weeks before the meeting in the case of the requisition requiring notice of a resolution or no less than one week before the meeting in case of any other requisition. The requisitionists must deposit a sum of money reasonably sufficient to meet the Company's expenses in serving the notice of the resolution and circulating the statement to all members of the Company.

#### To Propose a Person for Election as a Director

Members of the Company (other than the person to be proposed) who are qualified to attend and vote at general meetings of the Company can submit a written requisition to the Board to propose a person for election as a director of the Company at a general meeting.

The requisition must be signed by the requisitionists and deposited, with a notice signed by the nominated candidate of his/her willingness to be elected and the candidate's information required to be disclosed under Rule 13.51(2) of the Listing Rules and a written consent from the nominated candidate to the publication of his/her personal data, at the Company's principal place of business in Hong Kong no earlier than the day after the despatch of the notice of the general meeting at which the candidate is proposed for election and ending no later than seven days prior to the date of such general meeting.

# Volatility of Commodity Prices

The availability and prices of the necessary raw materials of animal health products and CTC may be adversely affected by factors beyond the Group's control, such as weather conditions, natural disasters or a sudden surge in demand.

If the supply of raw materials is disrupted to a material degree or if there is a substantial increase in the prices of raw materials, and the Group is not able to purchase the same raw materials of the same quality from alternative suppliers at competitive prices or to transfer such material price increase to customers, the Group's financial condition and operating results may be materially and adversely affected. Management will set a safety stock level and continuously collect and analyse the commodity prices information when purchasing these raw materials.

### Licenses and Permits

In accordance with applicable PRC laws and regulations, the Group is required to obtain and maintain various licences and permits in order to commence and operate our business. In addition, in order to export and sell products overseas, the Group needs to obtain various government approvals and comply with applicable standards in relation to production processes, premises and its products in the countries where the Group sells.

Although the Group currently has the necessary licences and permits, the eligibility criteria for such licences and permits may change from time to time and may become more stringent. In addition, new requirements for the grant or renewal of such licences and permits may come into effect in the future. The introduction of any such new and/or more stringent laws or regulations may significantly escalate the compliance and maintenance costs or may limit or even prohibit the Group to continue its existing operations or expand its business. Management continuously keeps abreast of regulatory changes in the relevant laws and regulations on licenses and permits.

### **Product Liability**

If the Group's products fail to perform as expected, or prove to be defective or result in accidents, personal injuries, casualties or financial losses to customers, the Group may be subject to liability claims for damages. If products do not meet the specifications and requirements requested by customers, or if any of the Group's products are defective, such defects or any complaints or negative publicity resulting therefrom could result in decreased sales of the Group's products, and the Group may also be subject to product liability claims and litigation. The Group's internal quality control team oversees quality assurance controls and systems throughout the production process.

### Disease Outbreak

Any animal disease outbreak, such as bird flu and African swine fever, may cause widespread animal death, and hence would affect demand for our products and results of the Group. Further, any human disease outbreak, such as COVID-19, may also disrupt the Group's business, including delay in raw material supply, workforce availability due to people movement restrictions and outbound logistical delays in our delivery of products to customers. The Group will monitor the situation and adopt appropriate measures to minimize the impact on the Group's business and operation.

### **Environmental Compliance**

Our CTC production is required to comply with applicable environmental protection laws and regulations in the PRC which govern the standards of air pollution, waste water discharge and noise emissions. Local PRC government and authorities generally have the authority delegated by relevant laws and regulations to impose penalties on companies failing to comply with the relevant environmental protection laws and regulations.

In addition to the existing environmental protection laws and regulations, the PRC government may promulgate new and stricter environmental protection laws and regulations in the biochemical industry in the future which may apply to the Group. As a result, compliance with such legal requirements will become more burdensome and we may incur additional costs in production process and operations, which may ultimately adversely affect production and results of operations. The Safety, Health and Environmental Committee of the Group oversees relevant environmental policies affecting the Group's operations.

## Occupational health and safety

The Group aims to provide a safe working environment for its personnel. Measures taken include risk assessments and the development of systems and procedures for monitoring, prevention and control of potential hazards. However, workplace accidents can still occur due to various factors such as human error, lack of knowledge or understanding, non-compliance, unclear work guidelines or malfunction of machinery or equipment. These incidents can result in injuries, illnesses or even fatalities among employees.

The Group strives to comply in all material aspects with the relevant laws and regulations which are regarded as having a significant impact on the Group, and has not come across incidence of material breach or non-compliance during 2024.

### **Employees**

We highly value our talents and are committed to providing a safe work environment to our employees. The Group remunerates its employees based on their performance, experience and prevailing market rates while performance bonuses are granted on a discretionary basis. Other employee benefits include, for example, medical insurance and training. We also ensure our recruitment policies are in compliance with national regulations in the areas of equal opportunity and anti-discrimination.

We have in place safety guidelines and operating manuals setting out safety measures for the production processes. In accordance with applicable laws and regulations in the PRC, we provide our employees with training programs on work safety including trainings on safe usage of chemicals and machineries, accident prevention and management. We also conduct regular inspections on our machineries to ensure compliance with safety standards.

### Suppliers

The quality of incoming materials is ensured under a well-established control process in our production plants. We carefully choose suppliers that share the same commitment to product quality and work ethics with us. # **Master ITOCHU Supply Agreement**

On 13 September 2023, the Company entered into an agreement (the "Master ITOCHU Supply Agreement") with ITOCHU Corporation ("ITOCHU") for the purchase of various additives and other related biochemical products required by the Group in the manufacture and/or sale of chlortetracycline and other related products by the Group from ITOCHU and its subsidiaries from time to time.

The Master ITOCHU Supply Agreement took effect on 13 September 2023 and would continue until 31 December 2025.

As at 13 September 2023, being the date of the Company's announcement, ITOCHU was interested in approximately 25% of the shares of the Company in issue and was a substantial shareholder of the Company. Accordingly, the transactions contemplated under the Master ITOCHU Supply Agreement constituted continuing connected transactions of the Company under the Listing Rules and were subject to the reporting and announcement requirements but were exempted from the circular (including independent financial advice) and the independent shareholders' approval requirements under Chapter 14A of the Listing Rules.

For the year ended 31 December 2024, the annual cap for the transactions contemplated under the Master ITOCHU Supply Agreement was US\$1,400,000 and the actual purchases recorded amounted to US\$335,000.

### 2023 Master HOEL Purchase Agreement

On 14 September 2023, the Company entered into a master purchase agreement (the "2023 Master HOEL Purchase Agreement") with HOEL for the sale and supply of various chlortetracycline products, animal drugs, animal health products and other related products produced and/or sold by the Group to HOEL and other associates of CPG (including the CPP Group, but excluding the Group). The 2023 Master HOEL Purchase Agreement took effect on 1 January 2024 and would continue until 31 December 2026. The 2023 Master HOEL Purchase Agreement and the annual caps were approved by the independent shareholders of the Company on 16 November 2023.

Due to CPG's near majority shareholding in CPF, the Company and CPG have agreed to treat CPG as a substantial shareholder of the Company and its subsidiaries (including HOEL which is its indirect wholly-owned subsidiary) and their respective associates as connected persons of the Company within the meaning of the Listing Rules. Therefore, transactions under the 2023 Master HOEL Purchase Agreement were treated as if they were continuing connected transactions of the Company under Chapter 14A of the Listing Rules.

For the year ended 31 December 2024, the annual cap for the transactions contemplated under the 2023 Master HOEL Purchase Agreement was US\$162,900,000 and the actual purchases recorded amounted to US\$160,254,000.

# **Listing Rules Compliance**

The Internal Audit Department has reviewed the above continuing connected transactions and had no material findings of non-compliance to report to the independent non-executive Directors.

The independent non-executive Directors have also reviewed the Group's continuing connected transactions and have confirmed that these continuing connected transactions were entered into (i) in the ordinary and usual course of business of the Group; (ii) on normal commercial terms or better; and (iii) in accordance with the relevant agreements governing them on terms that are fair and reasonable and in the interests of the Shareholders as a whole.

In respect of the above continuing connected transactions, the Company has complied with the relevant announcement, circular and shareholders' approval requirements under Chapter 14A of the Listing Rules from time to time.

# **Opinion**

We have audited the consolidated financial statements of Chia Tai Enterprises International Limited (the "Company") and its subsidiaries (together the "Group") set out on pages 66 to 150, which comprise the consolidated statement of financial position as at 31 December 2024, the consolidated statement of comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended and notes to the consolidated financial statements, including a summary of material accounting policies.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2024 and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with International Financial Reporting Standards ("IFRSs") issued by the International Accounting Standards Board ("IASB") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

# Revenue recognition

### The key audit matter

The Group's revenue is mainly derived from the sale of biochemical products. The Group generally recognises revenue when products are delivered to the customer's premises for domestic sales or in accordance with the terms and conditions of sale for export sales.

The terms set out in the Group's sales contracts relating to goods acceptance by customers are varied. Accordingly, the terms and conditions of sales contracts may affect the timing of recognition of sales to customers as each sales contract could have different terms relating to customer acceptance of the goods sold.

We identified the recognition of revenue as a key audit matter because revenue is one of the key performance indicators of the Group and is, therefore, subject to an inherent risk of manipulation by management to meet targets or expectations.

# How the matter was addressed in our audit

Our audit procedures to assess the recognition of revenue included the following:

- evaluating the design, implementation and operating effectiveness of key internal controls over the existence, accuracy and timing of revenue recognition;
- challenging the revenue recognition policies adopted by the Group by making inquiries of management and inspecting a sample of sales contracts to understand the delivery terms of the transactions and to assess the Group's timing of revenue recognition with reference to the requirements of the prevailing accounting standards;
- inspecting manual adjustments to revenue raised during the reporting period which met specific risk-based criteria, enquiring of management the reasons for such adjustments and comparing the details of the adjustments with relevant underlying documentation;
- assessing whether revenue had been recognised in the appropriate accounting period by comparing a sample of sales transactions around the year end with relevant underlying documents, which included customers' signed acknowledgement of receipt (for domestic sales) and bills of lading (for export sales); and
- identifying significant sales returns from the sales ledger after the year end and inspecting the underlying documentation to assess if the related adjustments to revenue had been accounted for in the appropriate accounting period.

#### 1 GENERAL INFORMATION

Chia Tai Enterprises International Limited (the "Company") is a limited liability company incorporated in Bermuda. The Company and its subsidiaries hereinafter are collectively referred to as the "Group". The Group and its joint venture and associate are principally involved in (i) manufacturing and/or sale of animal health products and chlortetracycline; (ii) trading of machinery; and (iii) manufacturing and sale of automotive parts respectively.

At 31 December 2024, the directors consider the immediate holding company of the Company to be Charoen Pokphand Foods Public Company Limited ("CPF"), which is incorporated in the Kingdom of Thailand and shares of which are listed on the Stock Exchange of Thailand, and remains to be as such as at the date of approval of these financial statements. CPF is a significantly owned company of Charoen Pokphand Group Company Limited ("CPG"), which is incorporated in the Kingdom of Thailand.

### 2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with International Financial Reporting Standards ("IFRSs") (which include all International Financial Reporting Standards, International Accounting Standards ("IASs") and interpretations) issued by the International Accounting Standards Board ("IASB") and the disclosure requirements of the Hong Kong Companies Ordinance. These financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules"). The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies.

#### **Basis of measurement**

These financial statements are presented in United States dollars ("US\$"), and all values are rounded to the nearest thousand ("US\$'000") except when otherwise indicated. The functional currency of the Company is United States dollars.

## 1 一般資料

#### Use of estimates and judgements

The preparation of these financial statements in conformity with IFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgements made by management in the application of IFRSs that have significant effect on these financial statements and major sources of estimation uncertainty are discussed in note 3.

## 2.4 SUMMARY OF MATERIAL ACCOUNTING 2.4 重大會計政策概要 POLICIES

#### (a) Subsidiaries and non-controlling interests

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power, only substantive rights (held by the Group and other parties) are considered.

An investment in a subsidiary is consolidated into these financial statements from the date that control commences until the date that control ceases. Intra-group balances, transactions and cash flows and any unrealised profits arising from intra-group transactions are eliminated in full in preparing these financial statements. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains but only to the extent that there is no evidence of impairment.

Non-controlling interests represent the equity in a subsidiary not attributable directly or indirectly to the Company, and in respect of which the Group has not agreed any additional terms with the holders of those interests which would result in the Group as a whole having a contractual obligation in respect of those interests that meets the definition of a financial liability. For each business combination, the Group can elect to measure any non-controlling interests either at fair value or at the non-controlling interests' proportionate share of the subsidiary's net identifiable assets.

## (a) 附屬公司及非控制性權益

Non-controlling interests are presented in the consolidated statement of financial position within equity, separately from equity attributable to the equity shareholders of the Company. Non-controlling interests in the results of the Group are presented on the face of the consolidated statement of comprehensive income as an allocation of the total profit or loss and total comprehensive income for the year between non-controlling interests and the equity shareholders of the Company. Loans from holders of non-controlling interests and other contractual obligations towards these holders are presented as financial liabilities in the consolidated statement of financial position in accordance with notes 2.4(h) or (i) depending on the nature of the liability.

Changes in the Group's interests in a subsidiary that do not result in a loss of control are accounted for as equity transactions, whereby adjustments are made to the amounts of controlling and non-controlling interests within consolidated equity to reflect the change in relative interests, but no adjustments are made to goodwill and no gain or loss is recognised.

When the Group loses control of a subsidiary, it is accounted for as a disposal of the entire interest in that subsidiary, with a resulting gain or loss being recognised in profit or loss. Any interest retained in that former subsidiary at the date when control is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset or, when appropriate, the cost on initial recognition of an investment in an associate or joint venture (see note 2.4(b)).

In the Company's statement of financial position, an investment in a subsidiary is stated at cost less impairment losses (see note 2.4(e)(ii)).

#### (b) Associate and joint venture

An associate is an entity in which the Group or Company has significant influence, but not control or joint control, over its management, including participation in the financial and operating policy decisions. Significant influence is presumed to exist when the Group holds between 20% and 50% of the voting power of another entity.

A joint venture is an arrangement whereby the Group or Company has joint control, established by contracts requiring unanimoius consent for decisions about the activities that significantly affect the arrangements' returns.

An investment in an associate or a joint venture is accounted for in these financial statements under the equity method, unless it is classified as held for sale (or included in a disposal group that is classified as held for sale). Under the equity method, the investment is initially recorded at cost, adjusted for any excess of the Group's share of the acquisition-date fair values of the investee's identifiable net assets over the cost of the investment (if any). Thereafter, the investment is adjusted for the post acquisition change in the Group's share of the investee's net assets and any impairment loss relating to the investment (see note 2.4(e)(ii)). At each reporting date, the Group assesses whether there is any objective evidence that the investment is impaired. Any acquisition-date excess over cost, the Group's share of the post-acquisition, post-tax results of the investees and any impairment losses for the year are recognised in profit or loss, whereas the Group's share of the post-acquisition post-tax items of the investees' other comprehensive income is recognised as other comprehensive income.

When the Group's share of losses exceeds its interest in the associate or the joint venture, the Group's interest is reduced to nil and recognition of further losses is discontinued except to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the investee. For this purpose, the Group's interest is the carrying amount of the investment under the equity method together with the Group's long-term interests that in substance form part of the Group's net investment in the associate or the joint venture.

Unrealised profits and losses resulting from transactions between the Group and its associate and joint venture are eliminated to the extent of the Group's interest in the investee, except where unrealised losses provide evidence of an impairment of the asset transferred, in which case they are recognised immediately in profit or loss.

If an investment in an associate becomes an investment in a joint venture or vice versa, retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method.

In all other cases, when the Group ceases to have significant influence over an associate or joint control over a joint venture, it is accounted for as a disposal of the entire interest in that investee, with a resulting gain or loss being recognised in profit or loss. Any interest retained in that former investee at the date when significant influence or joint control is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset.

Items of property, plant and equipment, other than construction in progress, are stated at cost less accumulated depreciation and impairment losses (see note 2.4(e)(ii)):

- buildings held for own use which are situated on (i) leasehold land; and
- (ii) other items of plant and equipment.

The cost of self-constructed items of property, plant and equipment includes the cost of materials, direct labour, the initial estimate, where relevant, of the costs of dismantling and removing the items and restoring the site on which they are located, and an appropriate proportion of production overheads and borrowing costs (see note 2.4(p)).

Items may be produced while bringing an item of property, plant and equipment to the location and condition necessary for it to be capable of operating in the manner intended by management. The proceeds from selling any such items and the related costs are recognised in profit or loss.

Gains or losses arising from the retirement or disposal of an item of property, plant and equipment are determined as the difference between the net disposal proceeds and the carrying amount of the item and are recognised in profit or loss on the date of retirement or disposal.

#### Construction in progress

Construction in progress represents the silos, factories and warehouses under construction. Construction in progress is stated at cost less any accumulated impairment losses, and is not depreciated. Cost comprises the direct costs of construction and capitalised borrowing costs on related borrowed funds during the period of construction. Construction in progress is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

#### As a lessee

Where the contract contains lease components and non-lease components, the Group has elected not to separate non-lease components and accounts for each lease component and any associated non-lease components as a single lease component for all leases.

At the lease commencement date, the Group recognises a right-of-use asset and a lease liability, except for short-term leases that have a lease term of 12 months or less and leases of low-value assets. When the Group enters into a lease in respect of a low-value asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. The lease payments associated with those leases which are not capitalised are recognised as an expense on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to profit or loss in the accounting period in which they are incurred.

The Group recognises a loss allowance for expected credit losses ("ECLs") on financial assets measured at amortised cost (including cash and cash equivalents and trade and other receivables).

#### Measurement of ECLs

ECLs are a probability-weighted estimate of credit losses. Credit losses are measured as the present value of all expected cash shortfalls (i.e. the difference between the cash flows due to the Group in accordance with the contract and the cash flows that the Group expects to receive).

The expected cash shortfalls are discounted using the following discount rates where the effect of discounting is material:

- fixed-rate financial assets, trade and other receivables: effective interest rate determined at initial recognition or an approximation thereof; and

Loss allowances for trade receivables are always measured at an amount equal to lifetime ECLs. ECLs on these financial assets are estimated using a provision matrix based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors and an assessment of both the current and forecast general economic conditions at the reporting date.

For all other financial instruments, the Group recognises a loss allowance equal to 12-month ECLs unless there has been a significant increase in credit risk of the financial instrument since initial recognition, in which case the loss allowance is measured at an amount equal to lifetime ECLs.

#### Significant increases in credit risk

In assessing whether the credit risk of a financial instrument has increased significantly since initial recognition, the Group compares the risk of default occurring on the financial instrument assessed at the reporting date with that assessed at the date of initial recognition. In making this reassessment, the Group considers that a default event occurs when the debtor is unlikely to pay its credit obligations to the Group in full, without recourse by the Group to actions such as realising security (if any is held). In particular, the following information is taken into account when assessing whether credit risk has increased significantly since initial recognition:

- failure to make payments of principal or interest on their contractually due dates;

Inventories are carried at the lower of cost and net realisable value.

Cost is calculated using the weighted average cost formula and comprises all costs of purchase, costs of conversion and other costs incurred in bringing the inventories to their present location and condition.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

When inventories are sold, the carrying amount of those inventories is recognised as an expense in the period in which the related revenue is recognised. The amount of any write-down of inventories to net realisable value and all losses of inventories are recognised as an expense in the period the write-down or loss occurs. The amount of any reversal of any write-down of inventories is recognised as a reduction in the amount of inventories recognised as an expense in the period in which the reversal occurs.

#### (g) Trade and other receivables

Trade and other receivables are initially recognised at fair value and thereafter stated at amortised cost using the effective interest method, less allowance for credit losses (see note 2.4(e)), except where the receivables are interest-free loans made to related parties without any fixed repayment terms or the effect of discounting would be immaterial. In such cases, the receivables are stated at cost less allowance for credit losses.

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Bank overdrafts that are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents for the purpose of the consolidated statement of cash flows.

Salaries, annual bonuses, paid annual leave and the cost of non-monetary benefits are accrued in the year in which the associated services are rendered by employees. Where payment or settlement is deferred and the effect would be material, these amounts are stated at their present values.

Certain provinces, autonomous regions or municipalities are overburdened by the pension insurance due to higher number of retired people, it is required to make specific contributions at rates higher than 16% (before 1 May 2019: 20%) (the percentage to be determined by each of the government of the provinces, autonomous regions or municipalities) of the total salaries of the employees upon approval of the ministry of labour and the ministry of finance. The PRC government is responsible for the pension liability to the retired employees. The employees of the subsidiaries are entitled to a monthly pension at their retirement dates. The subsidiaries have no further obligation for post-retirement benefits beyond the annual contributions.

Apart from certain limited exceptions, all deferred tax liabilities, and all deferred tax assets to the extent that it is probable that future taxable profits will be available against which the asset can be utilised, are recognised. Future taxable profits that may support the recognition of deferred tax assets arising from deductible temporary differences include those that will arise from the reversal of existing taxable temporary differences, provided those differences relate to the same taxation authority and the same taxable entity, and are expected to reverse either in the same period as the expected reversal of the deductible temporary difference or in periods into which a tax loss arising from the deferred tax asset can be carried back or forward. The same criteria are adopted when determining whether existing taxable temporary differences support the recognition of deferred tax assets arising from unused tax losses and credits, that is, those differences are taken into account if they relate to the same taxation authority and the same taxable entity, and are expected to reverse in a period, or periods, in which the tax loss or credit can be utilised.

### (i) Sale of goods

Revenue is recognised when the customer takes possession of and accepts the products. Sales returns are allowed only when the products are damaged or defective. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, applying the practical expedient in paragraph 63 of IFRS 15. If the products are a partial fulfilment of a contract covering other goods and/or services, then the amount of revenue recognised is an appropriate proportion of the total transaction price under the contract, allocated between all the goods and services promised under the contract on a relative stand-alone selling price basis. Foreign currency transactions during the year are translated at the foreign exchange rates ruling at the transaction dates. Monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at the end of the reporting period. Exchange gains and losses are recognised in profit or loss, except those arising from foreign currency borrowings used to hedge a net investment in a foreign operation which are recognised in other comprehensive income.

## 3 SIGNIFICANT ACCOUNTING JUDGEMENTS AND ESTIMATES

In the process of applying the Group's accounting policies, management has made the following accounting judgments and estimates:

#### (a) Impairment of property, plant and equipment

As explained in note 2.4(e)(ii), the impairment loss for property, plant and equipment is recognised for the amount by which the carrying amount exceeds its recoverable amount when events or changes in circumstance indicate the carrying amounts may not be recoverable. The recoverable amount of the assets, or, where appropriate, the cash generating unit to which they belong, is the higher of its fair value less costs of disposal and value in use. The recoverable amounts are determined based on fair value less costs of disposal which are based on the best information available to reflect the amount obtainable at the reporting date, from the disposal of the asset in an arm's length transaction between knowledgeable and willing parties, after deducting the costs of disposal. For the estimation of value in use, the Group's management estimates future cash flows from the cash-generating units and chooses a suitable discount rate in order to calculate the present value of those cash flows.

#### (b) Impairment of interest in joint ventures

Management reviews the carrying amounts of the investments in joint ventures at the end of each reporting period to determine whether there is objective evidence of impairment. When indication of impairment is identified, management assesses the differences between the carrying amounts and recoverable amounts and makes provision for impairment loss. Any change in the assumptions adopted in calculating the recoverable amount would increase or decrease the provision for impairment loss and affect the Group's share of profit or loss of joint ventures and interest in joint ventures in future years.

For management purposes, the Group is organised into business units based on their products and services and has two reportable operating segments:

- the biochemical segment is principally engaged in the manufacture and/or sale of animal health products and chlortetracycline; and
- the industrial segment is principally engaged in the trading of machinery and the manufacture and sale of automotive parts, through the Group's joint venture and associate.

Management monitors the results of the Group's operating segments separately for the purpose of making decisions about resource allocation and performance assessment. Segment performance is evaluated based on reportable segment profit, which is a measure of adjusted profit before tax. The adjusted profit before tax is measured consistently with the Group's profit before tax except that bank interest income, finance costs and items not specifically attributed to individual segments, such as head office or corporate administration expenses are excluded from such measurements.

Segment assets exclude unallocated corporate assets. Unallocated corporate assets include cash and cash equivalents, income tax receivable and other assets that are managed on a group basis.

Segment liabilities exclude unallocated corporate liabilities. Unallocated corporate liabilities include bank borrowings, income tax payables, deferred tax liabilities and other liabilities that are managed on a group basis.

All revenue from contracts with customers is recognised at the point in time when our customer obtains control of the promised goods, i.e. when products are delivered to the customers' premises for domestic sales or in accordance with the terms and conditions of sale for export sales. The major product line of the Group is the manufacture and/or sale of animal health products and chlortetracycline in the biochemical segment as disclosed in note 4(a).

Disaggregation of revenue from contracts with customers by geographical location of customers is disclosed in note 4(b)(i).

# The Group is within the scope of the Pillar Two model rules published by the OECD. Under the rules, the Group is liable to pay a top-up tax for the difference between their Global Anti-Base Erosion (GloBE) effective tax rate per jurisdiction and the 15 per cent minimum rate. Of the various jurisdictions where the Group operates, Pillar Two legislation has not yet been substantially enacted in Hong Kong and the Mainland China at 31 December 2024. However, it is expected that Pillar Two legislation will be enacted in Hong Kong during the financial year 2025 with effective date set retrospectively from the financial year beginning on or after 1 January 2025. The top-up tax for the Group's Hong Kong companies is expected to be negligible in 2025 as there will be no taxable income to be incurred by these entities during the financial year 2025.

The Group performs ongoing credit evaluations of its customers' financial conditions for its trade and bills receivables. Appropriate allowances for estimated irrecoverable amounts are recognised in profit or loss when there is objective evidence that the asset is impaired. The allowance recognised is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows discounted at the effective interest rate computed at initial recognition.

The Group measures loss allowances for trade receivables at an amount equal to lifetime ECLs, which, except for amounts due from customers with known financial difficulties or significant doubt on collection that are assessed individually, is calculated using a provision matrix. Accordingly, the Group recognised credit loss allowance of US\$71,000 for several customers with significant doubt on collection that is individually impaired for the year ended 31 December 2024 (2023: US\$54,000). As the Group's historical credit loss experience does not indicate significantly different loss patterns for different customer segments, the loss allowance based on past due status is not further distinguished between the Group's different customer bases. The Group assessed that there is no significant loss allowance recognised in accordance with IFRS 9 as at 31 December 2024 and 2023 and no ECL rate has therefore been disclosed.

The Group considered that the entire trade receivable balances have the same credit risk exposure. The expected loss rates are based on actual loss experience over the past five years. These rates are adjusted to reflect differences between economic conditions during the period over which the historical data has been collected, current conditions and the Group's view of economic conditions over the expected lives of the receivables.

RMB is not freely convertible into foreign currencies. All foreign exchange transactions are conducted with reference to the exchange rates quoted by the People's Bank of China. Payments for imported materials and remittance of earnings out of mainland China are subject to the availability of foreign currencies.

Export sales of the Group are conducted primarily in US\$. For certain subsidiaries, joint venture and associate, funds denominated in RMB may have to be, and from time to time are, converted into US\$ or other foreign currencies for the purchase of imported materials and equipment.
