During the financial year ("FY") of 2024, the Group faced strong challenges of continuous geopolitical tensions and rising interest rates that resulted in inflationary pressures and lower sales demand worldwide. To alleviate the impact of these uncertainties, the Group opted to exercise financial prudence to lower safety stock to an optimal level, and to optimize fixed costs usage by investing in new machineries prudently for confirmed new business, and adopting efficient cost cutting measures to cope with significant sudden drop in sales demand worldwide in the home environmental product category as consumers in China, Japan and Korea, facing higher unemployment rate and weakened domestic currencies during 2024, spent less money on health related consumer products. Nevertheless, the Group managed to tackle each challenge and launched more new innovative products during 2024 in the grooming product categories that helped consumers to look smart when they went out to work and socialize.

Despite launching new grooming products in niche markets, for FY2024, the Group's consolidated turnover decreased to HK\$1,075,732,000, representing a decrease of approximately 21.06% as compared with the same period in the previous year. Net profit of the Group was HK\$45,219,000, representing a decrease of approximately 33.38%, as compared with the net profit of HK\$67,871,000 for the same period in FY2023; and representing basic earnings per share of 9.02 Hong Kong cents (net profit in FY2023 was HK\$67,871,000, with basic earnings per share of 13.54 Hong Kong cents). The decrease in net profit was attributable to the fact that despite the Group's business had better gross margins for new products and better control of expenses, significant decrease in sales revenue in FY2024 inevitably increased per unit fixed costs that caused net profit to go down.

本人欣然提呈利民實業有限公司及其附屬公司(統稱「本集 團」)截至2024年12月31日止年度之年度業績。

在2024財政年度,本集團面臨持續的地緣政治緊張局勢 和利率上升的嚴峻挑戰,導致全球通膨壓力和銷售需求下 降。為了減輕該等不明朗因素的影響,本集團選擇實施審 慎的財政策將安全庫存降至最優水平,同時通過以下措施 優化固定成本的使用:一方面為已確定的新業務審慎投資 新機器,一方面採取有效的成本削減措施以應對因為中 國、日本和韓國的消費者在2024年面對高失業率及其本國 的貨幣疲弱,而減少在健康相關消費品上的支出。然而, 於2024財政年度,本集團成功應對了每一個挑戰,並在儀 容護理產品類別中推出更多創新產品,讓消費者在外出工 作及社交時更亮麗。

儘管於細分市場成功推出新儀容護理產品,本集團於2024 財政年度的綜合營業額減少至港幣1,075,732,000元,較去 年同期的綜合營業額減少約21.06%。本集團的淨溢利為港 幣45,219,000元,較2023年財政年度同期的淨溢利港幣 67,871,000元減少約33.38%;每股基本盈利港幣9.02仙 (2023財政年度淨溢利為港幣67,871,000元,每股基本盈 利港幣13.54仙)。儘管本集團的新產品有較佳的邊際利潤 及更好地控制支出,淨溢利減少仍因於2024財政年度銷售 額大幅下降,無可避免地使每單位的固定成本增加。

Chairman's Statement 主席報告

Cash generated from operations was HK\$77,239,000 in FY2024. Net cash and cash equivalents at the end of FY2024 was HK\$349,130,000 (of which HK\$70,158,000 was dividend paid out during FY2024) as compared with HK\$367,415,000 at the beginning of FY2024. The positive operating cash flow and substantial cash balances enable the Group to continue paying dividends to the shareholders. At the same time, the Group continues to invest excess cash in research and development ("**R&D**"), new technology and automation equipment. Consequently, the Group continues to qualify as a High and New Technology Enterprise ("**HNTE**") in The People's Republic of China (the "**PRC**").

In FY2024, the Group invested HK\$37,931,000 (compared with HK\$40,505,000 in FY2023) to purchase new injection moulding machines, procure more high precision laboratory testing equipment to upgrade our R&D and operational capabilities, build new toolings for new products, hire consultants to work on finance digital transformation to enhance faster data processing and analysis, and to realize a paperless finance operation. Part of the above-mentioned capital expenditure was related to new R&D projects to fulfill the HNTE minimum annual investment requirement; and we expect the investment in these R&D projects will improve our operational efficiency, enabling the Group's management to make better predictions and business decisions, and hopefully can generate more sales revenue in the near future from launch of new products. Qualifying for the HNTE status would enable the Group to continue to enjoy lower profit tax rate and to receive tax incentives from the PRC Government; and increase our competitiveness among our peers.

於2024財政年度,經營產生之現金為港幣77,239,000 元。於2024財政年度末之現金及現金等值項目淨額為港 幣349,130,000元(於2024財政年度已派發股息為港幣 70,158,000元),而2024財政年度初現金及現金等值項目 淨額為港幣367,415,000元。正營運現金流量及充足的現金 結餘使本集團可以繼續向股東派發股息。同時,本集團繼 續將過剩現金投入研發(「研發」)、新技術及自動化設備。 因此,本集團繼續在中國獲認證為高新技術企業(「高新技 術企業」)的資格。

於2024財政年度,本集團投資了港幣37,931,000元(2023 財政年度為港幣40,505,000元)購買新的注塑造型機和採購 精準度更高的實驗室測試設備,以提升我們的研發及營運 能力,為新產品建造新模具,聘請顧問為進財務進行數碼 化轉型,以加快數據處理和分析及實現無紙化財務運作。 以上部分資本支出與新的研發項目有關,是為了滿足高新 技術企業最低年度投資要求。本集團期望該等研發項目的 投資將提高我們的營運效率,使本集團管理層能作出更好 的預測和業務決策,並有望在不久將來憑藉推出新產品帶 來更多銷售收入。符合高新技術企業的資格將使本集團享 有較低的利得税率,並獲得中國政府的税收優惠,以提升 我們在行業的競爭力。

To achieve AIoT (Artificial Intelligence and Internet of Things) compatibility, the Group continued to invest in the information systems and automated production processes to convert the operations to a MES system that analyze manufacturing data real time and management can observe the important information such as manufacturing process bottleneck and equipment failure to take immediate action to remedy the situation. Our MES system can also utilize big data and mobile surveillance data to improve quality systems. With more digital transformation tools available, the Group's management can update strategies and react to changes quickly in this highly competitive global markets. The Group successfully obtained ISO27001 certification last year, certifying that the Group's information technology ("IT") system has adopted satisfactory cybersecurity measures to protect data privacy and the Group has passed the ISO 27001 audit again in FY2024. Furthermore, the Group's enterprise resource planning ("ERP") and IT system can achieve safe and secure data management, and safeguard important digital and intangible assets to give our stakeholders confidence in our ability to protect our data integrity.

The Group experienced serious flooding inside our Nansha factory in 2023 as a result of severe weather of "Black Rain" due to extreme climate change that led to damages and financial losses. Since then the Group adopted crisis risk management protocols and improved our climaterelated crisis measures, and we did not incur damages and losses in 2024. The Group will continue to review our risk management protocols under severe climate change and further optimize our crisis management procedures to better manage similar situation in the future.

In April 2024, the Group successfully shipped the first container of "Made in Indonesia" products for one of our major customers from the Batam, Indonesia factory of our manufacturing partner. To alleviate potential geopolitical risk, and to mitigate the uncertainty surrounding the trade war, it is important that the Group has an overseas manufacturing facility where we can produce key products outside China for our customers in case Sino-US relationship deteriorates. 為實現AloT(人工智慧與物聯網)相容性,本集團持續投資 於資訊系統和自動化生產流程,將業務轉換為MES系統, 該系統可實時分析製造數據,管理層可觀察到製造流程 瓶頸和設備故障等重要訊息,從而立即採取行動以糾正問 題。我們的MES系統還可以利用大數據和流動監控數據來 改善品質系統。透過更多數位轉型工具,本集團管理層可 以更新策略並對這競爭激烈的全球市場中的變化做出快速 反應。本集團於去年成功取得ISO27001認證,證明本集團 的資訊科技(「IT」)系統已採取令人滿意的網路安全措施保 護資料隱私,本集團於2024年再次通過ISO 27001審核。 此外,本集團的企業資源規劃(「ERP」)及IT系統可實現安 全可靠的資料管理,並保障重要數位及無形資產,讓我們 的持份者對我們就保護資料完整性的能力更有信心。

於2023年,由於極端天氣變化引發「黑雨」的惡劣天氣, 本集團的南沙廠房出現嚴重水災,造成設備損毀及財務損 失。自此以後,本集團採取危機風險管理協定及改善了與 氣候相關的危機措施,於2024年,我們沒有遭受任何損毀 和損失。本集團將繼續審視在極端氣候改變下的危機風險 管理協定,以及進一步優化我們的危機管理程序,以便將 來能更好地應對類似的情況。

2024年4月,本集團從製造合作夥伴在印尼巴淡島工廠成 功為我們的一位主要客戶運送了第一個「印尼製造」產品的 貨櫃。為減輕潛在的地緣政治風險,並減輕貿易戰帶來的 不確定性,本集團擁有海外生產設施非常重要,以便在中 美關係惡化時為客戶在中國以外生產關鍵產品。

In April 2024, the Group also rented out 38% of the office/ warehouse ("**investment property**") at the Hong Kong headquarters to generate rental income. The investment property has been revalued and booked as gain in the other comprehensive income.

In June 2024, the Group was nominated as one of the 3 finalists, among approximately 500 suppliers, as one of our most important customers' procurement partnership award. This kind of recognition would drive our management to strive for improvement and excellence in our future cooperation with strategic partners, both customers and key suppliers.

In November 2024, in celebration of the Group's 60th anniversary, the Group adopted a share option scheme to provide incentive and rewards to eligible participants for their contribution to the Group.

2024 marks the year that the Group celebrates her 60th anniversary. Over the past few years, the Group had made investment to renovate and upgrade the manufacturing facilities with digitally transformed data processing systems and AI enabled manufacturing processes and equipment. With the state-of-the art rejuvenated factory, enthusiastic management and workers, the Group's management strives to achieve greater results and to attain excellence in both operational and financial performance in the coming years.

On behalf of the board of Directors (the "**Board**"), I would like to extend the Board's appreciation to all our staff for their hard work and dedication throughout the year ended 31 December 2024.

於2024年4月,本集團亦出租香港總部38%的辦公室/倉 庫(「投資物業」)以產生租金收入。「投資物業」已重估並計 入其他綜合收益的收益。

2024年6月,本集團在我們一位重要的客戶約500家供應 商中,被提名為3名決賽入圍者之一,作為採購合作夥伴獎 之候選人。這種確認將促使我們的管理層在未來與策略合 作夥伴(包括客戶和主要供應商)的合作中力求改進和爭取 卓越的成績。

為慶祝本集團成立60週年,在2024年11月,本集團採納 了一項購股權計劃,以激勵及獎勵合資格參與者對本集團 所作出的貢獻。

2024年是本集團成立的第60個週年。過去幾年,本集團投 資改造及升級製造設施,採用數位轉型的數據處理系統和 人工智慧支援的製造流程和設備。憑藉最先進及煥然一新 的工廠、抱著一股熱誠的管理層和員工,本集團管理層將 努力在未來幾年取得更大的成果,並在營運和財務業績方 面實現卓越的成績。

本人謹代表董事會(「**董事會**」)對所有職員在2024年12月 31日止內的勤奮及所作出之貢獻深表謝意。

FINANCIAL POSITION

The liquidity position of the Group was satisfactory. The current ratio of the Group was 3.49 as of 31 December 2024, compared with 3.51 as of 31 December 2023. The quick ratio of the Group was 2.83 as of 31 December 2024 (31 December 2023: 2.84). The gearing ratio of the Group was 0.30 as of 31 December 2024 (31 December 2023: 0.32), which was computed by the trade and other payables over total equity.

During FY2024, the Group's trade receivables turnover stood at 69 days, compared with 60 days in FY2023. The inventory turnover in FY2024 was 53 days, compared with 45 days in FY2023.

Bank balances and cash were HK\$349,130,000 as of 31 December 2024 (2023: HK\$367,415,000), representing a decrease of HK\$18,285,000 as compared to the figures in the same period in FY2023 which was mainly due to more dividends were paid out in FY2024.

There were no bank borrowings as of 31 December 2024 (2023: Nil).

The Group had no contingent liabilities as of 31 December 2024 (2023: Nil).

CAPITAL STRUCTURE

During the year, the capital structure of the Company has not been changed with details shown in note 24(a) to the financial statements.

FINAL DIVIDEND AND SPECIAL DIVIDEND

The board of directors (the "**Board**") of the Company has proposed a final dividend of 2 Hong Kong cents per ordinary share (the "**Final Dividend**") (2023: 4 Hong Kong cents per ordinary share) and a special dividend of 6 Hong Kong cents per ordinary share (the "**Special Dividend**") (2023: 6 Hong Kong cents per ordinary share) for the year ended 31 December 2024. The Final Dividend and the Special Dividend, if approved by the shareholders at the forthcoming annual general meeting, will be paid on Monday, 9 June 2025 to the shareholders whose names appear on the register of members of the Company on Wednesday, 28 May 2025.

財政狀況

本集團的資金流動情況令人滿意。於2024年12月31日, 本集團的資金流動比率為3.49,而2023年12月31日為3.51。 於2024年12月31日,本集團的資金速動比率為2.83(2023 年12月31日:2.84)。於2024年12月31日,本集團的資 本與負債比率為0.30(2023年12月31日:0.32),計算基 準為貿易及其他應付賬款除以總權益。

於2024財政年度,本集團的應收賬款周轉期為69天,而 2023財政年度為60天。2024財政年度庫存周轉期為53天, 而2023財政年度為45天。

截 至2024年12月31日, 銀 行 結 餘 及 現 金 為 港 幣 349,130,000元(2023年:港幣367,415,000元),較2023 財政年度同期減少港幣18,285,000元,主要原因是由於 2024財政年度派息增加。

截至2024年12月31日,本集團並無銀行貸款(2023年: 無)。

截至2024年12月31日,本集團並無或然負債(2023年: 無)。

FUTURE PROSPECTS

The Group's management faced strong challenges during the second half of 2024 due to continuous geopolitical tensions and economic uncertainties. The Group's management expects in 2025 the toxic culture of "involution" in China will continue to increase domestic factories cost cutting competition resulting in diminishing returns if we do not innovate and carve out a niche market to develop new differentiated novel products. Furthermore, the Group's management needs to react quickly to formulate a new and effective strategy to counter the disruptive market forces emerging from the business ecosystem in which the Group operates. The Group's investment in R&D enables us to maintain the HNTE status for the eighth consecutive year, and allows the Group to use new knowledge, patents and innovations to grow our business despite a punctuated equilibrium in the business ecosystem. The Group's management will remain resilient to tackle any immediate market downturns and form stronger partnership with our strategic customers to adapt to the new business ecosystem.

前景

鑑於持續緊張的地緣政治局勢以及經濟不穩定等因素,本 集團管理層2024年下半年面臨嚴峻挑戰。本集團管理層預 計在2025年,如果我們不創新並開拓細分市場來開發新的 差異化新產品,中國「內捲化」的有毒文化將繼續加劇國內 工廠削減成本的競爭,導致回報遞減。所以,本集團管理 層需要迅速作出反應並制定有效的新策略,以應對本集團 所處的商業生態系統內出現破壞市場的力量。本集團在研 發方面的投資使我們能夠連續第八年保持高新技術企業資 格,令本集團能夠在商業生態系統平衡處於間斷的狀態下 能利用新的知識、專利和創新來發展我們的業務。本集團 管理層在面對突發的市場低迷時將繼續保持警覺性,並與 我們的策略性客戶建立更緊密的合作關係,以適應新的商 業生態系統。

In the year 2025, the Group will continue to invest and promote computerization of manufacturing. The Group has integrated our ERP system with new financial analytic software such as Microsoft Power BI to enable detailed financial analytics to help the Group's management team make wise decisions on important strategic tasks quickly and to unlock the Group's full operational potential. By analyzing the profit margins of different product lines, the cash and inventory real time positions, and the latest accounts receivables and payables status, the Group's management can address the entire value chain to open up new business opportunities, make more efficient use of working capital and better manage discretionary spending.

As more and more European countries propose "Carbon Border Adjustment Mechanism ("CBAM")", to comply with carbon emission and other environmental, social and governance ("ESG") targets, the Group's management is vigilant about this potential new requirement and gets ready to obtain the CBAM certificates based on Greenhouse Gases ("GHG") emissions embedded in the products to be imported in the European Union. The need for supply chain decarbonization will inevitably increase total product costs and our R&D team will take this new requirement into consideration when we develop new innovative products. Furthermore, the new measures proposed by the International Sustainability Standards Board will also enforce more climate change risk management and new ESG requirements. The Board and the Group's management will keep up-to-date on all the new ESG and decarbonization requirements so that we can be the market forerunner to introduce environmentally friendly new innovative products that suit this new globally sustainability trend.

During the year and up to the date of this report, Dr. WONG, Man Hin Raymond, Mr. WONG, Ying Man John, Mr. MOK, Kin Hing and Dr. WONG, Kin Lae Wilson, are also directors in certain subsidiaries of the Company.

In accordance with article 112 of the Articles of Association, at each annual general meeting one-third of the Directors for the time being or if their number is not three or a multiple of three then the number nearest one-third shall retire from office. Mr. MOK, Kin Hing, Mr. LO, Kwong Shun Wilson and Dr. KO, Siu Fung Stephen will retire from the Board by rotation at the forthcoming 2025 AGM.

Mr. MOK, Kin Hing, Mr. LO, Kwong Shun Wilson and Dr. KO, Siu Fung Stephen shall be eligible and will offer themselves for re-election at the 2025 AGM.

Pursuant to article 95 of the Articles of Association, any Director appointed either to fill a casual vacancy or as an addition to the Board shall hold office only until the next following annual general meeting of the Company and shall then be eligible for re-election at that meeting. Dr. WONG, Yin Wai, being an executive Director (appointed on 1 January 2025) will retire at the forthcoming AGM and shall be eligible and will offer himself for re-election at the 2025 AGM.

None of the Directors being proposed for re-election at the 2025 AGM has a service contract with the Company or its subsidiaries which is not determinable by the Company within one year without payment of compensation (other than statutory compensation).

The non-executive Directors do not have specific terms of appointment but are subject to retirement by rotation in accordance with the Articles of Association.

Biographical details of the Directors and the senior management of the Group are set out on pages 12 to 16 of this annual report.

CONFIRMATION OF INDEPENDENCE

ROLES OF THE BOARD AND MANAGEMENT

The Board is principally responsible for establishing the development direction of the Group, formulating targets and business development plans, approving major agreements and matters, and monitoring the performances of senior management. It is also responsible for corporate governance with a view to enhance shareholders' value. Led by the three executive Directors, the management is responsible for implementing the strategies and plans developed by the Board. The Company has developed a schedule of matters reserved to the Board for decisions and has separately identified those functions reserved to the Board. The Board will review those arrangements on a regular basis to ensure that the arrangements meet the needs of the Company.

ROLES AND DUTIES OF CHAIRMAN AND CHIEF EXECUTIVE OFFICER

The Chairman and the chief executive officer have different roles. The Chairman is responsible for the operation of the Board and the chief executive officer is responsible for managing the operations of the Group. Their functions have been clearly divided to ensure a balanced distribution of power and no authority will concentrate on a single individual.

Dr. WONG, Man Hin Raymond, the Chairman of the Board, an executive Director and the chief financial officer, is principally responsible for leading the Board and ensures the Board to act in the best interests of the Company. The Chairman ensures that the Board to operate effectively and perform its proper duties and discuss all important and proper matters in a timely manner. The Chairman is responsible for convening Board meetings, consulting, determining and approving the agenda of each Board meeting, and ensuring that Directors are provided sufficient information on current matters in a timely manner. The Chairman oversees the structure, number of members and composition of the Board and makes recommendations to the Board and the relevant committees on any intended changes. The Chairman is also responsible for ensuring that the Company formulates good corporate governance practice procedure.

In addition, Dr. WONG is responsible for the Group's financial reporting, internal control, material procurement and control, logistics, customs, taxes and legal matters and compliance, coordinating close cooperation among all departments, uniting efforts of staff and encouraging the initiative of staff so as to ensure smooth and effective operation of the Company's operations and systems.

Mr. WONG, Ying Man John, the Vice-Chairman, an executive Director and the chief executive officer, is principally responsible for the daily operation and management of the Group's overall operations and implementing the Board's operating strategy and policy and delegating tasks to all departments for implementation so as to realize the Board's objectives and decisions. In addition, he is also responsible for research & development, production, quality assurance and new product innovations, coordinating close cooperation among all departments, uniting efforts of staff and encouraging the initiative of staff so as to ensure smooth and effective operation of the Company's operations and systems.

Mr. MOK, Kin Hing, an executive Director and the chief operating officer, is principally responsible for the daily operation and management of the Group's overall operations and implementing the Board's operating strategy and policy and delegating tasks to all departments for implementation so as to realize the Board's objectives and decisions. In addition, he is also responsible for supervising all personnel issues at our Nansha production facilities, all capital equipment installation and disposal, and overseeing all employee champions programs to optimize costs and make sure our facilities are in full compliance with local, international and environment laws and standards.

CORPORATE GOVERNANCE STRUCTURE

The Company's corporate governance structure includes the Board and three committees under the Board, namely audit committee, remuneration committee and nomination committee. - (iv) developing, reviewing and monitoring the code of conduct applicable to employees and directors; and
- (v) reviewing the Company's compliance with the CG Code and disclosure in the Corporate Governance Report.

AUDIT COMMITTEE

The audit committee of the Company (the "Audit Committee") currently comprises three INEDs, at least one of them have appropriate professional qualifications or accounting or related financial management expertise. namely Ms. LING, Kit Sum Imma (chairlady), Mr. LO, Kwong Shun Wilson and Dr. KO, Siu Fung Stephen. The Audit Committee was established with specific written terms of reference, mainly responsible for reviewing the consolidated financial statements and annual and interim reports and accounts of the Company, submitting relevant reports and recommendations to the Board, reviewing the Company's financial controls, internal control and risk management systems and making recommendations on the appointment and remuneration of the auditors of the Company and any matters relating to the termination of appointment. The chairlady of the Audit Committee and is responsible for reporting the results and recommendations of the Audit Committee to the Board after each meeting.

NOMINATION OF DIRECTORS

Pursuant to article 95 of the Articles of Association, the Board is entitled to appoint any person as Director from time to time or at any time to fill a casual vacancy or add a new member to the Board. For nomination, the nominee's qualifications, capabilities and potential to make contribution to the Company shall be taken into consideration by the nomination committee.

BOARD DIVERSITY

The Board has adopted the board diversity policy (the "Board Diversity Policy") in January 2019 which sets out all measurable objectives to achieve and maintain diversity on the Board to enhance effectiveness of the Board. The Company recognises and embraces the benefits of diversity of Board. It endeavours to ensure that the Board has a balance of skills, experiences and varying perspectives appropriate for the Company's business. All Board appointments are made on a merit basis with due regard for the benefits of diversity of the Board members. Selection of candidates are based on a range of diversity perspectives, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills and knowledge. The Nomination Committee will review the Board Diversity Policy on a regular basis to ensure its continued effectiveness from time to time.

COMPANY SECRETARY

Ms. Liu Pui Yee ("**Ms. Liu**") was appointed as the company secretary of the Company on 9 February 2018. Ms. Liu is responsible for ensuring that the Board is fully appraised of the relevant corporate governance developments relating to the Group and facilitating the professional development of the directors. The Company engages an external service provider to provide compliance and full range of company secretarial services to the Company. The primary contact person of the Company with Ms. Liu is Dr. WONG, Man Hin Raymond, the Chairman of the Board, an executive Director and the chief financial officer.

Ms. Liu has received no less than 15 hours relevant professional training during FY2024.

SECURITIES TRANSACTIONS BY DIRECTORS

The Company has adopted the Model Code as its own code of conduct regarding securities transactions by the Directors and established written guidelines no less exacting than the Model Code for senior management and specified persons who are likely to possess inside information in relation to the Group.

Having made specific enquiry to the Directors, all the Directors confirmed that they had complied with the required standards as set out in the Model Code for the year ended 31 December 2024.

RISK MANAGEMENT AND INTERNAL CONTROL

The Board is responsible for maintaining an adequate risk management and internal control system to manage risks on an ongoing basis to reasonably safeguard the interests of the Company's shareholders and the Group's assets. In addition, there is regular dialogue with the Group's internal and external auditors so that both are aware of the significant factors which may affect their respective scope of work.

風險管理及內部監控

董事會有責任維繫足夠的風險管理及內部監控系統以持續 地維護本公司股東的利益及本集團的資產。另外,本集團 也會定期與內部及外部核數師進行對話,使雙方也意識到 影響其工作的重要因素。 The Board has approved an "Inside Information Policy" in May 2013 with the aim to set out guidelines to the directors, officers and all relevant employees of the Group to ensure inside information of the Company is to be disseminated to the public in equal and timely manner in accordance with the applicable laws and regulations. The term "relevant employee" refers to employee of the Group, because of his/ her office or employment, who is likely to be in possession of the unpublished Inside Information.

The Board has also adopted an anti-fraud and anti-bribery policy. Directors and senior management are responsible for ensuring the effective implementation, monitoring and investigating any material fraudulent or bribery activities committed within the Group.

The Group's risk management includes regular identification and review of business risks and control measures to mitigate such risks. The Group's internal control system comprises an established organizational structure as well as comprehensive policies and standards. Area of responsibilities of each business and functional unit is clearly defined to ensure effective check and balance. Procedures have been designed to safeguard assets from unauthorized use or disposition, and to ensure that proper accounting records are maintained and financial information used internally and for publication is reliable. The internal control procedures provide reasonable but not absolute assurance against material errors, losses and fraud; but deem sufficient to ensure full compliance with applicable laws and regulations.

The Audit Committee and the Board carry out an overview every six months on the effectiveness of the risk management and internal control system of the Group. The review covers all material controls, including financial, operational and risk controls. No material risk management and internal control aspects of any significant discrepancies were discovered during the review. The Directors acknowledge their responsibility in preparing the consolidated financial statements of the Group.

The finance department of the Company is managed by a qualified staff and supervised by the Chairman and chief financial officer, Dr. WONG, Man Hin Raymond, who is a U.S. certified public accountant. With the assistance of the finance department, the Board will ensure that the preparation of the consolidated financial statements of the Group complies with relevant regulations and applicable accounting standards.

AUDITOR'S REMUNERATION

The remuneration in respect of audit and non-audit services (including review of interim financial information and tax services) for the year ended 31 December 2024 provided by RSM Hong Kong and its affiliate were approximately HK\$820,000, and HK\$170,000 respectively. The statement of reporting responsibility issued by RSM Hong Kong, the auditor of the Company, in respect of the consolidated financial statements of the Group is set out in the independent auditor's report on pages 53 to 62.

COMMUNICATION WITH SHAREHOLDERS

The Company has maintained communication with its shareholders through the annual general meeting or other general meetings and encourages them to participate in general meetings. Registered shareholders of the Company receive notices of general meetings by post. The notice of general meeting contains the agenda, the proposed resolutions and the voting form. All shareholders of the Company are entitled to attend the annual general meeting and extraordinary general meetings of the Company. Shareholders who are unable to attend the general meeting can fill in the proxy form attached with the notice of general meeting and return the same to the share registrar and transfer office of the Company so as to appoint their representatives or the chairman of the meeting as their proxies. 董事會至少每年審閲並討論本公司的環境、社會及管治報 告,以了解對環境、社會及管治風險的管理及控制。關於 環境、社會和治理相關風險的進一步討論載於單獨的環 境、社會和治理報告中。

問責及審核

The Board has adopted a shareholders' communication policy in May 2013 (the "**Shareholders' Communication Policy**"). Its general policy is to maintain on- going dialogue with the Shareholders and investing community and to ensure that shareholders' views and concerns are appropriately addressed. The Board reviewed the communication activities with the shareholders during the year ended 31 December 2024 and based on such review was satisfied with the implementation and effectiveness of the Shareholders' Communication Policy.

SHAREHOLDERS' RIGHT

Right to convene an extraordinary general meeting

Pursuant to article 68 of the Articles of Association, an extraordinary general meeting shall be convened on requisition as provided by the Companies Ordinance or by the requisitionist. The Directors are required to call a general meeting if the Company has received requests from the Shareholders of the Company representing at least 5% of the total voting rights of all the Shareholders having a right to vote at general meetings.

Right to put enquiries to the Board

Shareholders have the right to put enquiries to the Board. All enquiries can be in writing and sent for the attention of the Board, in one of the following ways:

Procedures to put forward proposals at general meetings

Shareholders who would like to put forward proposals at a general meeting shall follow the procedures below.

Shareholders representing at least 2.5% of the total voting rights of all the Shareholders who have a relevant right to vote or at least 50 Shareholders who have a relevant right to vote may request the Company to:

- give notice of a resolution that may properly be moved and is intended to be moved at the annual general meeting of the Company; or
- ii) circulate a statement of not more than 1,000 words with respect to a matter mentioned in a proposed resolution to be dealt with at a general meeting or other business to be dealt with at the meeting;

to each Shareholder entitled to receive notice of the meeting.

A request to give notice of a resolution must be received by the Company not later than (i) 6 weeks before the annual general meeting to which the request relates; or (ii) if later, the time at which notice is given of that meeting. A request to circulate shareholders' statement must be received by the Company at least 7 days before the meeting to which it relates. Such request may be sent to the Company in hard copy form or in electronic form.

INVESTOR RELATIONS

There was no significant change in the constitutional documents of the Company during FY2024.

DIVIDEND POLICY

The Board has adopted a dividend policy in January 2019. In proposing any dividend payout, the Board shall take into account certain factors, including but not limited to the Group's expected and actual financial performance, its retained earnings and distributable reserves, the Group's capacity from current and future operation, future commitments at the time of declaration of dividend.

The dividend policy and the payment of future dividend are subject to the Board's continuing determination which would be in the best interests of the Group and Shareholders and are in compliance with all applicable laws and regulations.

I. GENERAL INFORMATION

Raymond Industrial Limited (the "**Company**") was incorporated and domiciled in Hong Kong. The address of its registered office and principal place of business is Rooms 1801 – 1813, 18th Floor, Grandtech Centre, 8 On Ping Street, Shatin, New Territories, Hong Kong. With effective from 1 September 2024, the Company's registered office and principal place of business was changed to Rooms 1806-1813, 18th Floor, Grandtech Centre, 8 On Ping Street, Shatin, New Territories, Hong Kong. The Company's shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited ("**the Stock Exchange**").

The principal activity of the Company is sale of electrical home appliances. The principal activities and other particulars of the subsidiaries of the Company are set out in note 31 to the consolidated financial statements.

In the opinion of the directors of the Company, Dr. WONG, Kin Lae Wilson is the ultimate controlling party of the Company.

2. BASIS OF PREPARATION

The consolidated financial statements for year ended 31 December 2024 comprise the Company and its subsidiaries (together the "**Group**").

These consolidated financial statements have been prepared in accordance with all applicable HKFRS Accounting Standards, issued by the Hong Kong Institute of Certified Public Accountants ("**HKICPA**"). HKFRS Accounting Standards comprise Hong Kong Financial Reporting Standards ("**HKFRS**"); Hong Kong Accounting Standards ("**HKAS**"); and Interpretations. These consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the Stock Exchange and with the requirements of the Companies Ordinance (Cap. 622).

The HKICPA has issued certain new and revised HKFRS Accounting Standards that are first effective or available for early adoption for the current accounting period of the Group. Note 3 provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current and prior accounting periods reflected in these consolidated financial statements.

These consolidated financial statements have been prepared under the historical cost convention, unless mentioned otherwise in the accounting policies below (e.g. investment properties that are measured at fair value).

The preparation of financial statements in conformity with HKFRS Accounting Standards requires the use of certain critical accounting estimates. It also requires management to exercise its judgements in the process of applying the Group's accounting policies. The areas involving a higher degree of judgements or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements are disclosed in note 33.

The material accounting policies applied in the preparation of these consolidated financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

(a) Consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries made up to 31 December. Subsidiaries are entities over which the Group has control. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The Group has power over an entity when the Group has existing rights that give it the current ability to direct the relevant activities, i.e. activities that significantly affect the entity's returns.

When assessing control, the Group considers its potential voting rights as well as potential voting rights held by other parties. A potential voting right is considered only if the holder has the practical ability to exercise that right.

Subsidiaries are consolidated from the date on which control is transferred to the Group. They are de-consolidated from the date the control ceases.

Intragroup transactions, balances and unrealised profits are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

(b) Separate financial statements

In the Company's statement of financial position, an investment in a subsidiary is stated at cost less impairment losses (see note 4(r)). Cost includes direct attributable costs of investments. The results of subsidiaries are accounted for by the Company on the basis of dividend received or receivable.

Impairment testing of the investments in subsidiaries is required if the carrying amount of the investment in the separate financial statements exceeds the carrying amount in the consolidated financial statements of the investee's net assets.

(c) Foreign currency translation

(i) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "**functional currency**"). The consolidated financial statements are presented in Hong Kong dollars ("**HK\$**"), which is the Company's functional and presentation currency.

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated using the foreign exchange rates ruling at the transaction dates. The transaction date is the date on which the company initially recognises such non-monetary assets or liabilities. Non-monetary items that are measured at fair value in foreign currencies are translated using the exchange rates at the dates when the fair values are determined.

When a gain or loss on a non-monetary item is recognised in other comprehensive income, any exchange component of that gain or loss is recognised in other comprehensive income. When a gain or loss on a non-monetary item is recognised in profit or loss, any exchange component of that gain or loss is recognised in profit or loss

(d) Property, plant and equipment

Property, plant and equipment are held for use in the production or supply of goods or services, or for administrative purposes (other than cost of construction in progress described below). Property, plant and equipment are stated in the consolidated statement of financial position at cost, less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any (see note 4(q)).

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other repairs and maintenance are recognised in profit or loss during the period in which they are incurred.

(e) Investment properties

Investment properties are land and/or buildings which are owned or held under a leasehold interest to earn rentals and/or for capital appreciation. These include land held for a currently undetermined future use and property that is being constructed or developed for future use as investment property.

Investment property are stated at fair value, unless they are still in the course of construction or development at the end of the reporting period and their fair value cannot be reliably measured at that time.

Gains or losses arising from changes in the fair value of investment properties are recognised in profit or loss for the period in which they arise.

A property is transferred to investment property when, and only when there has been a change in use. Such change in use occurs when the property meets the definition of investment property, and there is evidence of a change in use. If an owner-occupied property becomes an investment property, any difference between its carrying amount and fair value at the date of change in use is treated as revaluation in accordance with HKAS 16 Property, plant and equipment and recorded in other comprehensive income.

An investment property is derecognised upon disposal or when the investment property is withdrawn from use. Any gain or loss on disposal of an investment property is the difference between the net sales proceeds and the carrying amount of the property, and is recognised in profit or loss. Rental income from investment properties is accounted for as described in note 4(m).

(f) Leases

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

At the lease commencement date, the Group recognises a right-of-use asset and a lease liability, except for shortterm leases that have a lease term of 12 months or less and leases of low-value assets which, for the Group are primarily warehouses and carpark. When the Group enters into a lease in respect of a low-value asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. The lease payments associated with those leases which are not capitalised are recognised as an expense on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. Lease payments to be made under reasonably certain extension options are also included in the measurement of the lease liability. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method.

Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to profit or loss in the accounting period in which they are incurred.

The right-of-use asset recognised when a lease is capitalised is initially measured at cost, which comprises the initial amount of the lease liability plus any lease payments made at or before the commencement date, and any initial direct costs incurred. Where applicable, the cost of the right-ofuse assets also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, discounted to their present value, less any lease incentives received. The rightof-use asset is subsequently stated at cost less accumulated depreciation and impairment losses.

Right-of-use assets in which the Group is reasonably certain to obtain ownership of the underlying leased assets at the end of the lease term are depreciated from commencement date to the end of the useful life. Otherwise, right-of-use assets are depreciated on a straight-line basis over the shorter of its estimated useful life and the lease term.

The lease liability is remeasured when there is a change in future lease payments arising from a change in an index or rate, or there is a change in the Group's estimate of the amount expected to be payable under a residual value guarantee, or there is a change arising from the reassessment of whether the Group will be reasonably certain to exercise a purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the rightof-use asset, or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

The lease liability is also remeasured when there is a change in the scope of a lease or the consideration for a lease that is not originally provided for in the lease contract ("**lease modification**") that is not accounted for as a separate lease. In this case the lease liability is remeasured based on the revised lease payments and lease term using a revised discount rate at the effective date of the modification.

The cost of acquiring land held under an operating lease is amortised on a straight-line basis over the period of the lease term. Impairment losses are recognised in accordance with accounting policy set out in note 4(q).

The Group as a lessor

When the Group acts as a lessor, it determines at lease inception whether each lease is a finance lease or an operating lease. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to the ownership of an underlying assets to the lessee. If this is not the case, the lease is classified as an operating lease.

(g) Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined using the weighted average basis. The cost of finished goods and work in progress comprises raw materials, direct labour and an appropriate proportion of all production overhead expenditure, and where appropriate, subcontracting charges. The costs of purchased inventory are determined after deducting rebates and discounts. Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and the estimated costs necessary to make the sale.

When inventories are sold, the carrying amount of those inventories is recognised as an expense in the period in which the related revenue is recognised. The amount of any write-down of inventories to net realisable value and all losses of inventories are recognised as an expense in the period the write-down or loss occurs. The amount of any reversal of any write-down of inventories is recognised as a reduction in the amount of inventories recognised as an expense in the period in which the reversal occurs.

(h) Recognition and derecognition of financial instruments

Financial assets and financial liabilities are recognised in the consolidated statement of financial position when the Group entity becomes a party to the contractual provisions of the instrument.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss ("**FVTPL**")) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at FVTPL are recognised immediately in profit or loss.

If the Group neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Group recognises its retained interest in the asset and an associated liability for amounts it may have to pay. If the Group retains substantially all the risks and rewards of ownership of a transferred financial asset, the Group continues to recognise the financial asset and also recognises a collateralised borrowing for the proceeds received.

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable, including any non-cash assets transferred or liabilities assumed, is recognised in profit or loss.

(i) Financial assets

All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the marketplace. All recognised financial assets are measured subsequently in their entirety at either amortised cost or fair value, depending on the classification of the financial assets.

(j) Trade and other receivables

A receivable is recognised when the Group has an unconditional right to receive consideration. A right to receive consideration is unconditional if only the passage of time is required before payment of that consideration is due. If revenue has been recognised before the Group has an unconditional right to receive consideration, the amount is presented as a contract asset. **4. 重大會計政策**(續)

Trade receivables are recognised initially at the amount of consideration that is unconditional unless they contain significant financing components, when they are recognised at fair value. The Group holds the trade receivables with the objective of collecting the contractual cash flows and therefore measures them subsequently at amortised cost using the effective interest method less allowance for credit losses (see note 4(r)).

(k) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Cash and cash equivalents are assessed for expected credit losses ("**ECLs**") in accordance with the policy set out in note 4(r).

(I) Financial liabilities and equity instruments

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument under HKFRS Accounting Standards. An equity instrument is any contract that evidences a residual interest in the assets of the Group after deducting all of its liabilities. The accounting policies adopted for specific financial liabilities and equity instruments are set out below.

(i) Trade and other payables

Trade and other payables are recognised initially at fair value are subsequently measured at amortised cost using the effective interest method unless the effect of discounting would be immaterial, in which case they are stated at cost.

An equity instrument is any contract that evidence a residual interest in the assets of an entity after deducting all of its liabilities. Equity instruments issued by the Company are recorded at the proceeds received, net of direct issue costs.

(m) Revenue and other income

Revenue is recognised when control over a product or service is transferred to the customer, at the amount of promised consideration to which the Group is expected to be entitled, excluding those amounts collected on behalf of third parties. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts and sales rebate.

(i) Sale of goods

Revenue from the sales of electrical home appliances is recognised when control of the goods has transferred, being when the goods have been shipped to the wholesaler's specific location (delivery). Following delivery, the wholesaler has full discretion over the manner of distribution and price to sell the goods, has the primary responsibility when on selling the goods and bears the risks of obsolescence and loss in relation to the goods. A receivable is recognised by the Group when the goods are delivered to the wholesaler as this represents the point in time at which the right to consideration becomes unconditional, as only the passage of time is required before payment is due.

(ii) Interest income

Interest income is recognised as it accrues using the effective interest method. For credit impaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount net of loss allowance) of the asset.

Rental income receivable under operating leases is recognised in profit or loss in equal instalments over the periods covered by the lease term, except where an alternative basis is more representative of the pattern of benefits to be derived from the use of the leased asset.

(n) Product development costs

Expenditure on development activities, whereby research findings are applied to a plan or design for the production of new or substantially improved products and processes, is capitalised if the product or process is technically and commercially feasible and the Group has sufficient resources and the intention to complete development. The expenditure capitalised includes the costs of materials, direct labour and an appropriate proportion of overheads. Development expenditure which does not meet these criteria is recognised as an expense in the period in which it is incurred.

(o) Employee benefits

(i) Employee leave entitlements

Employee entitlements to annual leave and long service leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave and long service leave as a result of services rendered by employees up to the end of the reporting period.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

(ii) Pension obligations

The Group contributes to defined contribution retirement schemes which are available to all employees. Contributions to the schemes by the Group and employees are calculated as a percentage of employees' basic salaries. The retirement benefit scheme cost charged to profit or loss represents contributions payable by the Group to the funds.

For LSP obligation, the Group accounts for the employer MPF contributions expected to be offsetted as a deemed employee contribution towards the LSP obligation in term of HKAS 19 paragraph 93(a) and it is measured on a net basis. The estimated amount of future benefit is determined after deducting the negative service cost arising from the accrued benefits derived from the Group's MPF contributions that have been vested with employees, which are deemed to be contributions from the relevant employees.

(iii) Termination benefits

Termination benefits are recognised at the earlier of the dates when the Group can no longer withdraw the offer of those benefits, and when the Group recognises restructuring costs and involves the payment of termination benefits.

(p) Taxation

Income tax represents the sum of the current tax and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit recognised in profit or loss because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which deductible temporary differences can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit and at the time of transaction does not give rise to equal taxable and deductible temporary differences.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax is calculated at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised, based on tax rates that have been enacted or substantively enacted by the end of the reporting period. Deferred tax is recognised in profit or loss, except when it relates to items recognised in other comprehensive income or directly in equity, in which case the deferred tax is also recognised in other comprehensive income or directly in equity.

The measurement of deferred tax assets and liabilities reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred tax for investment properties that are measured using the fair value model, the carrying amounts of such properties are presumed to be recovered through sale, unless the presumption is rebutted. The presumption is rebutted when the investment property is depreciable and is held within a business model of the Group whose business objective is to consume substantially all of the economic benefits embodied in the investment property over time, rather than through sale. If the presumption is rebutted, deferred tax for such investment properties are measured based on the expected manner as to how the properties will be recovered.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority and the Group intends to settle its current tax assets and liabilities on a net basis, or to realise the asset and settle the liability simultaneously.

Companies within the Group may be entitled to claim special tax deductions for investments in qualifying assets or in relation to qualifying expenditure (e.g. the Research and Development Tax Incentive regime in PRC or other investment allowances). The Group accounts for such allowances as tax credits, which means that the allowance reduces income tax payable and current tax expense. A deferred tax asset is recognised for unclaimed tax credits that are carried forward as deferred tax assets.

The carrying amounts of non-financial assets are reviewed at each reporting date for indications of impairment and where an asset is impaired, it is written down as an expense through the consolidated statement of profit or loss to its estimated recoverable amount unless the relevant asset is carried at a revalued amount, in which case the impairment loss is treated as a revaluation decrease. The recoverable amount is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets. If this is the case, recoverable amount is determined for the cash-generating unit to which the asset belongs. Recoverable amount is the higher of value in use and the fair value less costs of disposal of the individual asset or the cash-generating unit.

Value in use is the present value of the estimated future cash flows of the asset/cash-generating unit. Present values are computed using pre-tax discount rates that reflect the time value of money and the risks specific to the asset/cashgenerating unit whose impairment is being measured.

Impairment losses for cash-generating units are allocated first against the goodwill of the unit and then pro rata amongst the other assets of the cash-generating unit. Subsequent increases in the recoverable amount caused by changes in estimates are credited to profit or loss to the extent that they reverse the impairment.

The Group recognises a loss allowance for ECLs on trade receivables and instruments that are measured at amortised cost. The Group always recognises lifetime ECL for trade receivables. The ECL on these financial assets are estimated using a provision matrix based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current as well as the forecast direction of conditions at the reporting date, including time value of money where appropriate.

For all other financial instruments, the Group recognises lifetime ECL when there has been a significant increase in credit risk since initial recognition. However, if the credit risk on the financial instrument has not increased significantly since initial recognition, the Group measures the loss allowance for that financial instrument at an amount equal to 12-month ECL.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of a financial instrument. In contrast, 12-month ECL represents the portion of lifetime ECL that is expected to result from default events on a financial instrument that are possible within 12 months after the reporting date.

Significant increase in credit risk

In assessing whether the credit risk on a financial instrument has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument at the reporting date with the risk of a default occurring on the financial instrument at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort. Forward-looking information considered includes the future prospects of the industries in which the Group's debtors operate, obtained from economic expert reports, financial analysts, governmental bodies, relevant think-tanks and other similar organisations, as well as consideration of various external sources of actual and forecast economic information that relate to the Group's core operations.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly since initial recognition:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk for a particular financial instrument;
- existing or forecast adverse changes in business, financial or economic conditions that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations;
- an actual or expected significant deterioration in the operating results of the debtor;
- significant increases in credit risk on other financial instruments of the same debtor;
- an actual or expected significant adverse change in the regulatory, economic, or technological environment of the debtor that results in a significant decrease in the debtor's ability to meet its debt obligations.

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk on a financial asset has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

Despite the foregoing, the Group assumes that the credit risk on a financial instrument has not increased significantly since initial recognition if the financial instrument is determined to have low credit risk at the reporting date. A financial instrument is determined to have low credit risk if:

- (i) the financial instrument has a low risk of default;
- (ii) the debtor has a strong capacity to meet its contractual cash flow obligations in the near term; and
- (iii) adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations.

The Group considers a financial asset to have low credit risk when the asset has external credit rating of "investment grade" in accordance with the globally understood definition or if an external rating is not available, the asset has an internal rating of "performing". Performing means that the counterparty has a strong financial position and there is no past due amount.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due. 4. 重大會計政策(續)

Definition of default

The Group considers the following as constituting an event of default for internal credit risk management purposes as historical experience indicates that receivables that meet either of the following criteria are generally not recoverable.

 when there is a breach of financial covenants by the counterparty; or information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

Irrespective of the above analysis, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

Credit-impaired financial assets

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- significant financial difficulty of the issuer or the counterparty;
- a breach of contract, such as a default or past due event;
- the lender(s) of the counterparty, for economic or contractual reasons relating to the counterparty's financial difficulty, having granted to the counterparty a concession(s) that the lender(s) would not otherwise consider;
- it is becoming probable that the counterparty will enter bankruptcy or other financial reorganisation; or
- the disappearance of an active market for that financial asset because of financial difficulties.

Write-off policy

The Group writes off a financial asset when there is information indicating that the debtor is in severe financial difficulty and there is no realistic prospect of recovery, including when the debtor has been placed under liquidation or has entered into bankruptcy proceedings, or in the case of trade receivables, when the amounts are over two years past due, whichever occurs sooner. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. Any recoveries made are recognised in profit or loss.

Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information as described above. As for the exposure at default, for financial assets, this is represented by the assets' gross carrying amount at the reporting date.

For financial assets, the ECL is estimated as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive, discounted at the original effective interest rate.

If the Group has measured the loss allowance for a financial instrument at an amount equal to lifetime ECL in the previous reporting period, but determines at the current reporting date that the conditions for lifetime ECL are no longer met, the Group measures the loss allowance at an amount equal to 12-month ECL at the current reporting date, except for assets for which simplified approach was used.

The Group recognises an impairment gain or loss in profit or loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account. **4. 重大會計政策**(續)

The discount rate used to determine the present value is a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability. The increase in the provision due to the passage of time is recognised as interest expense.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow is remote. Possible obligations, whose existence will only be confirmed by the occurrence or nonoccurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow is remote.

On 1 April 2024, the Group leased out a portion of an owner-occupied building to generate rental income. Accordingly, that portion of property, plant and equipment was reclassified as investment property when the owner-occupation ceased.

The Group's primary objectives when managing capital are to safeguard the Group's ability to continue as a going concern, so that it can continue to provide returns for shareholders and benefits for other stakeholders, by pricing products and services commensurately with the level of risk and by securing access to finance at a reasonable cost.

The Group actively and regularly reviews and manages its capital structure to maintain a balance between the higher shareholder returns and the advantages and security afforded by a sound capital position, and makes judgements to the capital structure in light of changes in economic conditions.

Consistent with industry practice, the Group monitors its capital structure on the basis of a net debt-to-adjusted capital ratio. For this purpose the Group defines net debt as total debt (which includes trade and other payables) plus unaccrued proposed dividends. Adjusted capital comprises all components of equity less unaccrued proposed dividends.

During the year ended 31 December 2024, the Group's strategy, which was unchanged from 2023, was to maintain the net debt-to-adjusted capital ratio at reasonable level. In order to maintain or adjust the ratio, the Group may adjust the amount of dividends paid to shareholders, issue new shares, return capital to shareholders, raise new debt financing or sell assets to reduce debt.

27. FINANCIAL RISK MANAGEMENT

The Group's activities expose it to a variety of financial risks: credit risk and concentration risk, liquidity risk, interest rate risk and foreign currency risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

(a) Credit risk and concentration risk

The Group's credit risk is primarily attributable to bank and cash balances and trade receivables. The maximum exposure to credit risk is represented by the carrying amount of each financial asset in the consolidated statement of financial position.

Substantially all the Group's bank and cash balances are deposited in financial institutions in Hong Kong and the PRC. The credit risk is limited as the majority of counterparties are financial institutions with high credit ratings assigned by international credit rating agencies or stated-controlled financial institutions with good reputations.

The Group's exposure to credit risk is influenced mainly by the individual characteristics of each customer. The default risks of the industry and country in which customers operate also have an influence on credit risk but to a lesser extent. At the end of the reporting period, the Group has a certain concentration of credit risk as 38% (2023: 33%); and 85% (2023: 89%) of the trade receivables was due from the largest customer and the five largest customers respectively.

本集團主要現金及現金等值項目一般存放於信譽良好之香 港及中國金融機構。資金流動性之信貸風險是有限是因大 多數貿易夥伴是獲國際信譽評級機構評為信貸良好之財務 機構及國家控制之良好信譽的財務機構。

本集團所承受的信貸風險主要受每位客戶的個人特徵影響。客戶經營所在行業和國家的違約風險也對信貸風險有 影響,但程度較小。於報告期末,本集團的信貸風險集中 度為38%(2023年:33%);應收貿易賬款中的85%(2023年: 89%)分別來自最大客戶和五個最大客戶。

In respect of trade receivables, management has a credit policy in place and the exposure to the credit risk is monitored on an ongoing basis. Individual credit evaluations are performed on all customers requiring credit over a certain amount. These evaluations focus on the customer's past history of making payments when due and current ability to pay, and take into account information specific to the customer as well as pertaining to the economic environment in which the customer operates. Trade receivables are due within 30 to 120 days from the date of billing. Normally, the Group does not obtain collateral from customers.

The Group measures loss allowances for trade receivables at an amount equal to lifetime ECLs. As the Group's historical credit loss experience does not indicate significantly different loss patterns for different customer segments, the loss allowance based on past due status is not further distinguished between the Group's different customer bases.

The directors of the Company have considered the credit risk of trade receivables and note that there was no actual loss nor significant past due experience over the past 2 years, including periods of unfavourable economic conditions. The directors consider the aggregate risks arising from the possibility of credit loss on trade receivables are not significant and no allowance for credit losses was made as at 31 December 2024.

Further quantitative disclosures in respect of the Group's exposure to credit risk arising from trade receivable are set out in note 18.

(b) Liquidity risk

Individual operating entities within the Group are responsible for their own cash management, including the short term investment of cash surpluses. The Group's policy is to regularly monitor its liquidity requirements to ensure that it maintains sufficient reserves of cash and adequate committed lines of funding from major financial institutions to meet its liquidity requirements in the short and longer term.

33. CRITICAL JUDGEMENTS AND KEY 33. ESTIMATES

In applying the Group's accounting policies, which are described in note 4, the directors are required to make judgements (other than those involving estimations) that have a significant impact on the amounts recognised and to make estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Critical judgements in applying accounting policies

In the process of applying the accounting policies, the directors have made the following judgements that have the most significant effect on the amounts recognised in the consolidated financial statements (apart from those involving estimations, which are dealt with below).

(a) Significant increase in credit risk

ECL are measured as an allowance equal to 12-month ECL for stage 1 assets, or lifetime ECL for stage 2 or stage 3 assets. An asset moves to stage 2 when its credit risk has increased significantly since initial recognition. HKFRS 9 does not define what constitutes a significant increase in credit risk. In assessing whether the credit risk of an asset has significantly increased the Group takes into account qualitative and quantitative reasonable and supportable forward-looking information.

對估計數和基本假設進行持續審查。如果修訂僅影響會計 估計的修訂期間,則在修訂估計的期間確認,如果修訂同 時影響當前和未來期間,則在修訂期間和未來期間確認。

應用會計政策時的重要判斷

在應用會計政策的過程中,董事作出了以下對綜合財務報 表中確認的金額有最重大影響的判斷(涉及估計的判斷除 外,將在下文討論)。

(a) 信貸風險顯著增加

第一階段資產的預期信貸虧損按相等於12個月預期信貸虧 損的撥備計量,或就第二或第三階段資產按相等於全期預 期信貸虧損的撥備計量。當一項資產的信貸風險自首次確 認以來顯著增加,該資產會轉移至第二階段。香港財務報 告準則第9號並無對信貸風險顯著增加的構成要素作出定 義。評估一項資產的信貸風險有否顯著增加時,本集團會 考慮合理及有理據支持的定性及定量前瞻性資料。

(b) Deferred tax for investment properties

For the purposes of measuring deferred tax for investment properties that are measured using the fair value model, the directors have reviewed the Group's investment property portfolios and concluded that the Group's investment properties are not held under a business model whose objective is to consume substantially all of the economic benefits embodied in the investment properties over time, rather than through sale. Therefore, in determining the Group's deferred tax for investment properties, the directors have adopted the presumption that investment properties measured using the fair value model are recovered through sale.

Key sources of estimation uncertainty

The key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are discussed below.

(a) Depreciation

Property, plant and equipment and right-of-use assets are depreciated on a straight-line basis or reducing balance basis over the estimated useful lives. The Group reviews annually the useful life of an asset and its residual value, if any. The depreciation expense for future periods is adjusted if there are significant changes from the previous estimation.

(b) 投資物業的遞延税項

就計量按公允價值模式計量的投資物業的遞延税項而言, 董事已審閱本集團的投資物業組合,並認為本集團的投資 物業並非根據目標為隨時間而非透過出售消耗該等投資物 業所包含的絕大部分經濟利益的商業模式持有。因此,在 釐定本集團投資物業的遞延税項時,董事已假設按公允價 值模式計量的投資物業已透過出售收回。

估計不明朗因素的主要來源

下文討論有關未來的主要假設及報告期末估計不明朗因素 的其他主要來源,該等假設及來源存在導致資產及負債的 賬面值須於下一個財政年度作出重大調整的重大風險。

(a) 折舊

物業、廠房及設備及使用權資產以直線法或餘額遞減法按 資產的估計可使用年期折舊。集團會每年檢討對該等資產 的可使用年期的及餘值估計,如有,未來的折舊開支會因 應過往估計數字的重大變化而調整。

(b) Impairment of property, plant and equipment and right-of-use assets

In considering the impairment loss that may be required for certain property, plant and equipment, right-of-use assets and investments in subsidiaries, the recoverable amount of the asset needs to be determined. The recoverable amount is the greater of the fair value less costs of disposal and the value in use. It is difficult to estimate precisely the fair value price because quoted market prices for the assets may not be readily available. In determining the value in use, expected cash flows generated by the asset are discounted to their present value, which requires significant judgement relating to items such as level of revenue and amount of operating costs. The Group uses all readily available information in determining an amount that is a reasonable approximation of the recoverable amount, including estimates based on reasonable and supportable assumptions and projections of items such as revenue and operating costs.

(c) Impairment of trade receivables

The Group considers the ECLs of trade receivables are based on management's estimate of the lifetime ECL which is taking into account the credit loss experience, ageing of overdue trade receivables, customers' repayment history and customers' financial position and an assessment of both the current and forecast general economic conditions, all of which involve a significant degree of management judgement.

The provision of ECLs is sensitive to changes in circumstances and of forecast general economic conditions. The information about the ECLs and the Group's trade receivables are disclosed in notes 18 and 27(a). If the financial condition of the customers or the forecast economic conditions were to deteriorate, actual loss allowance would be higher than estimated.

(b) 物業、廠房及設備及使用權資產減值

考慮到若干物業、廠房及設備、使用權資產及於附屬公司 之投資及可收回資產可能出現減值虧損,須釐定資產之可 收回金額。可收回金額為淨售價與使用價值兩者之較高 者。由於此等資產之所報市價不能可靠地獲取,故難以準 確地估計售價。在釐定使用價值時,資產所產生之預期現 金流量乃折讓至其現有價值,而須就營業額水平及營運成 本金額等項目作出重要評估。本集團在釐定金額時使用所 有可靠取得之資料,而金額為可收回金額之合理概約金 額,包括根據合理及有支持之假設及預測項目如營業額及 營運成本等估計數據。

(c) 貿易應收賬款減值

本集團認為貿易應收賬款的預期信貸虧損基於管理層對存 續期預期信貸虧損的估計,該估計考慮了信貸虧損經驗, 逾期貿易應收賬款的賬齡,客戶的還款記錄和客戶的財務 狀況以及當前和預測的總體經濟狀況評估,所有這些很大 程度由管理層判斷。

提供預期信貸虧損對環境變化和預測總體經濟狀況很敏 感。有關預期信貸虧損及本集團貿易應收賬款的資料於附 註18及27(a)披露。如果客戶的財務狀況或預測的經濟狀況 惡化,實際損失準備金將高於估計。

(d) Income taxes

Determining income tax provisions involves judgement on the future tax treatment of certain transactions and interpretation of tax rules. The Group carefully evaluates the tax implications of transactions and tax provisions are set up accordingly. The tax treatment of transactions is reconsidered periodically to take into account all changes in tax legislation.

(e) Allowance for slow-moving and obsolete inventories

The Group performs regular reviews of the carrying amounts of inventories with reference to aged inventories analyses, projections of expected future saleability of goods and management experience and judgement. Based on these reviews, write-down of inventories will be made when the carrying amounts of inventories fall below their estimated net realisable value. Due to changes in customers' performance, actual sale of goods may be different from estimates and profit or loss could be affected by differences from estimates.

(f) Fair value of investment properties

The Group appointed an independent professional valuer to assess the fair value of the investment properties. In determining the fair value, the valuer has utilised a method of valuation which involves certain estimates. The directors have exercised their judgement and are satisfied that the method of valuation and inputs used are reflective of the current market conditions.

(d) 所得税

釐定所得税撥備涉及對若干交易未來税項處理之評估及税務規則之詮釋。本集團審慎地評估交易之隱含税項,並據 此提撥税項撥備。該等交易之税項處理乃定期檢討,以計 及税項法例之所有變動。

(e) 滞銷及過時存貨撥備

本集團執行定期檢討按存貨賬齡分析、預期未來銷售、管 理經驗及判斷之存貨賬面值。基於此檢討,已因存貨賬面 值下跌低於其估算計現價值淨值而作存貨減值。因客戶表 現的變動、實際銷售將與此估計有差異及此計亦可能影響 溢利或虧損。

(f) 投資物業的公允價值

本集團已委派一名獨立專業估值師對投資物業的公允價值 進行評估。於釐定公允價時,估值師採用涉及若干估計的 估值方法。董事已行使其判斷,並相信該估值方法及所用 輸入數據能反映當前的市況。
