This announcement is made by Beijing Airdoc Technology Co., Ltd. (the “**Company**”) pursuant to Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) (the “**Inside Information Provisions**”) and Rule 13.09(2)(a) of the Rules (the “**Listing Rules**”) Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

References are made to the Company’s circular dated September 27, 2024 and announcement dated August 28, 2024 (the “**Announcement and Circular**”) in relation to, among others, the particulars of the Company’s application for “Full Circulation” of certain Unlisted Shares of the Company made to the China Securities Regulatory Commission (the “**CSRC**”). Unless the context otherwise requires, capitalized terms used herein shall have the same meanings as those defined in the Announcement and Circular.

The Company is pleased to announce that the Company recently received the Filing Notice for the “Full Circulation” of Domestic Unlisted Shares of Beijing Airdoc Technology Co., Ltd. (《關於北京鷹瞳科技發展股份有限公司境內未上市股份「全流通」備案通知書》) (the “**Notice**”) from the CSRC, pursuant to which the CSRC approved 26 Shareholders of the Company to convert a total of 50,151,012 Unlisted Shares held by them into overseas listed H Shares, which can be listed and traded on the Main Board of the Stock Exchange upon completion of the conversion (the “**Conversion and Listing**”). The Notice shall be valid for 12 months from the date of approval by the CSRC, namely April 25, 2026. Please refer to the Announcement and Circular for details of names of Shareholders and number of Unlisted Shares applied for full circulation. As of the date of this announcement, the details of the implementation plan of the H Share Full Circulation and the Conversion and Listing have not been finalized. The Company will

make further announcement(s) on the progress of the H Share Full Circulation and the Conversion and Listing in accordance with the Inside Information Provisions and/or the requirements of the Listing Rules.

The H Share Full Circulation and the Conversion and Listing are subject to other relevant procedures as required by the CSRC, the Stock Exchange and other domestic and overseas regulatory authorities. Shareholders and potential investors of the Company are advised to exercise caution when dealing in the securities of the Company.
