This announcement is made by Netjoy Holdings Limited (the “**Company**”, and its subsidiaries and consolidated affiliated entities, together, the “**Group**”) pursuant to Rules 13.09(2)(a) and 13.49(3) of the Rules Governing the Listing of Securities (the “**Listing Rules**”) on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to the announcement of the Company dated 1 April 2025 (the “**Announcement**”) in relation to, among other matters, (1) delay in publication of the 2024 Annual Results; (2) possible delay in despatch of 2024 Annual Report; (3) postponement of the Board Meeting; and (4) suspension of trading since 9:00 a.m. on 1 April 2025. Unless otherwise defined or the context otherwise requires, capitalised terms in this announcement shall have the same meanings as defined in the Announcement.

(1) FURTHER INFORMATION ON THE DELAY IN PUBLICATION OF ANNUAL RESULTS FOR THE YEAR ENDED 31 DECEMBER 2024

As stated in the Announcement, due to the reasons as set out in the Announcement, the Company was unable to publish the 2024 Annual Results on or before 31 March 2025. The Board (the “**Board**”) of Directors (the “**Directors**”) of the Company would like to provide its shareholders and potential investors with additional information on the delay in publishing the 2024 Annual Results.

In addition to providing the auditors with relevant information as requested, the Company is still in the course of providing additional supplementary information for the additional investigation to be conducted on certain prepayments paid by the Company to two suppliers, including the business rationale and business substance of these transactions. As of the date of this announcement, the Board has determined the scope of additional works and is conducting additional investigations. The Company will make further announcements in accordance with the Listing Rules to provide the latest progress of the above additional investigation and the expected publication date of the 2024 annual results.

Save as disclosed in this announcement, other contents of the Announcement remain unchanged. This announcement is supplemental to and should be read in conjunction with the Announcement.

(2) CONTINUED SUSPENSION OF TRADING

Trading in the shares of the Company has been suspended on the Stock Exchange since 9:00 am on Tuesday, 1 April 2025, and will continue to be suspended until further notice. The Company will make further announcements on the publication of the 2024 Annual Results and/or the Board Meeting as and when appropriate and in accordance with the Listing Rules.

Shareholders of the Company and potential investors are advised to exercise caution in dealing in the securities of the Company.
