NOTICE OF ANNUAL GENERAL MEETING**

1. INTRODUCTION

The purpose of this circular is to provide you with information regarding the resolutions to be proposed at the AGM to enable the Shareholders to make an informed decision on whether to vote for or against the resolutions and to give you notice of the AGM. Resolutions to be proposed at the AGM include ordinary resolutions relating to, among other things, (i) the Issue Mandate, (ii) the Repurchase Mandate and (iii) the re-election of Directors.

LETTER FROM THE BOARD

2. GENERAL MANDATE FOR THE ISSUE OF NEW SHARES

At the annual general meeting of the Company held on 3 June 2024, the Directors were granted general and unconditional mandates to:

- (i) allot, issue and deal with unissued Shares not exceeding 20% of the total number of Shares in issue as at the date of passing such resolution;
- (ii) repurchase Shares not exceeding 10% of the total number of the Shares in issue at the date of passing such resolution; and
- (iii) extend the issue mandate set out in (i) above by an amount equal to the number of Shares repurchased pursuant to the repurchase mandate set out in (ii) above.

The above general mandates will expire at the conclusion of the AGM and the purpose of this circular, among other things, is to request your support to approve the General Mandates at the AGM.

At the AGM, an ordinary resolution will be proposed which, if passed, will grant the Directors the Issue Mandate to allot, issue and deal with additional Shares (including any sale or transfer of the treasury shares out of treasury) up to 20% of the total number of issued Shares of the Company (excluding treasury shares, if any) as at the date of passing of the relevant resolution. As at the Latest Practicable Date, a total of 2,771,795,157 Shares were in issue. Subject to the passing of the relevant resolution granting the Issue Mandate to the Directors and on the basis that no Shares will be issued or repurchased by the Company between the Latest Practicable Date and prior to the AGM, the maximum number of Shares that may be issued by the Directors pursuant to the Issue Mandate (including any sale or transfer of treasury shares out of treasury) is 554,359,031 Shares. If the share capital of the Company changes as a result of a share consolidation or subdivision after the approval of the Issue Mandate, the maximum number of Shares that can be issued will be adjusted accordingly such that the maximum percentage of shares which may be issued under the Issue Mandate immediately before and after such share capital change shall be the same. In addition, approval of the Shareholders is proposed to be sought at the AGM to extend the Issue Mandate by adding to it the number of Shares repurchased by the Company under the Repurchase Mandate subsequent to the passing of the relevant resolutions.

The above mandates, if granted, will be valid until whichever is the earliest of (i) the conclusion of the next annual general meeting of the Company after the AGM, (ii) the expiration of the period within which the next annual general meeting of the Company after the AGM is required by the Articles of Association or any applicable laws to be held, and (iii) the passing of an ordinary resolution by the Shareholders in general meeting revoking or varying or renewing the authority given to the Directors, in order to provide flexibility for issuing new Shares when it is in the interests of the Company to do so.

As at the Latest Practicable Date, the Listing Rules provide that, unless the Stock Exchange agrees otherwise, in the event the Issue Mandate is exercised and Shares are placed for cash consideration under the Issue Mandate, the issue price of the Shares may not be at a price which represents a discount of 20% or more to the benchmarked price of the Shares, such benchmarked price being the higher of:

- (i) the closing price of the Shares as quoted on the Stock Exchange on the date of the relevant placing agreement or other agreement involving the proposed issue of securities under the Issue Mandate; and
- (ii) the average closing price of the Shares as quoted on the Stock Exchange in the 5 trading days immediately prior to the earlier of:
 - a) the date of announcement of the placing or the proposed transaction or arrangement involving the proposed issue of Shares under the Issue Mandate;
 - b) the date of the placing agreement or other agreement involving the proposed issue of Shares under the Issue Mandate; and
 - c) the date on which the placing or subscription or selling price is fixed.

In terms of the price at which Shares may be issued at time of exercise of the Issue Mandate, the Company will comply with the then prevailing requirements under the Listing Rules.

3. GENERAL MANDATE FOR THE REPURCHASE OF SHARES

An ordinary resolution will be proposed at the AGM to grant to the Directors the Repurchase Mandate. The Shares which may be repurchased pursuant to the Repurchase Mandate is limited to a maximum of 10% of the total number of issued Shares of the Company (excluding treasury shares, if any) as at the date of passing of the relevant resolution. Subject to the passing of the relevant resolution granting the Repurchase Mandate to the Directors and on the basis that no Shares will be issued or repurchased by the Company between the Latest Practicable Date and prior to the AGM, the Directors will be allowed under the Repurchase Mandate to repurchase a maximum of 277,179,515 Shares.

The Repurchase Mandate, if granted, will be valid until whichever is the earliest of (i) the conclusion of the next annual general meeting of the Company after the AGM, (ii) the expiration of the period within which the next annual general meeting of the Company after the AGM is required by the Articles of Association or any applicable laws to be held, or (iii) the passing of an ordinary resolution by the Shareholders in general meeting revoking or varying or renewing the authority given to the Directors. If the share capital of the Company changes as a result of a share consolidation or subdivision after the approval of the Repurchase Mandate, the maximum number of Shares that can be purchased will be adjusted accordingly such that the maximum percentage of Shares which may be purchased under the Repurchase Mandate immediately before and after such share capital change shall be the same.

With effect from 11 June 2024, the Listing Rules were amended to introduce flexibility for listed companies to allow repurchased Shares to be held in treasury with detailed rules to govern the resale of treasury shares. Following such changes to the Listing Rules, subject to obtaining the Shareholder's approval at the AGM, if the Company repurchases Shares pursuant to the Repurchase Mandate, the Company may (i) cancel the repurchased Shares and/or (ii) hold such Shares in treasury as treasury shares, subject to market conditions and the capital management needs of the Group at the relevant time such repurchases of Shares are made. If the Company holds Shares in treasury, any resale of treasury shares shall be made in accordance with the Listing Rules and applicable laws and regulations of Cayman Islands.

Appendix I to this circular contains an explanatory statement, as required by Rule 10.06(1)(b) and other relevant provisions of the Listing Rules, to provide the requisite information to the Shareholders to enable the Shareholders to make an informed decision on whether to vote for or against the resolution to grant the Repurchase Mandate.

4. RE-ELECTION OF RETIRING DIRECTORS

In accordance with Article 84(1) and (2) of the Articles of Association, Mr. Wang Wenliang (“**Mr. Wang**”), Mr. Jia Kun (“**Mr. Jia**”), and Mr. Lu Zhaoheng (“**Mr. Lu**”) will retire from office as Directors by rotation at the AGM. Mr. Wang and Mr. Jia, being eligible, offer themselves for re-election at the AGM. Mr. Lu has informed the Company that he will not offer himself for re-election at the AGM as he would like to devote more time to his family and personal interest. Accordingly, Mr. Lu will retire from office following the conclusion of the AGM.

The Nomination Committee has reviewed the structure and composition of the Board, the confirmations and disclosures given by the Directors, the qualifications, skills and experience, time commitment and contribution of the retiring Directors with reference to the nomination principles and criteria, defined process of selection and performance evaluation set out in the Company's Board Diversity Policy and Director Nomination Policy and the Company's corporate strategy. The Nomination Committee has established and implemented processes including taking into consideration the attendance records at the meetings of the Board and the relevant Board committees for monitoring and evaluating the contribution of the retiring Directors.

The Nomination Committee and the Board are satisfied with all the retiring Directors' contribution to the Company, which will continue to bring valuable knowledge and professionalism to the Board for its efficient and effective functioning and diversity. The Nomination Committee and the Board therefore recommended the re-election of all the retiring Directors at the AGM.

Set out below are the details of the Directors proposed to be re-elected:

Mr. Wang Wenliang, aged 54, is the Chairman of the Company. He was appointed as an executive Director on 10th July, 2003 and is responsible for the overall strategic planning and operational development of the Company and its subsidiaries (collectively the “**Group**”). Mr. Wang also serves as a director of certain other subsidiaries within the Group. Mr. Wang have accumulated over 30 years of business experience in China. With keen investment vision and rich operational and management experience, he has invested in various fields including financial securities, internet

information services and operation, building materials, real estate development, energy and infrastructures, etc. Mr. Wang currently serves as the standing vice chairman of Hong Kong Association for Promotion of Peaceful Reunification of China Limited and the deputy chairman of the fourth council of China Foundation For Justice And Courage. Mr. Wang was an executive director of China Gas Holdings Limited between 17th January, 2003 and 10th June, 2003. Mr. Wang completed his postgraduate course in Finance in the Graduate School of Chinese Academy of Social Sciences in the PRC in June 2001. Mr. Wang completed the EMBA program at School of Business of Peking University in July 2019. Mr. Wang is the sole shareholder, a chairman and director of Hezhong Investment Holding Company Limited (“**Hezhong**”), which is a substantial shareholder (as defined in the Listing Rules) of the Company.

As at the Latest Practicable Date, Mr. Wang is interested in an aggregate of 800,225,206 Shares, 21,324,616 Shares of which is beneficially owned by him, 10,938,301 Shares of which is beneficially owned by his wife, Ms. Feng Haiyan and 767,962,289 Shares of which is beneficially owned by Hezhong, a company wholly-owned by Mr. Wang. Under Part XV of the SFO, Mr. Wang is deemed to be interested in the Shares held by his spouse and company controlled by him.

Save as disclosed above, Mr. Wang does not have any other interest in the Shares within the meaning of Part XV of the SFO. Save as disclosed above, as at the Latest Practicable Date, Mr. Wang did not hold any directorships in any other public companies the securities of which are listed on any securities market in Hong Kong or overseas in the last three years and did not hold any other positions with the Company or other members of the Group.

Save as disclosed above, as at the Latest Practicable Date, Mr. Wang did not have any relationships with any of the Directors, senior management or substantial shareholders (within the meaning of the Listing Rules) or controlling shareholders (within the meaning of the Listing Rules) of the Company.

Pursuant to the service agreement entered into between Mr. Wang and the Company, the term of appointment for Mr. Wang is three years commencing on 11 July 2024 and shall determine upon expiry subject to renewal by mutual agreement between Mr. Wang and the Company prior thereto and in compliance with the Listing Rules. Mr. Wang’s directorship is subject to retirement by rotation and reelection at the annual general meeting of the Company in accordance with the Articles of Association. Under the service agreement, Mr. Wang is entitled to an annual emolument of HK\$7,140,000 for acting as the Chairman of the Company and an executive Director and a bonus for each financial year of the Company at the discretion of the Board. The annual emolument of Mr. Wang and his discretionary bonus would be determined with reference to various factors such as duties and level of responsibilities of Mr. Wang within the Group, the available information in respect of companies of comparable business or scale, the performance of Mr. Wang and the Group’s performance for the financial year concerned and the prevailing market conditions and based on the recommendation from the Remuneration Committee of the Company.

Save as disclosed in this circular, Mr. Wang is not aware of any other matters that need to be brought to the attention of the Shareholders nor is there any information that needs to be disclosed by the Company pursuant to any of the requirements under rule 13.51(2)(h) to (v) of the Listing Rules.

Mr. Jia Kun, aged 54, is an executive Director of the Company. He was appointed as an executive Director on 25th February, 2019. Mr. Jia graduated from Zhongnan University of Economics and Law (中南財經政法大學) (formerly known as Zhongnan University of Law (中南政法學院)) and Cheung Kong Graduate School of Business (長江商學院). Mr. Jia holds a bachelor of laws degree and an EMBA degree. Mr. Jia has several years of judicial, legal, risk management and administrative management experience. Mr. Jia previously served as head of office and chief executive officer of Henan Hezhong Group Company (河南和眾集團公司). Mr. Jia joined the Group in 2003 and currently serves as its executive president (執行總裁). Mr. Jia also serves as a director of certain other subsidiaries within the Group.

As at the Latest Practicable Date, Mr. Jia is beneficially interested in 7,055,031 Shares. Save as disclosed above, Mr. Jia does not have any other interest in the Shares within the meaning of Part XV of the SFO.

Save as disclosed above, as at the Latest Practicable Date, Mr. Jia did not hold any directorships in any other public companies the securities of which are listed on any securities market in Hong Kong or overseas in the last three years and did not hold any other positions with the Company or other members of the Group.

Save as disclosed above, as at the Latest Practicable Date, Mr. Jia did not have any relationships with any of the Directors, senior management or substantial shareholders (within the meaning of the Listing Rules) or controlling shareholders (within the meaning of the Listing Rules) of the Company.

Pursuant to the service agreement entered into between Mr. Jia and the Company, the term of appointment for Mr. Jia is three years commencing on 25 February 2025 and shall determine upon expiry subject to renewal by mutual agreement between Mr. Jia and the Company prior thereto and in compliance with the Listing Rules. Mr. Jia's directorship is subject to retirement by rotation and re-election at the annual general meeting of the Company in accordance with the Articles of Association. Under the service agreement, Mr. Jia is entitled to an annual emolument of HK\$3,100,000 for acting as an executive director and a bonus for each financial year of the Company at the discretion of the Board. The annual emolument of Mr. Jia and his discretionary bonus would be determined with reference to various factors such as duties and level of responsibilities of Mr. Jia within the Group, the available information in respect of companies of comparable business or scale, the performance of Mr. Jia and the Group's performance for the financial year concerned and the prevailing market conditions and based on the recommendation from the Remuneration Committee of the Company.

Save as disclosed in this circular, Mr. Jia is not aware of any other matters that need to be brought to the attention of the Shareholders in connection with his re-election nor is there any information that needs to be disclosed by the Company pursuant to any requirements under rule 13.51(2)(h) to (v) of the Listing Rules.

5. AGM

Whether or not you propose to attend the AGM, you are requested to complete the form of proxy in accordance with the instructions printed thereon and return the same to the branch share registrar of the Company in Hong Kong, Tricor Investors Services Limited, at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong as soon as possible but in any event not less than 48 hours before the time appointed for the holding of the AGM. Completion and return of the form of proxy will not preclude you from attending and voting at the AGM should you so wish.

6. VOTING BY POLL

Under Rule 13.39(4) of the Listing Rules, any vote of shareholders at a general meeting must be taken by poll. Accordingly, the resolutions proposed at the AGM will also be taken by poll. A poll results announcement will be published on the websites of the Company and the Stock Exchange after the AGM in accordance with Rule 13.39(5) of the Listing Rules. As at the Latest Practicable Date, to the knowledge of Directors, no Shareholder is required to abstain from voting under the Listing Rules in respect of any of the resolutions proposed at the AGM.

7. RESPONSIBILITY STATEMENT

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company. The Directors, having made all reasonable enquiries, confirm that to the best of their knowledge and belief the information contained in this circular is accurate and complete in all material respects and not misleading or deceptive, and there are no other matters the omission of which would make any statement herein or this circular misleading.

8. RECOMMENDATION

The Directors are of the opinion that the resolutions to be proposed at the AGM set out in the notice of the AGM set out on pages AGM-1 to AGM-5 of this circular, including the re-election of the retiring Directors and the grant of the General Mandates are in the best interests of the Company and the Shareholders as a whole and recommend the Shareholders to vote in favour of all the resolutions to be proposed at the AGM.

The Company's transfer books and register of members will be closed from Wednesday, 11th June 2025 to Thursday, 12th June 2025 (both days inclusive) for the purpose of ascertaining shareholders' entitlement to the proposed Final Dividend. APPENDIX I REPURCHASE MANDATE EXPLANATORY STATEMENT

This appendix is an explanatory statement given to all Shareholders relating to the resolution to be proposed at the AGM in relation to the Repurchase Mandate, which contains all the information required pursuant to Rule 10.06(1)(b) and other relevant provisions of the Listing Rules:

1. SHARE CAPITAL

As at the Latest Practicable Date, the Company has 2,771,795,157 Shares in issue.

Subject to the passing of ordinary resolution numbered 6 as set out in the notice of AGM set out on pages AGM-1 to AGM-5 of this circular and on the basis that no further Shares are issued or repurchased after the Latest Practicable Date and prior to the AGM, the Company would be allowed under the Repurchase Mandate to repurchase a maximum of 277,179,515 Shares representing slightly less than 10% of the number of issued Shares of the Company (excluding treasury shares, if any) as at the date of passing of the relevant resolution, during the period from the passing of the resolution until (i) the conclusion of the next annual general meeting of the Company after the AGM; (ii) the expiration of the period within which the next annual general meeting of the Company after the AGM is required by the Articles of Association or any applicable laws to be held; or (iii) the date of the revocation, variation or renewal of the Repurchase Mandate by ordinary resolution of the Shareholders in general meeting, whichever occurs first.

The Company may cancel such repurchased Shares or hold them as treasury shares, subject to market conditions and the Group's capital management needs at the relevant time of the repurchases. The Company may re-deposit its treasury shares into CCASS only if it has an imminent plan to resell or transfer these treasury shares on the Stock Exchange and will complete such resale or transfer as soon as possible. For any treasury shares deposited with CCASS pending resale on the Stock Exchange, the Company shall (i) procure its broker not to give any instructions to HKSCC to vote at general meetings of the Company for the treasury shares deposited with CCASS; and (ii) in the case of dividends or distributions, withdraw the treasury shares from CCASS, and either re-register them in its own name as treasury shares or cancel them, in each case before the record date for the dividends or distributions, or take any other measures to ensure that it will not exercise any Shareholders' rights or receive any entitlements which would otherwise be suspended under the applicable laws if those Shares were registered in its own name as treasury shares.

2. REASONS FOR REPURCHASES

The Directors believe that it is in the best interests of the Company and the Shareholders for the Directors to have general authority from Shareholders to enable the Company to repurchase Shares on the Stock Exchange. As at the Latest Practicable Date, the Directors have no present intention to exercise the Repurchase Mandate to repurchase any Shares. Repurchases of Shares will only be made when the Directors believe that such repurchase will benefit the Company and the Shareholders as a whole. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value of the Company and/or the earnings per Share.

3. FUNDING OF REPURCHASES

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with the memorandum and articles of association of the Company, the Listing Rules and the applicable laws of the Cayman Islands. The Company may not repurchase its own Shares on Main Board for a consideration other than cash or for settlement otherwise than in accordance with the trading rules of the Stock Exchange from time to time.

4. GENERAL

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the audited consolidated financial statements of the Group contained in the Annual Report) in the event that the Repurchase Mandate is exercised in full. However, the Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have any material adverse effect on the working capital requirements of the Company or on the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

6. EXERCISE OF REPURCHASE POWER

The Directors will exercise the power of the Company to make purchases pursuant to the Repurchase Mandate in accordance with the Listing Rules and the applicable laws of the Cayman Islands.
