Saved as disclosed above, the Company did not conduct any equity fund raising activities during the 12 months immediately preceding the date of this announcement.

REASONS FOR AND BENEFITS OF THE PLACING

The Group is principally engaged in designing, developing and commercializing surgical robots to assist surgeons in performing complex surgical procedures. The Group is the only global surgical robot company with its business covering the five major and fast-growing surgical specialties of laparoscopic, orthopedic, panvascular, natural orifice and percutaneous surgical procedures, and has accumulated several products at various stages as those in development, clinical trials, registration and commercialisation. Several surgical robot products of the Group have been approved and successfully entered the stage of commercialization in regions such as China, the United States and Europe, among which, the Toumai Laparoscopic Surgical Robot is the first domestically produced laparoscopic surgical robot to have obtained the CE Mark from EU. In the first year of commercialization in overseas markets, it not only expanded into emerging markets such as Asia, Africa, and Latin America, but also achieved a breakthrough in the high-end market in Europe, securing more than 20 overseas orders.

The Directors consider that the Placing represent an opportunity to raise capital for continuous optimization and iteration and future large-scale commercialisation in the global market of the products of the Group while broadening its Shareholders and capital base. The Directors are of the view that the Placing would strengthen the financial position of the Group and provide more efficient funding support to the Group.

The Directors consider that the terms of the Placing Agreement (including the Placing Price) are fair and reasonable and in the interests of the Company and the Shareholders as a whole.

USE OF PROCEEDS FROM THE PLACING
