BANKRUPTCY PETITION FILED AGAINST A DIRECTOR OF THE COMPANY

This announcement is made by the board (the “**Board**”) of directors (the “**Directors**” and each a “**Director**”) of Clarity Medical Group Holding Limited (the “**Company**”, which together with its subsidiaries are collectively referred to the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities (the “**Listing Rules**”) on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Future Ordinance (Chapter 571, Laws of Hong Kong).

The Company was informed that a bankruptcy petition (the “**Petition**”) was filed against Dr. Tse Wai Ip (“**Dr. Tse**”), an executive Director, by Ap China Unicorn Fund SPC (“**AP China**”) in the High Court of The Hong Kong Special Administrative Region. The hearing for the Petition is scheduled for 3 June 2025.

The Petition is a private matter between Dr. Tse and AP China. The Company is not a party to this Petition and bears no liability in connection with the Petition.

To the best knowledge, information and belief of the Directors after all reasonable enquiries, save as disclosed above, there is no other matter in relation to the directorship of Dr. Tse with the Company that needs to be brought to the attention of the shareholders of the Company.

As at the date of this announcement, to the best knowledge, information and belief of the Board after all reasonable enquiries, the Board is not aware of any material adverse effect on the business, operations or financial conditions of the Group as a result of the Petition.

The Company will continuously follow up on the progress of the Petition and will make further announcement(s) on the matter set out in this announcement to update the shareholders and potential investors of the Company as and when appropriate.

Shareholders of the Company and potential investors should exercise caution when dealing in the shares of the Company.
