On 30 December 2024 and 15 April 2025, the Exchange gave HSBC consent under Rule 10.06(3) for the issue of new contingent convertible securities, where such issuances would occur within a period of 30 days after any purchase of Shares made under the Buyback on the Hong Kong Stock Exchange and the UK Venues respectively as announced on 6 May 2025. Subject to the aforementioned consent, the moratorium period shall be up to the date as stated above.
