#### **INTRODUCTION**

The purpose of this circular is to provide you with information reasonably necessary to enable you to make a decision on whether to vote for or against the ordinary resolutions to be proposed at the AGM which will be convened for the purpose of considering and, if thought fit, approving (*inter alia*):

- (a) the grant of the Share Issue Mandate, Repurchase Mandate and Extension Mandate to the Directors; and
- (b) the re-election of the retiring Directors.

# PROPOSED GRANT OF THE SHARE ISSUE MANDATE, REPURCHASE MANDATE AND EXTENSION MANDATE

At the last annual general meeting of the Company held on 15 July 2024, the Directors were granted a general mandate to allot, issue and deal with Shares and a general mandate to repurchase Shares. These general mandates will expire at the conclusion of the forthcoming AGM on 14 July 2025. The Directors propose to seek the approval of the Shareholders at the AGM by way of passing ordinary resolutions for granting:

- (1) the Share Issue Mandate to allot, issue and deal with Shares up to a maximum of 20% of the Shares in issue as at the date of passing of the relevant resolution;
- (2) the Repurchase Mandate to repurchase Shares up to a maximum of 10% of the Shares in issue as at the date of passing of the relevant resolution; and
- (3) the Extension Mandate to increase the number of Shares to be issued and allotted under the Share Issue Mandate by an additional number representing such number of Share (if any) to be repurchased under the Repurchase Mandate.

As at the Latest Practicable Date, the total issued share capital of the Company was 705,895,060 Shares. Assuming there is no issue of Shares or repurchase of Shares from the Latest Practicable Date up to the date of the AGM, the number of Shares that can be issued under the Share Issue Mandate and that can be purchased by the Company under the Repurchase Mandate will be 141,179,012 Shares and 70,589,506 Shares respectively, representing 20% and 10% of the issued share capital of the Company as at the date of the AGM respectively. An explanatory statement required by the Listing Rules in connection with the proposed ordinary resolution on the Repurchase Mandate is set out in the Appendix to this circular.

Each of the Share Issue Mandate, the Repurchase Mandate and the Extension Mandate, if approved, will continue in force until the earliest of: (a) the conclusion of the next annual general meeting of the Company following the AGM; or (b) the end of the period within which the Company is required by the Bye-laws or any applicable laws of Bermuda to hold its next annual general meeting; or (c) the revocation or variation of the authority given under such resolution by an ordinary resolution of the Shareholders in a general meeting of the Company prior to the next annual general meeting of the Company following the AGM.

The Directors wish to state that they have no immediate definitive plans to issue any new Shares pursuant to the Share Issue Mandate or to repurchase any Shares pursuant to the Repurchase Mandate.

#### **PROPOSED RE-ELECTION OF DIRECTORS**

At the AGM, Mr. James Ngai ("**Mr. Ngai**") and Mr. Leung Wai Ki, George ("**Mr. Leung**") shall retire from office by rotation in accordance with Bye-law 87 of the Bye-laws. All the abovementioned Directors, being eligible, will offer themselves for re-election as Directors of the Company at the forthcoming AGM.

In reviewing the structure, size and composition of the Board and in proposing individuals for re-election as Directors at the AGM, the Nomination Committee considered the Board diversity from a number of aspects, including but not limited to gender, age, educational background, professional experience, skills, knowledge, industry experience and expertise. The candidates identified were considered against criteria including character and integrity, business experience, compliance, willingness to devote sufficient time to discharge duties, diversity, contribution to the Board, and independence as may be necessary for the operation of the Board as a whole, with a view to maintaining a sound balance of the Board's composition.

Notwithstanding that Mr. Leung has served as an independent non-executive Director of the Company for more than 10 years, the Nomination Committee is satisfied that he remains independent in discharging his duties as required by the Listing Rules. In reviewing his performance and attendance records on serving the Board and various committees in the past, it has demonstrated that he always gives impartial advice and exercises independent judgement on different issues of the Company. Mr. Leung, possessing different levels of knowledge and experience, also brings invaluable diversity and perspectives to the Board.

Furthermore, the Nomination Committee has assessed and reviewed the annual written confirmation of Mr. Leung based on the independent guidelines as set out in Rule 3.13 of the Listing Rules and confirmed that he remains independent. As Mr. Leung comes from a different profession and has over 30 years of experience in accounting, financial management, auditing and

receivership, he adds invaluable diversity to the Board and provides a different perspective and valuable contribution to the Board on business, accounting and internal control matters of the Group. The Nomination Committee believes that his in-depth knowledge and experience of the Group's business and his external experience continue to be of significant benefit to the Company, and that he maintains an independent view of its affairs.

In view of the above, the Board believes that the re-election of the retiring Directors as Directors is in the best interest of the Company and Shareholders as a whole, and therefore recommends the re-election of the retiring Directors to the Shareholders at the AGM. As a good corporate governance practice, each of the retiring Directors has abstained from voting at the relevant Board meeting on the respective propositions of their recommendations for re-election by the Shareholders at the AGM.

The biographical information of Mr. James Ngai and Mr. Leung are as follows:

James Ngai, aged 62, joined the Group in March 2011. He is a Non-Executive Director of the Company, the Chairman of the Board and a member of the Remuneration Committee and the Nomination Committee. He is responsible for the Group's leadership and management of the Board and the Group's strategy. Mr. Ngai graduated from University of Toronto with a Bachelor's degree in Economics. He is a Certified Public Accountant (Practising) in Hong Kong and a member of Hong Kong Institute of Certified Public Accountants and American Institute of Certified Public Accountants. He is also a fellow member of The Taxation Institute of Hong Kong. He has over 30 years of experience in accounting, auditing and taxation matters. Mr. Ngai is a director of an accounting firm which provides advisory and audit services to private companies owned by Mr. Lee Tze Bun, Marces ("Mr. Lee"), a controlling shareholder of the Company. In addition, both Mr. Ngai and Mr. Lee are directors of Stable Gain Holdings Limited which has an interest in the Shares which would fall to be disclosed to the Company under the provisions of Divisions 2 and 3 of Part XV of the SFO. Mr. Ngai is also an independent non-executive director of Max Sight Group Holdings Limited, the shares of which are listed on the Stock Exchange (stock code: 08483).

The Company entered into a service agreement with Mr. Ngai for a fixed term of 2 years commencing on 25 March 2025 and ending on 24 March 2027, and Mr. Ngai is subject to retirement by rotation and re-election at annual general meeting of the Company at least once every three years in accordance with the Bye-laws. The said service agreement may be terminated by either party by giving three-months' written notice or in accordance with other terms thereof. Mr. Ngai is entitled to receive a director's fee, which was determined and approved by the Board according to the prevailing market rate and the remuneration policy of the Company and which is subject to review by the Remuneration Committee each year. All additional remuneration (such as bonus) which may be given to Mr. Ngai (if any) shall be determined and approved by the

Remuneration Committee based on the remuneration policy of the Company. The Company has no intention of giving any such additional remuneration to Mr. Ngai as it has never provided to any Non-Executive Director any remuneration other than the annual director's fee. During the financial year ended 28 February 2025, Mr. Ngai received a director's fee of HK\$180,000.

Save as disclosed above, as at the Latest Practicable Date, (a) Mr. Ngai did not hold any directorships in any other listed public companies in the past three years; (b) he does not have any relationship with any other Directors, senior management or substantial or controlling shareholders of the Company; (c) he does not have any interests in Shares, underlying Shares and debentures of the Company and/or its associated corporations (within the meaning of Part XV of the SFO); (d) there is no other information which is discloseable pursuant to Rule 13.51(2)(h) to 13.51(2)(v) of the Listing Rules; and (e) there are no other matters that need to be brought to the attention of the Shareholders.

Leung Wai Ki, George, aged 67, joined the Group in September 2004. He is an Independent Non-Executive Director of the Company and a member of the Audit Committee, Remuneration Committee and Nomination Committee. Mr. Leung has over 30 years of experience in accounting, financial management, auditing and receivership. He is also a director and financial controller of a real estate development company in Hong Kong.

The Company entered into a service agreement with Mr. Leung for a fixed term of 2 years commencing on 1 November 2023 and ending on 31 October 2025, and Mr. Leung is subject to retirement by rotation and re-election at annual general meeting of the Company at least once every three years in accordance with the Bye-laws. The service agreement may be terminated by either party by giving three-months' written notice or in accordance with other terms thereof. Mr. Leung is entitled to receive a director's fee, which was determined and approved by the Board according to the prevailing market rate and the remuneration policy of the Company and which is subject to review by the Remuneration Committee each year. All additional remuneration (such as bonus) which may be given to Mr. Leung (if any) shall be determined and approved by the Remuneration of giving any such additional remuneration to Mr. Leung as it has never provided to any independent non-executive Director any remuneration other than the annual director's fee. During the financial year ended 28 February 2025, Mr. Leung received a director's fee of HK\$180,000.

As at the Latest Practicable Date, Mr. Leung was a governor of Xin Chuan Middle School Foundation Limited, which held 1,700,000 Shares representing approximately 0.24% of the issued share capital of the Company. Therefore, for the purpose of Part XV of the SFO, Mr. Leung was deemed to be interested in these Shares.

Save as disclosed above, as at the Latest Practicable Date, (a) Mr. Leung did not hold any directorships in any other listed public companies in the past three years; (b) he does not have any relationship with any other Directors, senior management or substantial or controlling shareholders of the Company; (c) he does not have any other interests in Shares, underlying Shares and debentures of the Company and/or its associated corporations (within the meaning of Part XV of the SFO); (d) there is no other information which is discloseable pursuant to Rule 13.51(2)(v) of the Listing Rules; and (e) there are no other matters that need to be brought to the attention of the Shareholders.

Save and except Ms. Chan Kit Yin, all of the independent non-executive Directors have served the Company for more than nine years. The lengths of their tenure are set out below:

Accordingly, the voting on all the resolutions to be put forward at the AGM will be conducted by way of poll. The Company will appoint scrutineers to handle vote-taking procedures at the AGM. The results of the poll will be published on the respective websites of the Stock Exchange and the Company as soon as possible after the AGM in accordance with Rule 13.39(5) of the Listing Rules.

#### **RESPONSIBILITY STATEMENT**

This circular includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company. The Directors collectively and individually accept full responsibility for the accuracy of the information contained in this circular and confirm, having made all reasonable enquiries that to the best of their knowledge and belief, there are no other facts the omission of which would make any statement herein misleading.

#### RECOMMENDATION

The Board believes that the proposed ordinary resolutions for approval of (a) the grant of the Share Issue Mandate, Repurchase Mandate and Extension Mandate; and (b) the re-election of the retiring Directors are each in the best interests of the Company and the Shareholders as a whole. Accordingly, the Board recommends you to vote in favour of all the ordinary resolutions to be proposed at the AGM.

This Appendix serves as an explanatory statement as required by the Listing Rules to provide the requisite information to you for your consideration of the Repurchase Mandate.

#### SHARE CAPITAL

As at the Latest Practicable Date, the authorised share capital of the Company was HK\$100,000,000 divided into 1,000,000,000 Shares, among which a total of 705,895,060 Shares were issued and fully paid-up, and the Company did not have any treasury share. Subject to the passing of the relevant ordinary resolution at the AGM approving the Repurchase Mandate and assuming that no further Shares will be issued or repurchased by the Company on or prior to the date of the AGM, the Company will be allowed to repurchase up to 70,589,506 Shares pursuant to the Repurchase Mandate.

#### **REASONS FOR REPURCHASES**

The Directors believe that it is in the best interests of the Company and the Shareholders as a whole to seek general authority from the Shareholders to enable the Directors to repurchase Shares in the market at any appropriate time. Such repurchases of Shares may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value and/or earnings per Share of the Company and will only be made when the Directors believe that such repurchases will benefit the Company and the Shareholders as a whole.

#### FUNDING OF REPURCHASES

In repurchasing Shares, the Company must apply funds legally available for such purpose in accordance with the Bye-laws and the laws of Bermuda. Under the laws of Bermuda, the amount of capital paid by the Company in connection with a Share repurchase may only be paid out of either the capital paid up on the relevant Shares, or the funds of the Company that would otherwise be available for distribution by way of dividend or distribution or the proceeds of a new issue of Shares made for such purpose. The amount of premium payable on a repurchase of Shares by the Company may only be paid out of either the funds of the Company that would otherwise be available for distribution or out of the share premium account of the Company. Under the laws of Bermuda, the Shares so repurchased will be treated as cancelled but the aggregate amount of the authorised share capital of the Company will not be reduced so that the Shares may be subsequently re-issued.

The Stock Exchange published its consultation conclusions on "Proposed Amendments to Listing Rules Relating to Treasury Shares" on 12 April 2024 and the relevant amendments to the Listing Rules ("Amendments") came into effect on 11 June 2024. The Company would like to observe the development of market practices and regulatory guidance before taking benefits from

the flexibility provided under the Amendments. Hence, the Company's present intention is that any Shares bought back under the Repurchase Mandate would be cancelled rather than being held as treasury shares. If there is any deviation from this intention statement, the Company will provide its reasons in the next day disclosure return and ensure compliance with the Listing Rules and the laws of Bermuda.

Taking into account the current working capital position of the Company, the Directors consider that, if the Repurchase Mandate were to be exercised in full, it might have a material adverse effect on the working capital and/or the gearing position of the Company as compared with the position disclosed in the audited consolidated financial statements of the Company in the annual report for the year ended 28 February 2025. However, the Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements or the gearing levels of Company which are in the opinion of the Directors from time to time appropriate for the Company.

## DIRECTORS, THEIR ASSOCIATES AND CONNECTED PERSONS

None of the Directors nor, to the best of their knowledge and belief having made all reasonable enquiries, any of their close associates (as defined in the Listing Rules) currently intends to sell Shares to the Company in the event that the Repurchase Mandate is granted by the Shareholders at the AGM.

No core connected person (as defined in the Listing Rules) of the Company has notified the Company that he/she has a present intention to sell any Shares to the Company, or has undertaken not to sell any Shares held by him to the Company, in the event that the Repurchase Mandate is granted by the Shareholders at the AGM.

#### SHARE REPURCHASE MADE BY THE COMPANY

The Company has not repurchased any Shares (whether on the Stock Exchange or otherwise) during the six months preceding the Latest Practicable Date.

#### DIRECTORS' UNDERTAKING

The Directors have undertaken to the Stock Exchange to exercise the power of the Company to make repurchases of Shares pursuant to the Repurchase Mandate in accordance with the Listing Rules and the laws of Bermuda.

#### CONSEQUENCES UNDER THE TAKEOVERS CODE

If, on the exercise of the power by the Company to repurchase Shares pursuant to the Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of the Takeovers Code. As a result, a Shareholder or a group of Shareholders acting in concert (as defined in the Take overs Code), depending on the level of such increase in the Shareholders' interest, could obtain or consolidate control of the Company and may become obliged to make a mandatory offer in accordance with Rules 26 and 32 of the Takeovers Code.

As at the Latest Practicable Date, according to the register of interests required to be kept by the Company under the SFO, the Shareholders who were interested in 5% or more of the issued share capital of the Company were as follows:

- 1. Mr. Lee personally held 54,561,000 Shares. Mr. Lee is beneficially interested in 100% of the issued share capital of Succex Limited which held 33,000,000 Shares. Mr. Lee was a founder and governor of Qing Yun Middle School Education Development Foundation Limited, which held 3,600,000 Shares. Therefore, Mr. Lee was deemed to be interested in the foregoing 36,600,000 Shares. Further, Mr. Lee is a founder and eligible beneficiary of the Lee Tze Bun Family Trust, of which HSBC International Trustee Limited ("HSBC Trustee") acts as a trustee. HSBC Trustee via its wholly-owned subsidiary, Stable Profit Holdings Limited, wholly owns Stable Gain Holdings Limited which held 225,500,000 Shares. The Lee Keung Charitable Foundation, of which Mr. Lee is the founder, held 55,000,000 Shares, representing approximately 7.79% of the issued share capital of the Company. Therefore, Mr. Lee was deemed to be interested in an aggregate of 371,661,000 Shares.
- 2. Ms. Lee is the daughter of Mr. Lee and personally held 6,985,000 Shares as beneficial owner.
- 3. Ms. Lee, Mr. Li and Ms. Cheung jointly held 55,000,000 Shares as trustees of The Lee Keung Charitable Foundation, so all of them were deemed to be interested in these Shares.
- 4. Mr. Li is the son of Mr. Lee and personally held 5,909,200 Shares as beneficial owner. He was interested in 11,000 Shares held by his spouse as beneficial owner.
- 5. Ms. Cheung is the daughter-in-law of Mr. Lee and was interested in 2,585,000 Shares held by her spouse as beneficial owner.

To the best of the knowledge and belief of the Directors, Mr. Lee, being a controlling Shareholder, was interested in 371,661,000 Shares, representing approximately 52.65% of the issued share capital of the Company as at the Latest Practicable Date. In the event that the Directors exercised in full the power to repurchase Shares which is proposed to be granted pursuant to the Repurchase Mandate, the interests of Mr. Lee in the Company would be increased to approximately 58.50% of the issued share capital of the Company. Such increase would not give rise to an obligation on Mr. Lee to make a mandatory offer under Rules 26 and 32 of the Takeovers Code. In any event, the Directors have no present intention to repurchase Shares to such extent. In the event that the Repurchase Mandate is exercised in full, the number of Shares held by the public would not fall below 25% of the issued share capital of the Company, being the relevant minimum prescribed percentage for the Company as required by the Stock Exchange.

Save as disclosed above, the Directors are currently not aware of any consequences which will arise under the Takeovers Code as a result of any purchase made under the Repurchase Mandate.
