UNAUDITED OPERATING FIGURES FOR THE MONTH ENDED 31 MAY 2025

The board of directors (the “Board”) of China Resources Land Limited (the “Company”) hereby announces that for the month ended 31 May 2025, the Company and its subsidiaries (the “Group”) achieved gross contracted sales of approximately RMB18.35 billion with contracted GFA of approximately 0.649 million square meters, down 11.4% and 26.6% YoY respectively. For the first five months of the year, gross contracted sales achieved approximately RMB86.85 billion with contracted GFA of approximately 3.222 million square meters, down 6.3% and 19.0% YoY respectively.

In May 2025, the Group's recurring revenue was approximately RMB4.09 billion, up 6.2% YoY. Among which, the rental income from investment property business was RMB2.69 billion, up 13.0% YoY. For the first five months of the year, the cumulated recurring revenue reached approximately RMB20.44 billion, up 9.6% YoY, of which, the cumulated rental income from investment property business amounted to RMB13.28 billion, up 12.9% YoY.

The preliminary figures disclosed above are derived from the Group’s internal management records and subject to change and may differ from those appear in the audited and unaudited financial statements of the Group to be published on yearly and half-yearly basis.
