POSITIVE PROFIT ALERT

This announcement is made by Crown International Corporation Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) pursuant to the provisions of inside information under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong) and Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

The board (the “**Board**”) of directors (the “**Directors**”) of the Company would like to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on the preliminary assessment of the Board with reference to the unaudited consolidated management accounts of the Group for the year ended 31 March 2025 (“**the Current Year**”) and other information currently available to the Board, the Group would record consolidated profit attributable to the Shareholders for the Current Year in the range of between HK\$15 million and HK\$25 million while there was consolidated loss attributable to the Shareholders of approximately HK\$127 million for the year ended 31 March 2024 (“**the Last Year**”). Such consolidated profit attributable to the Shareholders in the Current Year was mainly due to the reduction in finance cost from HK\$47 million in the Last Year to HK\$ Nil in Current Year and the reduction from loss on disposal of subsidiaries amounted to HK\$101 million in the Last Year as compared to HK\$Nil in Current Year.

The Company is still in the process of finalising the Group’s annual results for the Current Year. The information contained in this announcement is only based on a preliminary review of the unaudited consolidated management accounts of the Group for the Current Year which have not been audited or reviewed by the external auditors of the Company. Shareholders and potential investors are advised to read carefully the unaudited annual results announcement of the Company for the year ended 31 March 2025 which will be published on 27 June 2025.

Further announcements will be made by the Company if there is any significant change in the expected financial results of the Group as disclosed in this announcement.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
