PROFIT WARNING

This announcement is made by Far East Hotels and Entertainment Limited (the “Company”), and together with its subsidiaries (the “Group”), pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “Board”) wishes to inform the shareholders and potential investors of the Company that the annual results of the Group for the year ended 31 March 2025 (the “Year”) are expected to record a net loss ranging from approximately HK\$33 million to HK\$37 million, compared to a net loss of approximately HK\$33 million for the year ended 31 March 2024.

Based on the information currently available, the Group’s expected net loss for the Year as compared above was primarily due to (i) a decline in revenue from hotel operation in Hong Kong and serviced property letting in Mainland China; and (ii) a decrease in fair value of the Group’s investment properties.

The Company is still in the process of finalizing the annual results of the Group for the Year. The information contained in this announcement is only based on preliminary assessment made by the Board with reference to the unaudited financial information of the Group for the Year, which is subject to adjustments as appropriate and further review by the Company and its independent auditor. Shareholders and potential investors are advised to read carefully the annual results announcement of the Company for the Year for further details, which is expected to be announced by the end of June 2025.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.
