RESIGNATION OF INDEPENDENT NON-EXECUTIVE DIRECTOR UPON EXPIRY OF TERM OF OFFICE

Guolian Minsheng Securities Company Limited (the “**Company**”) would like to announce that the board of directors (the “**Board**”) of the Company received a written resignation letter from Mr. Chu, Howard Ho Hwa, an independent non-executive director, on 26 June 2025. Pursuant to the Measures for the Administration of Independent Directors of Listed Companies (《上市公司獨立董事管理辦法》) and other regulations, Mr. Chu, Howard Ho Hwa has tendered his resignation as an independent non-executive director, a member of the Strategy and ESG Committee and the Audit Committee under the Board of the Company as he has served six years consecutively.

Mr. Chu, Howard Ho Hwa has confirmed that he has no disagreement with the Company and the Board, and there is no matter relating to his resignation that needs to be brought to the attention of the shareholders and creditors of the Company.

Pursuant to the relevant provisions of the Measures for the Administration of Independent Directors of Listed Companies and the Articles of Association, as the resignation of Mr. Chu, Howard Ho Hwa will cause the proportion of independent non-executive directors of the Company to fall below one-third of the members of the Board, Mr. Chu, Howard Ho Hwa will continue to perform his duties as an independent non-executive director and as a member of the special committees under the Board until the date on which a new independent non-executive director is elected. The Company will complete the by-election of independent non-executive director as soon as possible in accordance with the relevant regulations.

During the tenure of Mr. Chu, Howard Ho Hwa as an independent non-executive director of the Company, he has performed his duties with dedication and diligence. The Board would like to express its sincere gratitude to Mr. Chu, Howard Ho Hwa for his contributions to the development of the Company during his term of office.
