Reference is made to the announcements of HKE Holdings Limited (the "Company") dated 28 January 2025, dated 11 February 2025 and dated 19 February 2025 (the "Announcements") in relation to the issue of the Convertible Bond (the "Convertible Bond"). On 28 January 2025, the Company and the Subscriber entered into the Subscription Agreement, pursuant to which the Company has conditionally agreed to issue and the Subscriber has conditionally agreed to subscribe for the Convertible Bond in an aggregate principal amount of HK\$26million at the initial Conversion Price of HK\$2.50 per Conversion Share (subject to adjustment events for the conversion price as set out in the Announcements). On 11 February 2025, the Company provided further information regarding the issue of the Convertible Bond to the shareholders and potential investors. Completion of the subscription and issuance of the Convertible Bonds took place on 19 February 2025. Based on the initial conversion price of HK\$2.50, a maximum of 10,400,000 conversion shares will be allotted and issued upon full conversion of the Convertible Bond. The conversion shares will be alloted and issued under the general mandate granted by the shareholders of the Company at the annual general meeting held on 27 November 2024.
