**ANNOUNCEMENT ON UNAUDITED OPERATING DATA
FOR THE SECOND QUARTER OF
THE THREE MONTHS ENDED 30 JUNE 2025 AND
THE HALF YEAR ENDED 30 JUNE 2025**

This announcement is voluntarily made by Dynagreen Environmental Protection Group Co., Ltd.* (the “**Company**”, together with its subsidiaries, the “**Group**”).

The board of directors (the “**Board**”) of the Company is pleased to announce that the unaudited waste input volume, electricity generation volume, on-grid electricity volume and steam supply volume of the Group amounted to 3,715,700 tons, 1,303,044,000 kWh, 1,081,894,600 kWh and 290,400 tons respectively in the second quarter of the three months ended 30 June 2025. For the half year ended 30 June 2025, the unaudited accumulated waste input volume of the Group amounted to 7,154,300 tons, representing a year-on-year increase of 2.10%; the accumulated electricity generation volume was 2,539,179,700 kWh, representing a year-on-year increase of 1.62%; the accumulated on-grid electricity volume was 2,113,307,500 kWh, representing a year-on-year increase of 1.99%; and the accumulated steam supply volume amounted to 515,500 tons, representing a year-on-year increase of 115.69%.
