**SUPPLEMENTAL ANNOUNCEMENT IN RELATION TO THE
ANNUAL REPORT FOR THE YEAR ENDED 31 DECEMBER 2024**

Reference is made to the annual report (the “**Annual Report**”) of South China Vocational Education Group Company Limited (the “**Company**”) for the year ended 31 December 2024 published on 30 April 2025. Unless otherwise defined, capitalized terms used in this announcement shall have the same meanings as those defined in the Annual Report.

As disclosed in the Annual Report, in light of the Audit Issue, the Group plans to implement new measures (the “**New Measures**”) to collect and retain sufficient documentary evidence to prove that the services were delivered by the vendors according to the contractual terms in the event that third party service providers are engaged to provide marketing and promotion service for student recruitment.

The Company would like to provide further details of the New Measures as follows:

Measures	Time/Frequency
(i) Requiring the vendors to provide full records of working plans in connection with their provision of services.	After each vendor is engaged for the relevant services
(ii) Requiring the staff of recruitment office to prepare plans of supervision on the vendors’ provision of services according to their working plans, and retaining the records for such supervision.	After each vendor is engaged for the relevant services
(iii) Increasing the frequency of onsite supervision and <i>ad hoc</i> checks on the provision of services by the vendors.	At least once a month until the relevant service period expires

Measures	Time/Frequency
(iv) Requiring the staff of recruitment office to keep written records of communication with the vendors with respect to the confirmation on results of the provision of services.	During the confirmation process for the relevant services
(v) Keeping written records of reconciliation between the result of the services performed by the vendors with the service fees paid in accordance with the contract terms.	During the reconciliation process for the relevant services
(vi) Taking pictures of vendors' work.	During the onsite supervision and <i>ad hoc</i> checks
(vii) Arranging periodic meetings with the vendors to discuss the status of the provision of services.	Once a month until the relevant service period expires

As of the date of this announcement, all the New Measures have been implemented by the Group.

The Board is of the view that the internal control of the Group, after implementing the New Measures, is adequate and effective to address the Audit Issue.
