PROFIT WARNING

This announcement is made by AuGroup (SHENZHEN) Cross-Border Business Co., Ltd. (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of the Company (the “**Board**”) hereby notifies the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on the preliminary assessment of the Group’s unaudited consolidated management accounts for the six months ended 30 June 2025 (the “**Reporting Period**”) and other information currently available, the Group’s net profit attributable to the parent company for the Reporting Period is expected to be between RMB100 million and RMB130 million, representing a decline of between 50% to 62% as compared with that of the corresponding period in 2024, primarily attributable to:

1. in terms of the sales of goods business, tariff policy adjustments during the Reporting Period, combined with rising logistics costs, led to a significant increase in overall costs;
2. in the logistics solutions business, due to the addition of leased warehouses by the end of 2024 and the first half of 2025, the growth in relevant income has not yet fully realized; however, relevant operating costs have risen significantly due to the commencement of amortization of the related right-of-use assets, resulting in a decrease in net profit;
3. the Group’s strategic incubation projects are still in the early stages with high investment costs, which have diluted overall profits.

The Company is in the process of finalising the Group’s 2025 interim results. The information contained in this announcement is only based on the Board’s preliminary assessment in accordance with the unaudited consolidated management accounts of the Group and other information currently available and has not been audited or reviewed by the independent auditors and the audit committee of the Company. Therefore, the Group’s 2025 actual interim results may differ from the information contained in this announcement. Shareholders and potential investors are advised to refer to the details of the announcement of the Group’s 2025 interim results, which is expected to be published by end of August 2025.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
