**POSITIVE PROFIT ALERT
FOR THE SIX MONTHS ENDED JUNE 30, 2025**

This announcement is made by GUSHENGTANG HOLDINGS LIMITED (the “**Company**”, together with its subsidiaries and consolidated affiliated entities, the “**Group**”) pursuant to the Inside Information Provisions (as defined under the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”)) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09(2)(a) of the Listing Rules.

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors of the Company that based on the information currently available and a preliminary review of the unaudited consolidated management accounts of the Group for the six months ended June 30, 2025 (“**1H2025**”), it is expected that the Group will record (a) a revenue for 1H2025 in the range of approximately RMB1,474 million to RMB1,529 million as compared with the revenue for the six months ended June 30, 2024 (“**1H2024**”) of RMB1,365.0 million, representing an increase by approximately 8% to 12%; (b) a net profit for 1H2025 in the range of approximately RMB149 million to RMB155 million as compared with the net profit for 1H2024 of RMB107.3 million, representing an increase by approximately 39% to 44%; and (c) an adjusted net profit for 1H2025 in the range of RMB167 million to RMB175 million as compared with the adjusted net profit for 1H2024 of RMB147.9 million, representing an increase by approximately 13% to 18%.

Based on the information currently available to the Board, the Board believes that the increase in revenue, net profit and adjusted net profit (as defined by the Group as the net profit eliminating the effect of equity-settled share-based payment in relation to (i) the share options granted under the pre-IPO share option plan approved and adopted by the Company on March 31, 2021, (ii) the share awards granted under the restricted share award scheme (existing shares) adopted by the Board on September 9, 2022, and (iii) the share options and share awards granted under the share option scheme and the restricted share award scheme (new shares), respectively, both adopted by the Company on December 7, 2022 (the “**Adjusted Items**”)) were primarily due to the increase in customer visits to our medical institutions, which is attributable to the wide-recognition of our “GUSHENGTANG” brand resulting from our continuous effort on providing comprehensive and excellent traditional Chinese medicine healthcare services; and our business expansion including the increase in the number of physicians and the growth in the number and geographic coverage of medical institutions.

The Board wishes to highlight that “adjusted net profit” is not defined under the HKFRS Accounting Standards. The Board believes that the “adjusted net profit” would provide useful information to potential investors and others in understanding and evaluating the operating results of the Group by eliminating the effect of the Adjusted Items, which is non-operating in nature and is not indicative of the actual operating performance of the Group.

As the Company is still in the process of finalizing the results for 1H2025, the information contained in this announcement is based on the management’s preliminary review of the unaudited consolidated management accounts of the Group and information currently available to the Board for 1H2025, which has neither been reviewed or audited by the auditors of the Company, nor reviewed by the audit committee of the Board. Shareholders and potential investors of the Company are advised to read carefully the interim results announcement of the Company for 1H2025, which is expected to be published by August 2025.

Shareholders and potential investors are advised to exercise caution when dealing in the securities of the Company.
