The Subscription Shares of 19,063,898 new Shares represent approximately 20.00% of the existing issued shares of the Company and approximately 15.89% of its enlarged Shares. The Subscription Shares will be issued under the General Mandate and will rank equally with all existing Shares.

The gross proceeds from the issue of Subscription Shares are expected to be approximately HK\$11,438,000 and the net proceeds from the issue of Subscription Shares (after deducting of expenses) will be approximately HK\$11,300,000. The Group is operating a terrestrial UHF wireless television network providing digital media, entertainment and similar multimedia service platform in the United States of America.

In view of the current market conditions, the Directors consider the Subscription represents a good opportunity to strengthen the financial position and general working capital of the Company.

The Directors consider the terms of the Subscription Agreements are on normal commercial terms and are fair and reasonable based on the current market conditions and these are in the interests of both the Company and its Shareholders as a whole.
