VOLUNTARY ANNOUNCEMENT SHARE REPURCHASE

This announcement is made by Sihuan Pharmaceutical Holdings Group Ltd. (the “**Company**” or “**Sihuan Pharmaceutical**”, together with its subsidiaries, the “**Group**”) on a voluntary basis.

The board of directors of the Company (the “**Board**”) hereby announces that it intends to exercise its powers under the general mandate (the “**Repurchase Mandate**”) to repurchase shares of the Company granted by the shareholders of the Company at the annual general meeting held on 6 June 2025 to repurchase shares in the open market at appropriate timing.

The Board further announces that, on 15 October 2025, the Company repurchased, pursuant to the Repurchase Mandate, a total of 10,000,000 shares of the Company on market at an average price of HK\$1.5189 per share (the “**Share Repurchase**”). The aggregate purchase price paid (excluding commission and other expenses) for the Share Repurchase was approximately HK\$15,189,000. The repurchased shares represent approximately 0.1089% of the total number of issued shares (excluding treasury shares) of the Company as at the date of this announcement. The Company subsequently intended to hold the repurchased shares as treasury shares, and to use such treasury shares for subsequent sale or transfer.

The Board believes that the implementation of the Share Repurchase is in the interests of the Company and its shareholders as a whole. Sihuan Pharmaceutical has always been committed to achieving the strategic goal of becoming a leading medical aesthetics and biopharmaceutical enterprise in China. The Company has made several positive business progresses in its new businesses of medical aesthetics and innovative pharmaceuticals. The Company's carefully incubated medical aesthetics platform, Meiyang Space, has evolved into a leading medical aesthetic company in China. It is a comprehensive integrated platform encompassing research, production and marketing, with a pipeline of more than 60 medical aesthetic products, covering the needs of the whole life cycle of beauty lovers. For the six months ended 30 June 2025, revenue of the Group's medical aesthetic business segment was approximately RMB585 million, increasing approximately 81% year-on-year. In addition, the innovative drug R&D of the Group has entered a harvest period. For the nine months ended 30 September 2025, the Group has obtained approval for the market launch of a total of 15 new medical aesthetic products and drugs, including a total of 3 medical aesthetic products including self-developed Class III medical device flagship product PLLA filler (Trade Name: Huiyanyan, Sifuyan), PCL filler (Trade Name: Qingyan) and a composite solution skin booster containing L-Carnosine (Trade Name: Dongyan), as well as a total of 12 new drugs including Class 1 innovative drug Bireociclib Tablets (Trade Name: Xuan Yue Ning) and Dirozalciclib Tablets (Trade Name: Xuan Fei Ning). The Group expects that the simultaneous launch of such a large number of flagship new products will bring strong momentum to the Group's future revenue and profit growth. The Group holds great confidence in the Company's future development prospects.
