Explanation on reasons for retrospective adjustment or restatement

- During the Reporting Period, the Company had a business combination under common control, and therefore, in accordance with the relevant requirements of the Accounting Standards for Business Enterprises No. 33 – Consolidated Financial Statements, the Company included the consolidated entity, Wuxi Xindong Semiconductor Technology Co., Ltd.* (無錫芯動半導體科技有限公司), into the scope of the Company's consolidated statements for the Current Period, and retrospectively adjusted the data as at the beginning of the Reporting Period and for the corresponding period last year.
- The Ministry of Finance issued the Interpretation No. 18 of the Accounting Standards for Business Enterprises in December 2024, the Article 2 of which provides that for the assurance-type warranties which are not separate performance obligations, the amount of provisions determined shall be credited to "principal operating costs" or "other operating costs", and presented under "operating costs" in the income statement. When the interpretation is initially applied, companies shall make a retrospective adjustment if such assurance-type warranties were included in "selling expenses". Since the Company's assurance-type warranties were included in "selling expenses", and therefore it retrospectively adjusted the data on operating costs and selling expenses for the first three quarters of 2024, which did not involve the adjustments to major accounting data and financial indicators.
