PROFIT WARNING

This announcement is made by Crown International Corporation Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) pursuant to the provisions of inside information under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong) and Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

The board (the “**Board**”) of directors (the “**Directors**”) of the Company would like to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on the preliminary assessment of the Board with reference to the unaudited consolidated management accounts of the Group for the period ended 30 September 2025 (“**the Reporting Period**”) and other information currently available to the Board, the Group would record consolidated loss attributable to the Shareholders for the Current Reporting Period in the range of between HK\$32 million and HK\$36 million while there was consolidated loss attributable to the Shareholders of approximately HK\$2 million for the period ended 30 September 2024 (“**the Last Reporting Period**”). Such consolidated loss attributable to the Shareholders in the Current Reporting Period was mainly due to the increase in operating and marketing expense of trading of premium white spirit from HK\$Nil in the Last Reporting Period to HK\$8 million in Current Reporting Period and impairment loss recognised in the Current Reporting Period.

The Company is still in the process of finalising the Group's interim results for the Current Reporting Period. The information contained in this announcement is only based on a preliminary review of the unaudited consolidated management accounts of the Group for the Current Reporting Period which have not been audited or reviewed by the external auditors of the Company. Shareholders and potential investors are advised to read carefully the unaudited interim results announcement of the Company for the period ended 30 September 2025 which will be published on 28 November 2025.

Further announcements will be made by the Company if there is any significant change in the expected financial results of the Group as disclosed in this announcement.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
