**ANNOUNCEMENT ON UNAUDITED OPERATING DATA
FOR THE FOURTH QUARTER OF
THE THREE MONTHS ENDED 31 DECEMBER 2025 AND
THE TWELVE MONTHS ENDED 31 DECEMBER 2025**

This announcement is voluntarily made by Dynagreen Environmental Protection Group Co., Ltd.* (the “**Company**”, together with its subsidiaries, the “**Group**”).

The board of directors (the “**Board**”) of the Company is pleased to announce that the total waste input volume, electricity generation volume, on-grid electricity volume and steam supply volume of the Group’s subsidiaries amounted to 3,807,600 tons, 1,373,363,200 kWh, 1,152,993,200 kWh and 332,400 tons respectively in the fourth quarter of the three months ended 31 December 2025. In 2025, the accumulated waste input volume of the Group’s subsidiaries amounted to 14,729,600 tons, representing a year-on-year increase of 2.41%; the accumulated electricity generation volume was 5,240,086,000 kWh, representing a year-on-year increase of 1.80%; the accumulated on-grid electricity volume was 4,359,282,900 kWh, representing a year-on-year increase of 2.31%; and the accumulated steam supply volume amounted to 1,120,500 tons, representing a year-on-year increase of 98.81%.
