ANNOUNCEMENT POWER GENERATION FOR JANUARY 2026

This announcement is made by China Datang Corporation Renewable Power Co., Limited* (the “**Company**”) pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

The board of directors (the “**Board**”) of the Company announces that, according to the Company’s preliminary statistics, the power generation of the Company and its subsidiaries (collectively, the “**Group**”) for January 2026 on consolidated basis amounted to 3,272,182 MWh, representing an increase of 6.69% as compared with that of the corresponding period of 2025, of which, the wind power generation amounted to 2,880,606 MWh, representing an increase of 4.34% as compared with that of the corresponding period of 2025; and the photovoltaic power generation amounted to 391,576 MWh, representing an increase of 27.89% as compared with that of the corresponding period of 2025. As of 31 January 2026, the total power generation of the Group for 2026 amounted to 3,272,182 MWh, representing an increase of 6.69% as compared with that of the corresponding period of 2025, of which, the wind power generation amounted to 2,880,606 MWh, representing an increase of 4.34% as compared with that of the corresponding period of 2025; and the photovoltaic power generation amounted to 391,576 MWh, representing an increase of 27.89% as compared with that of the corresponding period of 2025.
