## **VOLUNTARY ANNOUNCEMENT INCLUSION AS A CONSTITUENT OF HANG SENG INDEX SERIES**

This announcement is made by BUTONG GROUP (the “**Company**,” together with its subsidiaries, the “**Group**”) on a voluntary basis to inform the shareholders and potential investors of the Company about the latest business updates of the Group.

The board of directors of the Company (the “**Board**”) is pleased to announce that the Company will be included as a constituent of Hang Seng Index Series, including the Hang Seng Composite Index and Hang Seng Stock Connect Hong Kong Index, according to the quarterly review results published by Hang Seng Indexes Company Limited on February 13, 2026. The adjustment will take effect officially on March 9, 2026.

The Hang Seng Composite Index, as a comprehensive Hong Kong market benchmark, covers the top 95% of listed companies by cumulative market capitalization on the Main Board of The Stock Exchange of Hong Kong Limited and is widely used by index funds, mutual funds, and performance evaluation systems. Inclusion into the Hang Seng Composite Index will allow the Company to join the eligible shares list of the Shanghai-Hong Kong Stock Connect and the Shenzhen-Hong Kong Stock Connect for trading with investors in the Chinese Mainland.

According to Hang Seng Indexes Company Limited’s quarterly review results, the Company will also be selected for other Hang Seng Index components, including Hang Seng Composite Industry Index – Consumer Discretionary, Hang Seng Composite MidCap & SmallCap Index, Hang Seng Composite SmallCap Index, Hang Seng Small Cap (Investable) Index, Hang Seng Stock Connect Hong Kong Index, Hang Seng Stock Connect Hong Kong MidCap & SmallCap Index, Hang Seng Stock Connect Hong Kong SmallCap Index, Hang Seng SCHK Consumer Discretionary Index, Hang Seng SCHK Consumer Discretionary (Investable) Index, Hang Seng SCHK Consumption (Investable) Index, and Hang Seng SCHK Mainland China Companies Index.

The Board believes the inclusion of the Company into the Hang Seng Index Series reflects investors' recognition of the Company's sustained value and potential. It's expected to further improve the stock liquidity, broaden investor base with diversified shareholder composition, and promote the Company's development in the long run. The Board would like to thank the shareholders and investors of the Company for their continued support. The Company will continue to develop its business and strive to maximize value for the shareholders.
