ANNOUNCEMENT IN RELATION TO RESIGNATION OF CHAIRMAN

Mr. Luo Bing (“**Mr. Luo**”), the Chairman of CSSC Offshore & Marine Engineering (Group) Company Limited (the “**Company**”), submitted a written resignation to the board (the “**Board**”) of directors (the “**Directors**”) of the Company on 19 March 2026 to resign from the positions of the Chairman and a Director of the eleventh session of the Board and the chairman of the Strategy Committee of the Board of the Company due to work rearrangement. Following his resignation, Mr. Luo will no longer hold any position in the Company.

Mr. Luo confirmed that he had no disagreement with the Board and that there were no matters relating to his resignation that needed to be brought to the attention of the shareholders of the Company.

In accordance with the relevant laws and regulations and the relevant provisions of the articles of association of the Company, the resignation of Mr. Luo has not resulted in the number of Board members falling below the statutory minimum quorum and will not affect the normal operation of the Board. His written resignation shall take effect upon its delivery to the Board (that is, 19 March 2026). The Company will conduct a by-election of Director and elect a new Chairman of the Board in accordance with the statutory procedures.

The Board would like to express its sincere gratitude to Mr. Luo for his outstanding contribution to the business development and corporate governance of the Company during his tenure.
