## **PROPOSED AMENDMENTS TO THE ARTICLES OF ASSOCIATION**

This announcement is made by the board (the “**Board**”) of directors (the “**Directors**”) of Haidilao International Holding Ltd. (the “**Company**”) pursuant to Rule 13.51(1) of the Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

The Board is pleased to propose certain amendments (the “**Proposed Articles Amendments**”) to the current articles of association of the Company (the “**Articles of Association**”) by way of adopting the new articles of association of the Company (the “**New Articles of Association**”) for the purpose of, among others, (i) bringing the Articles of Association in line with the latest regulatory requirements in relation to holding of hybrid general meetings, electronic voting, and treasury shares and the relevant amendments made to the Listing Rules; and (ii) making other consequential and house-keeping amendments.

The Proposed Articles Amendments and the proposed adoption of the New Articles of Association are subject to the approval of the shareholders of the Company (the “**Shareholders**”) by way of a special resolution at the forthcoming annual general meeting of the Company (the “**AGM**”) or any adjourned meeting. A circular of the Company containing, inter alia, further details on the aforesaid subject matters, together with a notice of the AGM, will be despatched to the Shareholders, if necessary, in accordance with the requirements of the Listing Rules in due course.
