UPDATE ON QUALIFICATION OF COMPANY SECRETARY

Reference is made to the announcement of Kuaishou Technology (the “**Company**”) dated February 20, 2023 in relation to the waiver granted to the Company by The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) from strict compliance with Rules 3.28 and 8.17 of the Rules Governing the Listing of Securities on the Stock Exchange (the “**Listing Rules**”) in respect of the eligibility of Mr. Matthew Huaxia Zhao (趙華夏) (“**Mr. Zhao**”) to act as a joint company secretary of the Company (the “**Joint Company Secretary**”) for a period of three years from February 20, 2023 (being the effective date of Mr. Zhao’s appointment) to February 19, 2026 (the “**Waiver Period**”).

The board of directors of the Company (the “**Board**”) is pleased to announce that the Company has recently obtained confirmation from the Stock Exchange that Mr. Zhao has been qualified to act as the company secretary of the Company under Rules 3.28 and 8.17 of the Listing Rules after the Waiver Period and thus a further waiver is not necessary.

In pursuit of high corporate governance standards, while Mr. Zhao has been qualified as a company secretary under the Listing Rules, the Company will continue to retain the arrangement of joint company secretaries.

CHANGE OF JOINT COMPANY SECRETARY AND AUTHORIZED REPRESENTATIVE

The Board hereby announces that Ms. So Ka Man (蘇嘉敏) (“**Ms. So**”) has resigned as the Joint Company Secretary and an authorized representative of the Company as required under Rule 3.05 of the Listing Rules (the “**Authorized Representative**”) with effect from March 25, 2026.

Ms. So has confirmed that she has no disagreement with the Board and there is no other matter relating to her resignation that needs to be brought to the attention of the shareholders of the Company or the Stock Exchange.

The Board further announces that Ms. Yip Hoi Lam (葉凱琳) (“**Ms. Yip**”) has been appointed as the Joint Company Secretary and an Authorized Representative with effect from March 25, 2026, while Mr. Zhao will continue to act as the other Joint Company Secretary.

Ms. Yip is currently a manager of company secretarial services of Tricor Services Limited. She has extensive experience in the corporate secretarial field and has been providing professional corporate services to Hong Kong listed companies as well as multinational, private and offshore companies. She obtained her master’s degree in Corporate Governance from the Hong Kong Metropolitan University in August 2021.
